Re: Devra Patton West, her cult / criminal racketeering gang and the ongoing campaign of intimidation against me and my family to which you are complicit.


Over the past 5 years or so you have received some 500 to 600 emails from me cataloging the ongoing campaign of intimidation being directed at me and my family by Devra Patton West – the leader of your cult / criminal racketeering gang. This would be the campaign of intimidation that fellow cult / gang member Geoffrey Reynolds announced to the Montana press on August 9 2007. In what he thought was an 'off the record' conversation with the reporter, Constance See, Reynolds made the following statement. "Watson would be dead within 12 months or in jail for reacting to what Devra Patton West was going to do to him and his family." End quote. Constance See took the threat serious enough to pass it on to John Nielson and IRS Criminal Investigator looking into Patton West's finances at the time. Both these witnesses will confirm Reynolds' comments.

The motive for my planned murder and the ongoing campaign of intimidation, which you and Reynolds remain complicit in, was me suing Patton West for defrauding me in 2002. Additionally I had put up a website to counter her, your and Reynolds' lies about me that were posted on her website. Lies posted to discredit other victims of crime at Patton West's hands most notably Dr. Pat Cole MD who was subject to a campaign of vicious assaults by Patton West whose objective was to extort \$1.3 million from the victim which Patton West succeeded in doing.

The big question is, Why would you and Reynolds, both total strangers to me, intervene against me in a lawsuit I had issued against Patton West after she defrauded me? The big answer is both you and Reynolds, while total strangers to me were / are members of her cult and therefore fully under her control.

Though this email is principally about your past and present role in Patton West's cult / criminal racketeering gang let us first establish, beyond any doubt that Patton West is the leader of a cult. And by extension, because of the prolific number of serious crimes that have been committed by Patton West over the past 20 years since you joined her cult, the leader of a criminal racketeering gang. In 2008 I received judgment against patton West for defrauding me. That lawsuit was issued against her in 2003 and after countless dirty tricks, defamations from her website, false witnesses, a campaign of intimidation and death threats I won the lawsuit in 2008. In 2010 while attending court in Montana, to see how much I was to be awarded by the court, I was served with two defamation lawsuits by Patton West and senior cult / gang member Geoffrey Reynolds CPA. One of their chief claims was that I was charging Patton West with criminal activity and with **running a cult**.

Below here is a copy of the front page of his pleadings...



Above: Cult / gang member Geoffrey Reynolds, a total stranger to Watson who could not possibly have been defamed by him none the less at Patton West's instructions makes totally false claims for his part in a \$10,000,000 extortion scam.

I will leave aside the fact that Reynolds could not possibly have been defamed by me between 2002 & 2006 because Reynolds did not join Patton West's employ (cult / criminal racketeering gang) in Montana from California until September 2006. That lie / false pleadings / perjury is easily shown for what it is by Reynolds' own website which clearly shows he did not join Patton West in Montana until September 2006! Clearly Reynolds is not the brightest bulb on the Christmas Tree that his own website proved he was lying to the court for Patton West.

However what I want to establish beyond any doubt here is that Patton West WAS running a cult. And because of the large number of well documented crimes that have occurred during your tenure over the past 20 years she WAS running a criminal gang which you were and REMAIN a willing member of. The current bulletin being sent to the FBI and others makes it obvious that Patton West is a prolific criminal, a murderer and possibly a serial killer.

To help establish what a cult is I have referred to the material published by Janja Lalich on the <u>Cult Research</u> website. The following slides were sourced from her material. The arrows and comments are mine.

Slide 1. There are four characteristics to a cult group.

There's four characteristics to a cult group.
1. Charismatic leader: The charismatic leader is the originator of the group. Charismatic leaders are people who are great
manipulators, they're charming. They know how to read people. They come along and offer a message that is going to resonate with somebody. Once they get a few followers that's all they need and then those people go out, recruit more and they build up an aura around the leader. [This is all based on some philosophy strung together from a variety of sources such as religion, UFOs, Science or mythologies.]

The cult is originated by a charismatic leader who is able to read and manipulate people. As a brain washed member of the cult you are fully employed by Patton West to 'market' her to the public as a **charismatic leader** even though the documentary evidence shows you are fully aware that she is dangerous psychopath, a prolific criminal and perhaps a murderer and serial killer. Your role is to **manipulate** other members of the cult and the public into believing the lies. This is called fraud.

Slide 2. The Transcendent belief System.

2. Transcendent belief system: Most religions and even political groups are going to have a transcendent belief system, a means how to get to some better place. But what's different in cult groups is they have their way to get you there. It is the recipe for change to get to a goal. In order to be part of the group, you have to go through a transformational process, which they dictate to you and you can't be there otherwise. That's the indoctrination program.

[Marxist-Socialist politics teach this extensively. Eastern religions also use this method. The global warming cult teaches that at the end the earth will be a much better place **if mans population is reduced** so we don't hurt mommy earth.]

Patton West's claims include 'how she can take followers to a **better place**.' In 2005 she was offering to take followers to Shamballa but only those who could pledge 66% of their net worth to her. Shamballa turned out to be a journey north from Victor MT to Lakeside MT. Patton West is known to use brainwashing and conditioning as part of an **indoctrination process** that results in employees and students 'submitting to her will.' Those employees who do not submit within 90 days of being hired are summarily dismissed. This email from <u>Rebecca West</u> shows the turnover in employees and this email from <u>Carlida Finch</u> shows that she was given an ultimatum join Patton West's cult or be fired. Carlida also overheard patton West planning the murder of her business partner Dr. Pat Cole MD a fellow physician which you turned your back on and even published false statements about including denying Patton West's assault on Cole even though you knew it to be true. But let's leave murder aside and focus on proving Patton West was / is running a cult you were and are a willing member of.

Slide 3. Systems of Control.

Organizations to Avoid Because They Will Only Take Advantage of You.

3. Systems of control: Followers think they're joining something that's going to give them purpose and meaning in life. Slowly they are forced to go through the rituals or the study sessions that get you more and more drawn in. As this process goes on, the person begins to adopt this new worldview that requires new behaviors, and which most often requires cutting off from the past [or family and friends. Some of the most common control mechanisms these cult leaders use is purchasing a plot of land and having the followers move there. Once a core of followers are isolated on that land, the leader controls the amount of information that is allowed into the commune. The land is usually in an isolated location away from friends and relatives or large cities.] The other control mechanisms are rules and regulations created by the leader. [All money flows to the top of the organization leaving the followers with little to nothing 1

Patton West had her cult set up as an unaccredited school for occult studies to which you attended and have, as I write been a student of for 20 years. The school had from memory 4 or 5 tiers (5 years of study) during the **study sessions** 'students' were indoctrinated and brainwashed into accepting Patton West as a demi god. Students were required to **cut off from their past which included family and friends**. In 1995, after being chased out of New Mexico at the point of a gun, Patton West **bought a plot of land in Victor MT and had her followers move there**. The land was in a **fairly isolated area** and Patton West definitely **controlled the information** allowed to enter **into her commune**. There were endless **rules and regulations** which often changed on a day to day basis as employees were worked to the bone as part of the system of organized chaos used to break their mental well-being as a prelude to their submitting to Patton West's will. As her Business Manager for six months in 2002 I was witness to the fraud and theft of cash donations by Patton West who used the charities bank account as her own. <u>AJ White's</u> notarized statement to me is a good example of the criminality rife at the time.

Eventually Patton West bankrupted the charity and in doing so defrauded Mike Hendrickson out of \$200,000 which she put in a personal trust fund for her and her eldest son Rob Meador. She also stole the charities property worth \$1,250,000 and put that in the same trust fund even though it was largely paid for by cash donations from the public! Then there was approximately \$4,000,000 worth of artwork and valuables which she stole from the charity in 2004 and hid in a lock up for ten years until the statute of limitations passed on theft. These items suddenly appearing in Arizona in 2014. The very times she maintained did not exist! At least that is what she said while giving a statement under oath to my lawyer in 2009!

Slide 4. Systems of Influence.

Organizations to Avoid Because They Will Only Take Advantage of You.

4. Systems of influence: There is also **peer pressure**. Older members will model for the new members how you're supposed to behave. Before you know it, you're so enveloped in this other reality that you don't look to anything else. **You don't allow yourself to be opened to any other explanations. Your mind has completely closed** in on this new worldview. The connections to the belief system is the glue that keeps you there. Belonging to the cult appears the only hope you have.

Peer pressure was always present in the cult as long term members were used to spy on and exert pressure on new members to behave in a way that patton West mandated. Anandra George was a good example of the spy / peer pressure example. As is Patton West's edict entitled 'Protocol to be Observed at the House.' This explains the photographs I see of you kneeling at her feet. Clearly those present in the cult, including yourself, were / are **enveloped in a false reality** created by Patton West and her closest aides / accomplices. Your threatening <u>email to</u> me of January 2007 clearly sought to convince those who read it that Patton West was a guru (and still espouse that lie). When any cursory review of the evidence over the past 20 years shows her to be a dangerous criminal and you to be a pathological liar and a total fraud. You also dishonestly inferred in your email that I was a student of Patton West's which I never was. However like every employee or business consultant before or since I was subject to daily pressure to join her cult. Clearly you are totally brainwashed and **your mind is completely closed**. The only **other explanation** is that you are totally corrupt and a willing accomplice in racketeering and complicity to commit murder.

Slide 5. Mental Illness.

Organizations to Avoid Because They Will Only Take Advantage of You. Mental Illness For decades there have been studies about the various mental issues that cult leaders and their followers have. Most cult leaders have Narcissistic personality disorder. Symptoms include an excessive need for admiration, disregard for others' feelings, an inability to handle any criticism, and a sense of entitlement. As for the followers, most people who join a cult are just going through a mental crisis and that cult seems to offer relief or fulfillment. For the most part, the mental state plays an important role in people who join a cult or is a cult leader Symptoms of psychosis include delusions and hallucinations (seeing or hearing things that

others do not see or hear). Other symptoms include incoherent or nonsense speech, and **behavior** that is inappropriate for the situation.

There is little doubt in my mind that both Patton West, as the **leader of her own cult**, **is mentally ill** and that some of her **followers**, you included **are mentally ill**. That Patton West is suffering from a **Narcissistic Personality Disorder** is not in doubt. The image below and all the idiot titles and accolades are just a tiny portion of the lies, propaganda and bullshit to be found on her current website. Lies and propaganda you 'market' to the public with your <u>fake testimonials</u> as truth even though you are well aware from your own experience over the past 20 years this is all a massive fraud.

Symptoms of mental illness include excessive need for admiration, disregard for other's feelings, an inability to handle any criticism and a sense of entitlement. Nothing describes Patton West's sense of entitlement as the following image taken from a recent bulletin. The image contains the phrase "It will be your privilege to financially seed my transition. It is not my need but rather your need."



The above statement in a <u>missive</u> sent to her entire cult in 2005 entitled 'Financial Form Building.' Go to page 2 and scroll down to paragraph 7. You joined Patton West's cult in 2000, twenty years ago, so I must ask you the question, "At the time you joined were you going through a **mental crisis**?" Does the cult / criminal racketeering gang offer you **relief or fulfilment**?

Patton West expresses all the symptoms of someone suffering from psychosis indeed a someone attending a course with Patton West in 1991 made that same claim in correspondence to me. In a 2010 <u>email to me</u> Satya described Patton West as delusional psycho / socio path. But we need not rely on Satya alone to diagnose Patton West as being psychotic as <u>her own website</u> is evidence of her delusions. Then there are two other websites put

up by the UK group which contain several hundred documents and audio recordings evidencing her mental illness which includes documents she has issued to her cult which she maintains were channeled to her by long dead Ascended Masters who speak through her because she too is an Ascended Master? A good example of that Julio is the document she issued to her entire mailing list on April 17 2006 days after she viciously assaulted Dr. Pat Cole MD. The missive entitled, '<u>The Law of Severity on the Path to Purification</u>' was dictated to her by the voices in her head. In this missive, which you got a copy of, Patton West justifies the vicious assault on Cole by asserting she was a Nazi in the WWII death camps in another life time. Evidence of insanity in spades.

In conclusion, and with the aid of the material published by Janja Lalich on the <u>Cult Research</u> website I have proved beyond all doubt that Patton West was running a cult at the time Patton West and Reynolds launched their defamation lawsuits against me in 2010. Lawsuits you funded.

Which brings me neatly to the email you sent to me in January 2007 as part of Patton West's attempt to intimidate me into dropping my fraud lawsuit against her. Again you and I are total strangers as was / is Reynolds but clearly from Reynolds false pleadings to the court in 2010 and your email to me in January 2007 both you and Reynolds, as members of Patton West's cult, agreed to join her conspiracy against me. Though I have no evidence to prove it as a senior member of her cult I suspect you were briefed about Patton West's plan to murder me. I am 100% sure that you have been aware of Patton West's ongoing attempts to intimidate me by targeting me and my family after all I have sent you between 500 & 600 emails logging those attacks. Neither the intimidation nor the ongoing attempts to murder me will deter me from seeking justice not just for myself but for the scores of other victims of organized crime over the past 30 years.

Then there are the ongoing crimes being committed in Arizona where fake cures for cancer are being 'sold' to unwary victims for huge sums of money. You are directly involved in this giant fraud scam and have even provided your own home as a venue at which these crimes are committed presumably with you in attendance as Patton West kneeling, supplicant, brainwashed physician assuring potential victims that she really has been planning to lead humanity for thousands of years!

Finally having proved Patton West is running a cult / criminal gang and that you are a willing and key accomplice in her criminal racketeering gang and complicit in her ongoing attempts to 'silence' me let us now get to your January 2007 email to me. Your email was a clumsy attempt at witness tampering in that you sought to intimidate me, the plaintiff in a lawsuit against your cult leader, into withdrawing that lawsuit.
