

## Rishi Devra - A Few More Pointers for the FBI and Arizona Police Departments.

Either Patton West is a violent psychopath, a criminally insane narcissist, a con artist, murderer and suspected serial killer as we claim she is, or as she claims, she is the Regent of the Western Hemisphere who has been preparing to lead humanity for thousands of years. Let us review what evidence there is to support either proposition.

**In support of our claims.** Prior to 1991, Patton West was a pot grower, drug dealer and small time con artist ripping off victims one at a time for several thousand dollars each. Patton West has operated her cult / criminal racketeering business model for the past 30 years first in New Mexico, then Montana and now Arizona. During a meeting with John Watson in March 2003 Patton West admitted defrauding Watson but did not see herself writing out a check for what she owed him. She then went on to level several expletive threats against him. When Watson went public with this information Patton West, aided and abetted by Reynolds & Williams tried to murder Watson in 2007. When that failed Patton West launched a campaign of violent intimidation against Watson, his wife and children which, 14 years later, is ongoing. Reynolds & Williams are totally aware and are complicit in the ongoing attempts at intimidation and murder.

After John Watson, a victim of fraud at Patton West's hands in 2002, turned whistle-blower in 2006 and put up a website about her criminal activities in Montana, the public stopped believing the 'divine being' bullshit she espouses about herself. Then the publication of three very negative newspaper articles [\(1\)](#), [\(2\)](#) & [\(3\)](#) about her activities rendered her criminal activities in Montana 'dead in the water.' Patton West's response was to engage the services of two senior members of her cult / criminal gang, Julio Williams MD & Geoffrey Reynolds CPA, in a conspiracy to murder Watson. The 2007 murder plot failed but all three had better luck with Plan 'B' which in 2010 involved outspending Watson in a civil court.

With Montana now a hostile environment for Patton West, she moved her criminal business model to Arizona in 2010. This was a repeat of 1995, when she was forced to move from New Mexico to Montana. With Watson's website no longer up, Patton West reincarnated herself the 'Western Regent' and 'The Mother of Ten Thousand Suns.'

But apparently, all allowed under religious freedom laws even though Patton West is obviously a criminal, bat shit crazy or both!

This crap, this verbal diarrhea, nets Patton West millions of dollars a year from fraud and extortion just as it did in Montana and New Mexico before that. Motive enough for murder. Is it any wonder that, aided and abetted by Williams & Reynolds, she tried to murder Watson to bury the truth about her criminal past?

We are determined to get justice for the scores of victims from three western states over the past 30 years. The conspiracy and attempted murder of Watson is well documented. Reynolds even announced his murder to the press in advance! Both Williams & Reynolds left behind written evidence of their involvement in Patton West's conspiracy to murder him and, when that failed, their role in Plan 'B' to bankrupt him into silence. Additionally, both Williams and Reynolds are fully aware of the ongoing campaign of intimidation being directed at Watson, his wife and children by Patton West. 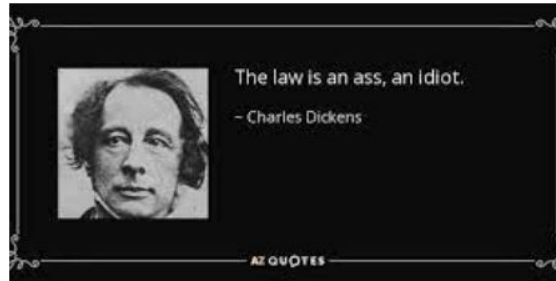
**NOTE TO FBI & POLICE IN ARIZONA - Not every murderer uses a gun, knife, club, poison or rope.**

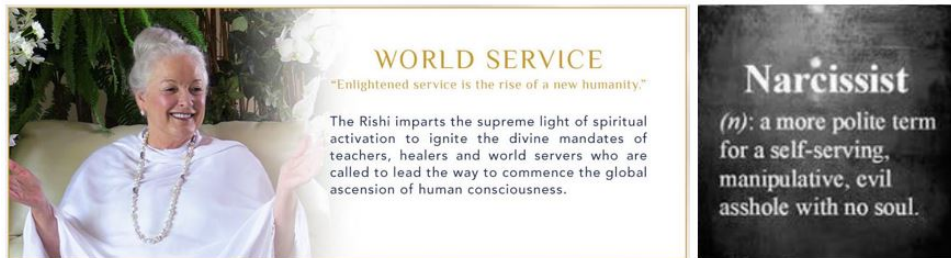

In January 2007, as Watson was about to win his lawsuit, senior cult / gang member Dr. Julio E Williams MD wrote [a threatening expletive laden email](#) to Watson, in an attempt to get him to withdraw his lawsuit. Above is a photograph of Williams with an excerpt from his email.

#### **Four things to note about Dr. Julio E Williams MD:-**

1. Williams has been working as a surgeon for [Essentia Health](#) at their facility in Fargo ND since September 2018. Had Essentia Health been aware of Williams poor 'bed side' manner and his 20 year membership of a dangerous cult they may have passed him over. If Essentia Health have any sense I suspect Williams will be taking a 'leave of absence' real soon.

2. Williams was a total stranger to Watson and yet felt inclined not only to insert himself into a legal dispute, threatened the plaintiff in that lawsuit with the clear intention of intimidating him into withdrawing but also pledged \$2,000,000 of his own personal fortune for Patton West knowing she was guilty of the fraud.

3. After the subsequent August 2007 attempt to murder Watson failed Patton West launched a campaign of intimidation against Watson and his family which continues to this day 14 years later. Williams is totally aware of what Patton West is doing. We know this because Watson has sent him 500 emails complaining about the violence. Williams has so far refused to share these with the police or the FBI.

On August 9 2007, while being interviewed by the [Bigfork Eagle](#) reporter Constance See, Reynolds announced Watson's imminent murder in what he thought was an 'off the record' conversation with the reporter. What Reynolds actually said was, and I quote, "Watson will be dead within 12 months or in jail for reacting to what Patton West was going to do to Watson and his family." End quote.

#### **Four things to note about Geoffrey Reynolds CPA:-**

1. Last time we looked Reynolds was working for [McSwain & Co.](#) accountants in Olympia WA. Though, if that is still the case, he'll need a very long leave of absence shortly to go to trial for racketeering and complicity to commit murder. The idea of someone like Reynolds having access to client confidential files is horrifying. Read on.

2. Reynolds is a pathological liar a qualification admired by criminals like Patton West but an anathema to anyone running a business like McSwain & Co. [Reynolds' online resume](#) claims he sourced \$30 million in financing for Patton West's business 'Surya Enterprises Unlimited.'



However in reality, as the [Bigfork Eagle](#) newspaper makes clear, the business he referred to was involuntarily dissolved! In other words the funding he refers to in his resume as a 'Career Accomplishment' was not forthcoming.

3. In addition to being complicit, in and announcing to the press, Watson's impending murder Reynolds was also guilty of making totally false pleadings to a Montana court in 2010 as part of a \$5,000,000 extortion scam against Watson. Once again Reynolds' own [resume on-line](#) proves he is a pathological liar. His resume makes it clear that he did not commence is employment with Patton West until September 2006 and yet in [Reynolds' pleadings](#) to court Reynolds stated under oath that he was defamed by Watson between 2002 & 2006. Reynolds worked in California until September 2006 and did not know Watson existed until Patton West recruited him to be part of her vendetta against Watson. Reynolds is totally aware of what Patton West is doing. We know this because he has been sent copies of the 500 emails sent to Williams complaining about the on-going campaign of intimidation by Patton West.
