In 2002, business consultant John Watson was defrauded by Patton West. 

In 2007, the Whitefish Pilot newspaper published a detailed list of some of the crimes being committed by Patton West at that time and led with Patton West's vicious assault on her business partner Dr. Pat Cole MD. This was followed a month later by a similar news article published by the Bigfork Eagle newspaper which showed Patton West to be a pathological liar. 


