RISHI DEVRA – INSIDE THE BRAIN OF A PSYCHOPATH, MURDERER & SUSPECTED SERIAL KILLER.






As mentioned above Dr. Julio E Williams MD & Ms. Coffin have been a disciples for more than two decades and both were fully aware of the crimes committed by Patton West in New Mexico and Montana. In 2005 Williams posted a <u>statement</u> on Patton West's website in response to fraud victim John Watson's decision to sue Patton West for defrauding him a lawsuit Watson won in 2008.

Since Williams remained disciple of Patton West's between 2000 and 2021, it is clear that Williams has no honor or credibility. Why would Williams, a total stranger to Watson, send an expletive laden threatening email to Watson in January 2007? Why would Williams pledge \$2M of his own fortune to fund Patton West's legal fees so as to block Watson's and other victim's lawsuits against Patton West? This document from an employee of Patton West's evidences a \$100,000 payment to Patton West in early 2007. This payment was made shortly after Patton West viciously assaulted Dr. Pat Cole MD and months before Patton West was convicted of that assault. Why in 2018 would Williams propagate the lies posted online by Patton West that her two* defamation lawsuits against Watson (which Williams Funded) were about cyber-crime? Why would Williams post a statement online that totally misrepresents the injunction that Williams' money 'bought' for Patton West? Williams knows that the truth is bad for his cult leader's business (theft, fraud and extortion) so in addition to attempting to quash the truth about Patton West's crimes, Williams also posted a series of fake, idiotic testimonials on her website. (*Reynolds pleadings were a copy of Pattonb West's hence the two defamation lawsuits brought against Watson but funded by Williams.

6. CORINNE COFFIN AKA TANMAYO. Corinne Coffin had been a disciple / student of Patton West's going back to the 1990's. Ms. Coffin is a Brazilian heiress who has been funding Patton West's activities for decades. The whistleblower John Watson, worked with Patton West as a 'business consultant' between January 2002 to August 2002. During that time, Watson was aware that Ms. Coffin had given one of her credit cards to Patton West, which Patton West used to fund many of her day to day expenses. This seemed odd to Watson as at the time as there were capital controls on the outflow of monies from Brazil? Allegedly much larger sums of money were passed to Patton West from Brazil via an intermediary in New York. During the Spring of 2002, Watson and Coffin ended up being selected by Patton West as busines 'partners' (directors and shareholders) in Millennia Mind Inc. Below are copies of the business cards that a Colorado design agency created for that project.



Up until that time, Watson believed that he was working for a respectable charity and that the charity's finances were all above board. While setting up for-profit and non-profit corporations for Patton West, Watson discovered that Patton West and her then husband, Jack West, were using the charity's bank account as their personal accounts. When Watson brought this to the attention of Patton West, explaining that if any large donors to her charity were to take her seriously they would need to see proper sets of accounts showing the charity's finances. Fearing that she was going to lose access to hundreds of thousands of dollars a year from donations, Patton West made up totally false grounds which she used to constructively dismiss Watson. This resulted in the Watson being defrauded out of shares and pay.

Patton West's personal secretary, Barbara Costantino, shared a <u>written statement</u> with Watson in which she made clear that every time someone challenges or opposes Patton West's crimes, Patton West gets rid of them and then manufactures a totally false narrative about the departing individual to cover up her crimes.

Ms. Coffin at the start of this project in the Spring of 2002, confided in Watson that she was glad he was onboard, as she did not trust Patton West to use the \$1.000,000 she was going to donate for the purpose the money was intended for. Unfortunately, after Watson was gotten rid of by Patton West, Ms. Coffin swallowed all of Patton West's lies about his departure and went ahead with the project without Watson's involvement. Here is a <u>document</u> evidencing payments totalling nearly \$750,000 to Patton West. - Witnesses allege Patton West is being investigated for fraudulently applying for and receiving hundreds of thousands of dollars of Covid Emergency Relief Funds for non-existent employees. Patton West used some of those funds to pay off her rent arrears of \$80,000. Patton West also used some of the Covid Disaster Relief funds to pay for her \$8,000 a month hotel bills. Recently, Patton West moved into a modest condo whose rent is also being paid for out of the funds she defrauded the US government out of.

The IRS can spend a million dollars to recover one hundred dollars in unpaid taxes. The US government, both state and federal, can spend millions of dollars prosecuting guilty of fraud. 
