

**RISHI DEVRA –SELF APPOINTED PLANETARY REGENT DEFRAUDS IRS OUT OF MILLIONS

Above: Had the authorities interviewed some of the scores of victims of organized crime over the past three decades, they would have learned that Patton West's success as a career criminal, murderer and suspected serial killer, was made possible by her use of occult knowledge. After outstaying her welcome in New Mexico and Montana, Patton West is now 'working' Sedona Arizona.

For 32 years, Patton West has operated her cult / criminal racketeering gang in three western states NM, MT and since 2010 AZ. There have been scores of victims of theft, fraud, extortion and multiple victims of violent assaults. There have also been several suspicious deaths with one failed attempt to murder the whistleblower, John Watson. Individual victims are taken in by Patton West's fantastical lies. After being duped into joining her cult, they are brainwashed and conditioned as a prelude to having their bank accounts emptied into Patton West's. Those victims that go public, are subject to a campaign of public defamation, threats, a campaign of occult (hidden) violent assaults and murder. Senior members of her cult e.g. Julio Williams, Corinne Coffin, Geoffrey Reynolds and Jack West, were all aware of what was going on but believed that Patton West's occult knowledge would prevent her ever being held to account for her crimes.

In Montana, Patton West used several 'front companies' as vehicles for organized crime. Here is an excerpt from the [Bigfork Eagle](#) newspaper article published about Patton West's criminal activities in 2007.



Thursday, August 09, 2007

Out of six businesses mentioned in West's literature, only one remains active and in good standing with the Montana Secretary of State office -- Sacred Environments LLC. Two were never registered -- Divine Unity Foundation and Millenium Mind Institution; two were involuntarily dissolved -- Surya Enterprises Unlimited and Global Guardianship Initiative; and one was involuntarily revoked -- Sacred Archive Institute.

The point we are making clearly and unequivocally is that as when operating in Montana, Patton West used several 'front companies' to carry out her criminal activities. The 'front companies' currently being used in Arizona are 'The Rishi LLC' & 'Omni Institute for the Divine Sciences' (more about the latter further on in this bulletin).

FOR WHAT FOLLOWS IS A BRIEF ILLUSTRATION OF THE ROLE THAT CULT / GANG MEMBERS WILLIAMS, COFFIN, REYNOLDS & JACK WEST PLAYED TO KEEP PSYCHOPATH PATTON WEST IN BUSINESS FOR DECADES....



Dr. Julio E Williams MD. Williams joined the cult in the year 2000. Since then Williams has donated hundreds of thousands of dollars to Patton West's criminal racketeering business model. Williams has been at the forefront of 'marketing' Patton West to the public as a "virtual wellspring of living divinity" while personally threatening those victims of crime who went public. In a 2007 email to the whistleblower Williams pledged \$2,000,000 of his own fortune so that his cult / gang leader Patton West could outspend the whistleblower in court. He also said that if the whistleblower 'f*cked' with him he would meet his match. Over the past two decades Patton West has had two arrest warrants, a conviction for assault, was the defendant in multiple fraud related lawsuits and was forced to sell all her assets to pay past victims of crime \$2,000,000 in court fines and interest. Williams was aware of all of this and remained a senior member of the cult / gang until 2021.



Corinne Coffin. Ms. Coffin is a Brazilian millionairess who has been a member of Patton West's cult / criminal racketeering gang for well over two decades. During that time Ms. Coffin has funded Patton West's criminal activities to the tune of millions of dollars. Ms. Coffin was in a brief business partnership with Patton West and the whistleblower John Watson. Ms. Coffin knew that Patton West had defrauded the whistleblower out of pay and shares after he completed all the work on their project but did nothing. In fact Ms. Coffin 'rewarded' Patton West for her deceit by funding her next corporation (a front for organized crime) to the tune of approximately \$750,000! According to government documents Ms. Coffin remained as 'Treasurer' to Patton West's 'front company' until 2021. Ms. Coffin must have been aware of Patton West's arrest warrants, convictions, visits to court etc. but she still remained involved until 2021.



Geoffrey Reynolds CPA. Reynolds was a senior member of Patton West's cult / criminal racketeering gang between 2006 & 2014. Reynolds is a pathological liar who would sell his wife and children if the price was right. In August 2007 Reynolds announced to the local press that the whistleblower John Watson would be dead within 12 months or in jail for reacting to what Patton West was going to do to his wife and children. Reynolds knew that Patton West was a career criminal, a murderer and quite possibly a serial killer. Why else would Reynolds feel so comfortable about announcing the murder of a total stranger whose only crime was to go public about Patton West's crime spree in New Mexico and Montana? Like Williams and Ms. Coffin Reynolds was aware of all the criminality but felt quite at home being a part of it. Reynolds posted several scathing critiques on-line vilifying the local press for publishing the truth about Patton West.



Jack West. Jack West has been involved with Patton West from the start. According to two witnesses (both victims of fraud) Jack West was being 'run' by Patton West back in the '70's and '80's well before Patton West announced herself in 1991 to be an Ascended Master. Like Patton West and Geoff Reynolds Jack West is a pathological liar. In 2007 Jack West declared his then wife to be as ethically pure as any human can be. This was shortly before Patton West's two arrest warrants, a conviction for assault and the forced sale of her assets to pay past victims of crime \$2M in court fines and interest went public. Jack West had previously warned the whistleblower that those who opposed his wife had a habit of dying suddenly. Like Lisa Swidler in 2005? Jack West has been a full and willing partner in many of Patton West's most serious crimes and was obviously aware of her ability to commit murder with apparent impunity.

None of the above cult / criminal racketeering gang members showed any concern about the scores of **individual victims** of theft, fraud, extortion, violent assaults or the suspicious death of Lisa Swidler in 2005.

However in 2021, Patton West decided that it was the **Federal Government's** Privilege to seed her Financial Transition by applying for \$500,000 in SBA Loans for non-existent employees...

"It will be your privilege to financially seed my transition. It is not my need but rather your need."

A quote from Patton West when she was masquerading as the Ascended Master Devra Ji. Circa 2004 / 2005.

Patton West has operated her cult / criminal racketeering business model in three western states over the past 32 years. Unfortunately for Patton West (and unlike individual victims) the US government has unlimited funds to pursue criminals.

Like several of her corporations in Montana, the **'Omni Institute for the Divine Sciences'** is a **'front company'** for **organized crime**. Patton West's record in Arizona speaks for itself, even without factoring in the crime spree in Montana and New Mexico. While Julio Williams, Corinne Coffin, Geoffrey Reynolds and Jack West were happy to be part of Patton West's criminal racketeering gang while she was picking off individuals one at a time.

They all realized that defrauding the US government out of \$500,000, and according to witnesses on the ground, she is going back for more, was not a good idea. So where are they all now?

IRS Halts Pandemic-Era Small-Business Tax Break Following 'Flood' Of Potential Fraud Claims

The Internal Revenue Service (IRS) has announced pausing a small-business tax credit program from the pandemic era for the remainder of the year following worries that ineligible claims are being filed.



The Employee Retention Credit (ERC) was instituted during the COVID-19 pandemic to encourage small businesses to retain their employees on payroll. **It offered a refundable tax credit for businesses that paid employees while being shut down due to lockdowns and other restrictions.** More than three years later, applications for ERC claims continue to pour in at the agency.

Amid "rising concerns about a flood of improper Employee Retention Credit claims," the IRS announced an immediate moratorium on the program on Sept. 14 that is valid through "at least the end of the year."

Patton West is a career criminal, who due to her use of an occult hidden weapon, has managed to avoid justice by threatening, violently assaulting and even murdering those who would go public about her crimes. In addition to acts of theft, fraud and extortion against individuals, Patton West has been defrauding the IRS and state and federal governments for three decades or more. This is easy to prove. Let me give you an example. Between January 2002 & August 2002, John Watson was 'employed' as a Business Consultant by Patton West. During his short tenure, Watson discovered that Patton West and her then husband Jack West, were defrauding their charity out of hundreds of thousands of dollars, most of which was received by the charity as cash donations received from the public. NONE of this money went to the 'good causes' espoused by Patton West. Immediately after challenging Patton West about this massive fraud, Watson was summarily dismissed without pay or the shares he was promised for his work.

Watson responded by calling in the IRS and by reporting the fraud to the Montana Secretary of State.

However, before the IRS could investigate the alleged crimes, Patton West forced her employees (members of her cult) to shred all the incriminating documents. The Secretary of State for Montana, upon receiving Watson's evidence, struck Patton West's then charity (a front for organized crime) [off the Montana charity register](#). 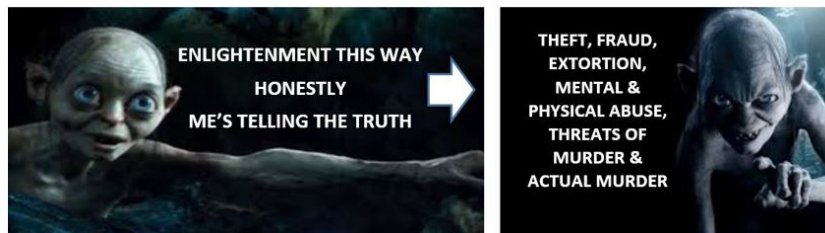

Sage of Sedona: Inside the Cult of the Rishi

A dislocated jaw. Bloody scalps. Bruises. A torn ear. Violent shakings. Occult initiations. Broken marriages. These are just some of the abuses ex-followers allege by Sedona's Devra Patton West aka the Rishi.



The above is an excerpt. The full article focused on the mental / physical abuse meted out by Patton West upon those whose only sin was to seek spiritual growth. For over three decades, Patton West has been selling 'enlightenment' for six figure sums. However, many of those who take up her offer, end up being the victims of theft, fraud extortion, violent assault and murder. One of the victims Be Scofield focused on was Lalita Jordan.



Here is a short excerpt from Be Scofield's article...

The Rishi was performing a "rare cardinal cross Christ over-lighting initiation," according to Lalita's husband Nicholas who was present. "It sounded like she was being crucified," Nicholas said. She "screamed for five minutes" and her "spine contorted," he told me. "Her eyes rolled back in her head, fluttering. She was convulsing uncontrollably. Her fists were clenched tightly."

With each occult initiation, Lalita Jordan became more sinister Nicholas said. Others also saw the change as she slipped deeper into the Rishi's grip. He's since escaped but his wife remains under her spell. "Lalita smack him," the Rishi said during a later episode before Nicholas left. Lalita walked across the room and slapped Nicholas, "wide swing, open-handedly across the face," many times.



Nicholas had been sitting in the middle of the room shaking intensely from the Rishi relentlessly screaming at him. “I was debilitated and felt helpless while being hypnotized under her sorcery,” he told me. “My sight had become pixelated with dark blurred vision and it felt I was in a trance.”

Cult Watch USA, one of four websites dedicated to jailing Patton West for three plus decades of racketeering and domestic terrorism, posted a memorial for Lalita Jordan. Those who go public, go to the police or to court for justice are subject to a campaign of occult violent intimidation or are murdered.

How Devra Took Over Lalita and Implanted an Entity in Her.

Devra Patton West screamed continuously for 10 minutes, screaming, “Stare Into Its Yellow Eyes, Hold Your Glance With It, Lalita!” as Lalita was implanted, accepting an entity into her being, followed by Devra diabolically completing her entity implant procedure, by pounding Lalita once in the heart chakra, leaving her unconscious on the floor. Lisa Swidler died suddenly and mysteriously after trying to leave the cult in 2005. What separates Patton West from other murderers and suspected serial killers is the [weapon she uses](#). Murders occasioned with the use of firearms, knives, blunt instruments and poison leave a trail of evidence that can lead back to the perpetrator. Because Patton West's [weapon of choice](#) is occult (hidden) in nature it cannot be traced back to her. A criminally insane narcissist like Patton West, could not resist using this weapon regularly.



Above: Imagine giving a criminally insane narcissist the codes to a nuclear bomb. This is the equivalent of what Patton West acquired between 1990 & 1991 while attending the 'Robert Jaffe School for Energy Mastery.' Being criminally insane she has used this occult (hidden) knowledge for the past 28 years to feather her own financial nest at the expense of scores of others.

Murder is an important tool in Patton West's criminal tool box. The occult weapon used by Patton West to subdue her victims, turn them into mindless obedient droids and, when they have outlived their usefulness, murder them is not regarded as a weapon by legal statute. So the law, up until now, has been totally impotent to deal with a career criminal like Patton West and as a consequence she has been allowed to get away with multiple murders over the past 30 plus years. What follows are some more examples of what Patton West and her accomplices call 'World Service.'



Above from left to right: Career criminal Patton West masquerading as a guru. (1) Lisa Swidler murdered to keep her from going to the police. (2) Marion Cantwell kidnapped, beaten, the victim of extortion and threats of murder. (3) Dr. Pat Cole MD viciously beaten on multiple occasions, the subject of extortion and threats of murder. (4) John Watson defrauded, the victim of defamation and a failed murder attempt. In 2010 Watson was the victim of a concerted effort by cult members Patton West, Williams & Reynolds to bankrupt Watson into silence.

EXAMPLE 1. The Suspected Murder of Student Lisa Swidler. Lisa may have been murdered in 2005 to stop her going to the police about crimes committed against fellow students, [Dave Kushner](#) (defrauded out of \$30,000), [Mike Hendrickson](#) (defrauded out of \$200,000) and [Marion Cantwell](#) who after selling her home was the victim extortion. Lisa was also aware of the [brutality](#) being meted out to Dr. Pat Cole MD by Patton West, while in the process of extorting \$1.3 million from Cole.

EXAMPLE 2. Marion Cantwell Kidnapped, Falsely Imprisoned, Threatened with Murder and the Victim of Extortion. After the sale of her home, student [Marion Cantwell](#) was kidnapped, falsely imprisoned and beaten. After being forced to make a 'donation' of tens of thousands of dollars, Marion was told she would be murdered if she went to the police.

EXAMPLE 3. The Planned Murder of Dr. Pat Cole MD by Patton West. Patton West was overheard by employee, [Carlida Finch](#), talking about the murder of her business partner Dr. Cole. Cole was viciously assaulted several times (the [Whitefish Pilot](#) newspaper has the details) by Patton West, while extorting the victim's entire net worth from her, which included Cole being forced to sign over her \$750,000 home to Patton West. West was convicted in 2008 of assaulting Cole. Cole was not murdered getting a reprieve after emptying her bank account into Patton West's.

EXAMPLE 4. The Attempted Murder of Fraud Victim turned Whistleblower John Watson. When fraud victim John Watson put up a website about Patton West's criminal activities in Montana, one of her cult / criminal gang members, Geoffrey Reynolds CPA, [announced Watson's impending murder](#) to the local press.

After a failed attempt on Watson's life by Patton West, and after Watson won a [fraud lawsuit](#) against Patton West, the cult rallied around its leader, Patton West, who came up with Plan 'B..' Plan 'B' being an attempt by Patton West aided and abetted by [Williams](#) & [Reynolds](#), to bankrupt Watson into silence so Patton West and the cult could relocate to Arizona without details of her criminal past in Montana being available online to those currently being targeted in Arizona.

It is hard for normal, sane people, to understand just how evil Patton West is. We suspect that once Patton West had drained Lalita of all monies and usefulness she gave the OK to the demonic entities she works with permission to 'take' Lalita.

THIS IS WHAT PATTON WEST CALLS 'WORLD SERVICE.'



In a meeting in March 2003, John Watson told Patton West that he was going to sue her for fraud. At the same meeting, and in response to the threat of being sued, Patton West made the following comments to Watson. You can listen to them being made by Patton West who was unaware she was being recorded:-

[The truth does not actually matter.](#) (If I can convince the public that my lies are their truth!)

[Yes I dispose of people like Kleenex.](#)

[My agreements are worthless.](#)

[Yes I defrauded you but I do not see myself writing out a check for you.](#)

[If you sue me I will get so down and f*cking dirty huge expenses coming out of your pocket not mine because cult members like Dr. Julio Williams MD will fund my legal costs.](#)

Watson went ahead and successfully sued Patton West for fraud and received [judgment](#) in his favor in 2008.

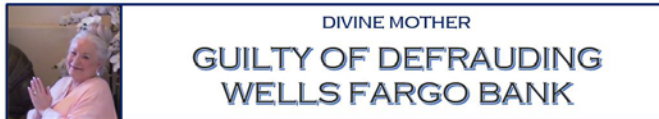

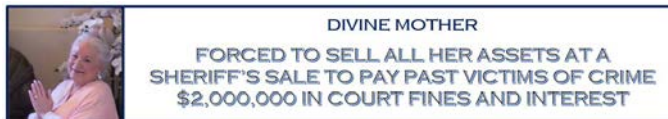

NEWS FLASH Patton West and her accomplices should be very worried about the fact that the [Department of Justice \(DOJ\)](#) which has just launched two new COVID-19 fraud strike forces. With 371 already charged for Covid 19 Fraud. **“This latest action, involving over 300 defendants and over \$830 million in alleged COVID-19 fraud,** should send a clear message: The COVID-19 public health emergency may have ended, but the Justice Department’s work to identify and prosecute those who stole pandemic relief funds is far from over,” he added.

The charges are the result of a COVID-19 fraud enforcement sweep that took place nationwide from May through the end of July.

Both Williams & Coffin are aware that (unlike private individuals like the whistleblower and countless others) the US government has endless resources to prosecute fraudsters. **So neither want to be associated with Patton West when the feds arrest her.** For this reason, and after a decades long association, Williams & Coffin jumped ship in 2021. 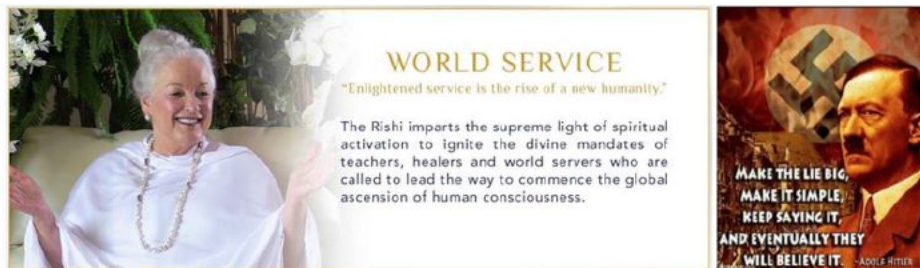

When is the 'Racketeer Influenced and Corrupt Organizations Act' (RICO) going to be applied to Patton West and her Accomplices?

Racketeer Influenced and Corrupt Organizations Act (RICO), U.S. federal statute targeting organized crime and white-collar crime. Since being enacted in 1970, it has been used extensively and successfully to prosecute thousands of individuals and organizations in the United States. Part of the Organized Crime Control Act of 1970, the Racketeer Influenced and Corrupt Organizations Act (RICO) makes it unlawful to acquire, operate, or receive income from an enterprise through a pattern of racketeering activity. Geared toward ongoing organized criminal activities, the underlying tenet of RICO is to prove and prohibit a pattern of crimes conducted through an "enterprise," which the statute defines as "any individual, partnership, corporation, association, or other legal entity, and any union or group of individuals associated in fact although not a legal entity."

In order for an individual or organization to be convicted of racketeering under RICO, there must be proof of a "pattern" of illegal offenses, which RICO defines as the commission of at least two identified criminal offenses within a 10-year period. RICO defines racketeering in an extremely broad manner and includes many offenses that do not ordinarily violate federal statutes, such as any act or threat involving murder, Kidnapping, gambling, arson, robbery, bribery, extortion or dealing in narcotic or other dangerous **drugs**.

From the above description of the RICO Act we can draw a number of conclusions:-

- 1.** The "enterprise" can be any individual, partnership, corporation, association, or other legal entity, and any union or group of individuals associated in fact although not a legal entity." Patton West, Jack West, Julio Williams, Geoffrey Reynolds and Corinne Coffin were clearly acting together in an "enterprise" described by Patton West as 'World Service.' It does not matter whether that relationship was legally formalized, though we can easily prove that Jack West, Julio Williams, Geoffrey Reynolds and Corinne Coffin were at times either formally employed, were partners, directors and officers in the various vehicles Patton West used as 'containers' for her criminal racketeering business model. There is also plenty of evidence to prove that Williams & Coffin funded Patton West's criminal activities to the tune of millions of dollars.

2. There must be proof of a “pattern” of illegal offenses, which RICO defines as the commission of at least two identified criminal offenses within a 10-year period. Hell, you could probably prove that Patton West commissioned two criminal offenses within a week or a month, let alone ten years! Above in this bulletin is a short list of some of the crimes Patton West committed in Montana. That list is the tip of the iceberg. Below is a list of some of the crimes committed by Patton West over the last three decades or more. That there is a three decade “pattern” of criminality in three western states cannot be disputed. I will highlight in yellow those crimes that constitute offenses under the RICO statutes.

THESE INCLUDED TWO CHILD CUSTODY CASES – COUNTLESS ACTS OF FRAUD INCLUDING AGAINST THE IRS, STATE AND LOCAL GOVERNMENTS.
