Jack West: His Specialty. Telling lies to the public. Telling lies under oath in court. Example 1. Lying to the public. In 2008 Patton West was the recipient of an arrest warrant for felony check fraud. In 2008 Patton West was the subject of a Sheriff's Sale to force her to pay past victims of crime \$2M in court fines and interest. In 2008 Patton West was convicted of assaulting her business partner Dr. Pat Cole MD. In 2008 Patton West was found guilty of defrauding the whistleblower John Watson. In 2008 Jack West posted a statement on his then wife's website stating, and I quote, **"She remains as utterly free of wrongdoing and as ethically virtuous as any human being can be."** In 2009 Patton West was the recipient of a second arrest warrant this time for felony theft.

Example 2. Lying under oath. In 2007, while being questioned in court under oath Jack West denied that the whistleblower John Watson was ever employed by his wife Patton West. When Watson's lawyer produced a letter signed by Jack West confirming Watson's employment Jack West said that Watson forced him to write the letter. Watson's lawyer reminded Jack West that making false statements to the INS (Immigration and Naturalization Service) was subject to a 10 year prison sentence. Jack West withdrew his lies.

Finally in 2004 the charity that Jack West and his then wife Patton West operated in Montana was struck off the charity register after massive fraud was reported to the authorities by the whistleblower. An ex-business partner of Jack West's reported criminal behaviour going back 40 years or more.

Corinne Coffin AKA Tanmayo. Her Speciality. Funding Organized Crime. Ignoring criminal acts occurring under her nose. In 2002 both the whistleblower John Watson and Corinne Coffin were 'recruited' by Patton West to launch a series of for-profit and non-profit corporations. To be clear Corinne Coffin and John Watson were business partners with Ms. Coffin agreeing to put up \$1 million in seed funds. Watson was hired as a management consultant tasked with setting up several corporations to form a group of companies to be headed by Patton West. Between January 2002 & August 2002 Watson found several serious crimes being committed by Patton West including the theft of funds from the charity to fund Patton West's lifestyle costs.

When Watson confronted Patton West with this information and suggested she operate within the law Patton West summarily dismissed Watson in August 2002 without the pay and shares he was promised. Watson reported the crimes to the authorities and Patton West's 'charity' was struck off. Corinne Coffin, totally under the control of Patton West, ignored Watson's dismissal and instead swallowed Patton West's lies about Watson's departure. This made Ms. Coffin an accessory to fraud. Ms. Coffin went on to fund the project to the tune of approximately \$736,000 knowing full well Watson had been defrauded. Watson sued Patton West for fraud and in 2008 was granted judgment against Patton West and was awarded \$736,000 by the judge. Watson never collected a cent of the award and along the way was the subject of a failed murder plot by Patton West in August 2007 and a criminal conspiracy to bankrupt him in 2010.

Corinne Coffin is a Brazilian national. In, 2002 during capital restrictions put in place by the Brazilian government, Ms. Coffin illegally funnelled money to Patton West through an intermediary in New York. Additionally she left her credit card with Patton West and topped it up regularly as Patton West spent the money. Ms. Coffin remained involved with Patton West's criminal operations right up until 2021 as 'treasurer' to the corporation Patton West was using as a front for organized crime. Even though (as explained in Jack West's section above) she witnessed Patton West's two arrest warrants, her conviction for assault, her conviction for defrauding the whistle-blower (her business partner) and knew about the Sheriff's Sale forcing Patton West to pay \$2M in court fines and interest to other victims of crime. Julio Williams MD. His Speciality. Funding Organized Crime. Marketing a Psychopath, Murderer and Suspected Serial Killer to the Public as a "Wellspring of Divinity." Threatening Victims and Witnesses who go public or go to court. Williams has been associated with Patton West since the year 2000. In 2005, in response to the whistleblower suing Patton West for fraud, Williams posted a statement on Patton West's website in which, and I quote, "**Williams staked his honor and credibility on defending her personal integrity and establishing the truth.**" As can be seen Williams has no honor or credibility and the very last thing Williams or his cult leader wants is to establish the truth. As made clear in Williams' expletive laden threatening email to John Watson in January 2007. Just as Watson's lawsuit was about to be concluded against Patton West. In his email Williams warned Watson not to f*ck with him and also announced that he had personally set aside 2M of his own fortune to fund Patton West's defense against Watson's and other victims lawsuits.

A strange thing to do considering Williams and Watson were total strangers. However it makes total sense when you realise that like Jack West and Corinne Coffin Williams was totally under Patton West's control. This also explains why Williams posted several idiotic sycophantic 'testimonials' on Patton West's website over the past two decades. He did this knowing about the multiple arrest warrants, the conviction for assault, the Sheriff's Sale forcing Patton West to pay \$2M in court fines and interest to earlier victims of organized crime. And there is the conviction against Patton West for defrauding Watson. Williams knew all about this. There is more. Dr. Williams even made his home available to Patton West, and was present, while she attempted to sell 'miracle cures for cancer' for five figure sums. Williams remained an 'officer' of Patton West's front company for organized crime until 2021

Geoffrey Reynolds CPA. His Specialty. A Pathological Liar. Reynolds announced the impending murder of a total stranger for going public about Patton West's crimes. Reynolds moved from California in September 2006 to take up what he thought was a regular job with Patton West's corporation which was a 'front' for organized crime. Reynolds quickly came to understand that he was not an employee in a regular corporation but was in fact a member of a cult / criminal racketeering gang ran by psychopath Patton West. However Reynolds did not realize this until after he had been manipulated into loaning his life savings, \$300K, to Patton West.

As fellow employee Rebecca West (no relation to Devil West) commented in an email to the whistleblower Reynolds, fearing he would not get his money back, fell totally under Patton West's control and proceeded to carry out her orders however illegal and immoral. For example Reynolds **announced the impending murder of the whistleblower John Watson to a local newspaper reporter just 7 days before Patton West made a failed attempt to murder Watson. Reynolds announced that Watson would be dead within 12 months or in jail for reacting to the violence Patton West was going to be meting out to Watson's wife and children.** The campaign of violence that Reynolds announced in August 2007 is **ONGOING** and a second attempt by Patton West was made on Watson's life in November 2023. So no statute of limitations for Reynolds!

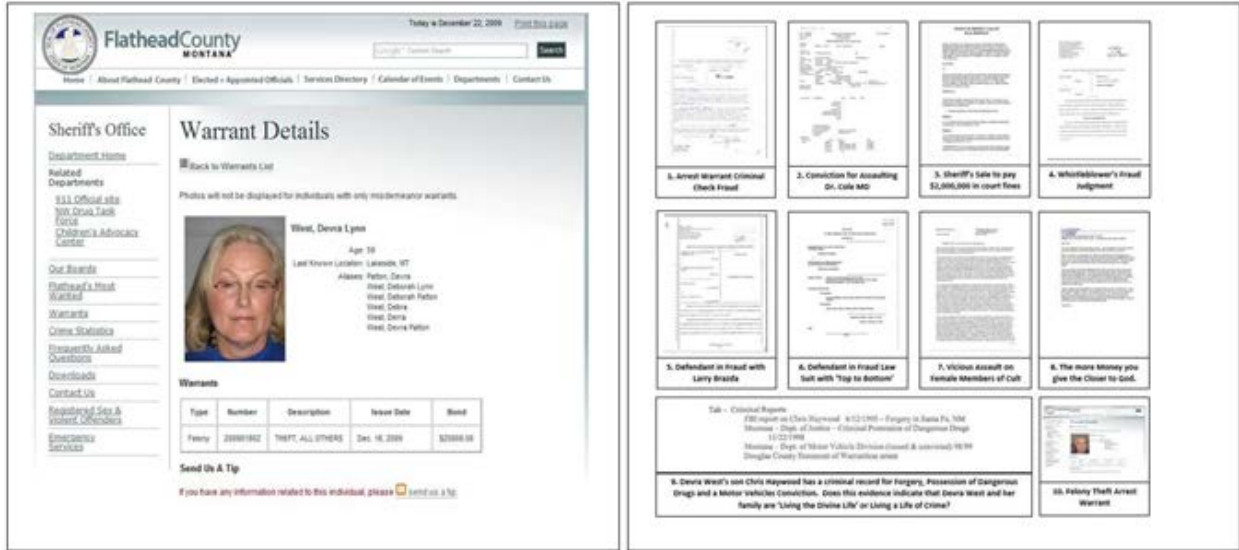
Reynolds posted several dishonest statements on Patton West's website vilifying the editor of a local newspaper for publishing the TRUTH about Patton West's crimes in Montana. **Reynolds also vehemently denied that Patton West had assaulted her business partner Dr. Pat Cole MD** even though there were several witnesses to the assault and the police were called. 3. Suspected Murders. **1.** Jack West, Patton West's ex-husband told the whistleblower in 2002 that those who opposed his wife had a habit of dying suddenly. The word 'those' implies multiple murders prior to 2002. **2.** Student / cult member [Lisa Swidler](#) a mother of two children under the age of 10 years died suddenly in 2005 while trying to escape the cult. We believe that Lisa was murdered by Patton West to stop Lisa from going to the police to report three serious crimes committed against other cult members. **3.** Then there is the well documented planned murder of the whistleblower, John Watson. Senior cult member and scumbag, Geoffrey Reynolds, actually announced Watson's impending murder **(1) & (2)** to the local press on August 9 2007.

In addition to announcing Watson's impending murder, Reynolds announced a campaign of occult violence to be directed against Watson and his wife and children. The objective being to 'silence' Watson, to take down his websites and to stop him telling the TRUTH so Patton West could move her 'shit' show to Arizona without the inconvenient TRUTH contradicting her lies and propaganda.

After moving herself and the cult to Arizona in 2010, Patton West changed her name (yet again) and awarded herself several new titles and accolades to be added to her totally false bio / life story (1) (2) & (3). Patton West does not live in a mansion as indicated on her website. Patton West does not have a 'Sedona Retreat' as indicated on her website. Patton West is variously homeless, living in Air B & B's while looking for the next big financial victim.

4. Crimes committed in Arizona. According to witnesses on the ground, Patton West recently defrauded the US Government out of \$500K in SBA Loans applied for by Patton West for non-existent employees. Witnesses on the ground allege that Patton West obtained the coordinates to a trust fund belonging to the mother of one of her cult slaves, Lolita Jordan. After Lolita was brainwashed, conditioned and Patton West forced her to accept a demon into her body Lolita gave up the coordinates to her mother's trust fund which Patton West emptied into her own bank account. Then there is the theft of thousands of dollars of artwork from a local artist.

Williams and Coffin only distanced themselves in 2021 after Patton West defrauded the US Government out of \$500K in SBA Loans!

Williams sent a threatening email to Watson in January 2007, in a vain attempt to intimidate him into taking down his website and dropping his lawsuit against Williams' cult leader Patton West. When that did not work, Rat Reynolds announced Watson's impending murder by Patton West on August 2007. The campaign of violent intimidation Reynolds also announced against Watson and his family is ongoing. Coffin has funded Patton West's criminal enterprise to the tune of millions of dollars. Like Williams, Coffin has been on board for over two decades. Jack West has been onboard for at least 40 years. This is a criminal gang.

Violence and Murder are accepted by all. Reynolds, Williams & Jack West are certainly complicit in the attempted murder of Watson and Williams & Coffin has bankrolled the whole operation for two decades or more.

Above from left to right: A psychopath pretending to be a 'World Server.' Remember the devil himself appears as an angel. Who in their right mind believes that a member of the public would willingly donate hundreds of thousands of dollars to a career criminal with a 32 year history of organized crime in three western states? It is all about the money!

Posing in yards of curtain material, holding large bouquets of flowers, is part of the illusion that Patton West is a guru and not a career criminal, murderer and suspected serial killer. What follows are some examples which demonstrate how Patton West, with the help of accomplices, has extorted tens of millions of dollars from wealthy victims. The first thing to understand, is that Patton West uses occult (hidden) knowledge as a [secret weapon](#). This weapon is used to intimidate, injure and murder those who go public, to the police or the law courts. The weapon is also used to generate vast sums of money from victims of extortion.

	<p>Based on the whistleblower John Watson's estimates Patton West has robbed, defrauded and extorted an estimated \$50 Million dollars over the past three decades or more and paid ZERO tax on any of it. As one of her employees attested (see below) Patton West received \$500K from one victim alone in 2002.</p> <p>Most of Patton West's ill-gotten gains were converted into precious metals or artwork and other valuables. Virtually none of the proceeds of organized crime went through her bank account as other witnesses attest (see below).</p>

Here are two examples that the whistleblower became aware of during his time working for Patton West as a business consultant back in 2002.

PLAYBOOK 1. All the potential victims that attend Patton West's 'private' sessions or 'spiritual' retreats are by definition, individuals (mainly female) who are susceptible to brainwashing and conditioning. Patton West plays on this by convincing some of her targets that they were sisters in a previous lifetime and, that during that lifetime, the target betrayed Patton West. Therefore they must pay Patton West in this lifetime to make amends. Those that immediately fall for this BS make a 'donation.' Those that are reluctant or outright refuse are told that the Ascended Masters are watching them and that if they do not make reparations they, the Ascended Masters, will make them progressively ill in the days ahead until they do pay. This is sold to the victim as karma. Most victims become 'believers' after several days of extreme migraine headaches, digestive issues or being unable to sleep.

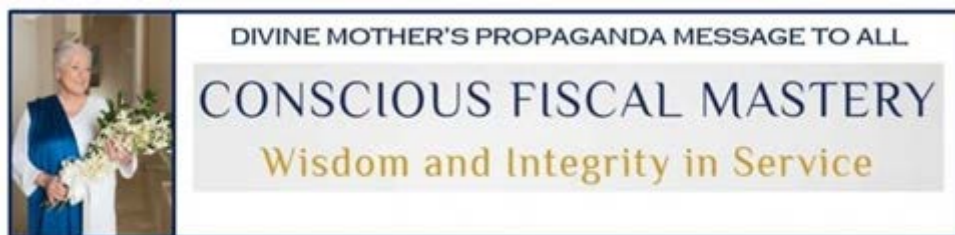
The above is an excerpt from a lengthy posting the Master Liar posted on Facebook. Patton West is offering 'Divine Grace healings' (read miracle cures for money) she also offers the dispensation of (bad) karma for money.

PLAYBOOK 2. The other approach is that during a 'private' session Patton West informs the 'targeted' individual that they have a brain tumour or cancer. Patton West offers to cure or remove the condition in return for a huge sum of money. Those who swallow every lie that Patton West utters, pay up. Those that do not pay are told that the (non-existent) condition will make itself known in the days ahead. In the days ahead, just as predicted by Patton West, the targeted individual gets bad migraine headaches and other medical conditions that seem to affirm Patton West's diagnosis. Most of these individuals also become 'believers' and pay up. As with group (1.) above they are the victims of a massive deception. In the above example shared by Kathleen Francisco, one victim paid \$500,000. This money was paid in 2002 / 2003. NONE of the \$500,000 was declared to the IRS and NONE of it went to the charity that Patton West was heading at the time. A charity that was [struck off](#) the Montana charity register in January 2004, after the whistleblower reported Patton West to the Secretary of State for Montana and the IRS. According to two employees, by the time the IRS arrived, Patton West had [shredded](#) all the documentary evidence.

As stated above, the rank and file members of her cult (employees and 'students') provide the bread and butter to fund Patton West's luxurious lifestyle and daily expenses.....

Patton West always has some headline 'save the planet' scheme around which she fundraises. The millions of dollars raised was never used for the reasons espoused but rather always ends up funding her luxurious lifestyle which includes servants and a chef. One such victim was Dr. Pat Cole MD who was recruited and brainwashed and conditioned into believing the latest greatest scam, which was to build Spa Developments for autistic patients. After Patton West's charity was struck off for fraud in January 2004, Patton West moved her shit show from Victor MT to Lakeside MT which Patton West referred to as 'Shamballa.'

In a [letter sent to every member of her cult](#), Patton West announced that only those ~~slaves~~ students and employees (cult members) who committed 66% of their net worth would be eligible to travel to 'Shamballa' with her. Dr. Cole was one of those who apparently agreed. Apparently, Dr. Cole took too long to hand over her net worth so Patton West launched a campaign of violence against Dr. Cole MD to speed up the process. After one particularly vicious assault, the police were called in and Patton West was in 2008, convicted of misdemeanor assault and fined \$500 and given a 6 month suspended prison sentence.

Spiritual guru pleads guilty in assault

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.

Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.

After entering her plea, Devra West was sentenced to

a six-month deferred jail term and fined \$500.

Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.

Justice of the Peace David Ortley issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.

West's trial was postponed

from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.

West's trial originally was scheduled for April 2007.

Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.

Patton West should have been jailed for felony assault but, as with all other complaints against her, she lined up several cult members who agreed to lie on her behalf. This incident was covered in detail in two newspapers and by witnesses one of whom, Carlida Finch, overheard Patton West talking about murdering Dr. Cole MD. Here are links to the evidence.

Williams has been a willing accomplice in Patton West's criminality for over two decades. 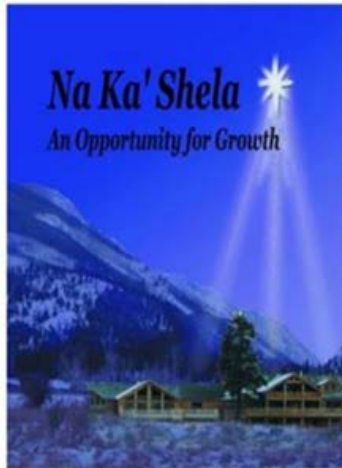

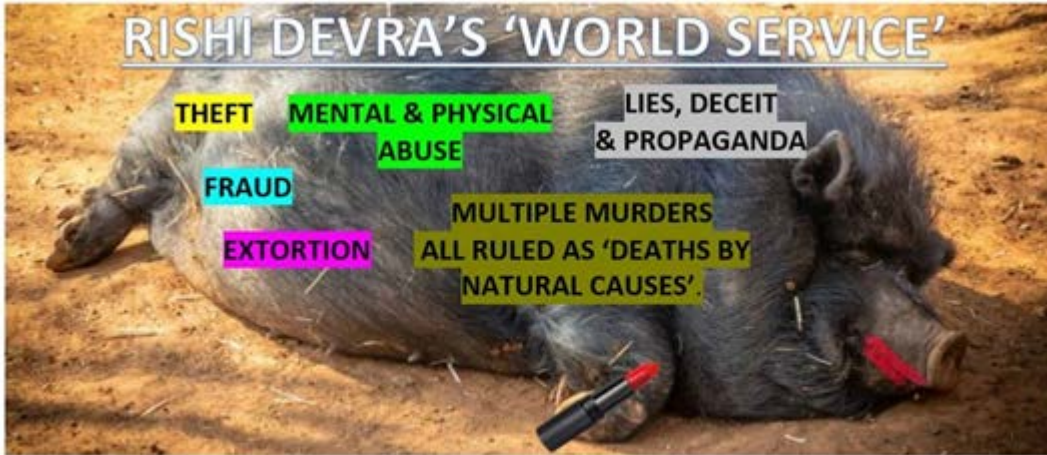
