CRIMINALLY INSANE NARCISSIST





In March 2007 one of Patton West's employees, Rebecca, went public about the crimes being committed by Patton West on an industrial scale against her own employees. In response Patton West used her 'secret weapon' against Rebecca who asked the whistleblower for help dealing with Patton West's "Shamanic witchcraft." In her email Rebecca wrote about the huge turnover in employees. New recruits had their wages and benefits cut on day one of their employment. Patton West subsequently wrote to Rebecca stating that it was, and I quote, "A good day to die."

And...



Patton West's 'policy' is to offer employees high wages and conditions as an inducement to get them to give up their employment elsewhere and in some cases move from different parts of the country to work for her charity (cult). Within days of taking up employment the advertised wages are reduced and the advertised health insurance is withdrawn. By 2003 Joseph Costantino was owed \$20,000 in salary and overtime which Patton West refused to pay. After taking Patton West to an employment tribunal Joseph settled for \$10,000. In 2003 Joseph had facilitated multiple statements from employees about the crimes being committed by Patton West against them. Shortly afterwards Joseph died suddenly.







In 2005 Lisa Swidler, a student and teacher at Patton West's unaccredited school for occult studies, died suddenly and unexpectedly leaving behind two small children under the age of 10 years. Maybe it was a total coincidence that at the time of her sudden death Lisa had fled the cult and was likely going to the police to report three serious crimes she had witnessed Patton West committing against other 'students.' Dave Kushner was defrauded out of \$30K. Mike Hendrickson defrauded out of \$200K. And last but not least Marion Cantwell was kidnapped, held hostage and beaten until she agreed to make a large donation to Patton West from the sale proceeds of her house.

After Patton West's charity was struck off for fraud in January 2004 Patton West had no choice but to move her cult / criminal operations to a new location. Accordingly she wrote to all of her cult members telling them that she was moving to 'Shamballa' and that only those willing to commit 65% of their net worth were allowed to follow her there. Shamballa being Flathead Lake which was one hundred miles north of her previous location. Dr. Pat Cole signed up to give her wealth away. Unfortunately for Cole she did not give up her wealth as fast enough so Patton West initiated a campaign of violent beatings to speed things up. Another employee, Carlida Finch, overheard Patton West saying that she did not care if she murdered Cole as being an enlightened being Patton West could as easily live in a 6' X 6' jail cell as in a \$6M mansion.

In 2005, having just sold her home, Marion Cantwell was kidnapped by Patton West, falsely imprisoned and beaten until she agreed to make a large donation to Patton West's good causes (herself). Upon release Marion was told that she would be murdered if she went to the police. Some months later the whistleblower had a phone call from Marion's new employer. Apparently Marion had shared her experiences with her new employer who wanted to make sure that Marion was indeed a victim and not an active member of Patton West's cult / criminal racketeering gang. The whistleblower was happy to confirm that Marion was indeed a victim.







After being defrauded out of wages and shares fraud victim turned whistleblower sued Patton West a lawsuit he won in 2008. However along the way on August 9 2007 senior cult member Geoffrey Reynolds announced Watson's impending murder to a local newspaper reporter. The newspape reporter took the threat seriously and shared it with a federal agent who was investigating Patton West at the time. Approximately one week later Patton West made a failed attempt to murder the whistleblower. As well as announcing Watson's impending murder Reynolds also announced a campaign of occult violence against Watson, his wife and children which is ongoing. More recently, in November 2023, Patton West made another attempt to murder Watson using a different tactic. Reynolds did not announce this in advance! Corinne Coffin AKA Tanmayo. Her Speciality. Funding Organized Crime. Ignoring criminal acts occurring under her nose. In 2002 both the whistleblower John Watson and Corinne Coffin were 'recruited' by Patton West to launch a series of for-profit and non-profit corporations. To be clear Corinne Coffin and John Watson were business partners with Ms. Coffin agreeing to put up \$1 million in seed funds. Watson was hired as a management consultant tasked with setting up several corporations to form a group of companies to be headed by Patton West. Between January 2002 & August 2002 Watson found several serious crimes being committed by Patton West including the theft of funds from the charity to fund Patton West's lifestyle costs.

When Watson confronted Patton West with this information and suggested she operate within the law Patton West summarily dismissed Watson in August 2002 without the pay and shares he was promised. Watson reported the crimes to the authorities and Patton West's 'charity' was struck off. Corinne Coffin, totally under the control of Patton West, ignored Watson's dismissal and instead swallowed Patton West's lies about Watson's departure. This made Ms. Coffin an accessory to fraud. Ms. Coffin went on to fund the project to the tune of approximately \$736,000 knowing full well Watson had been defrauded. Watson sued Patton West for fraud and in 2008 was granted judgment against Patton West and was awarded \$736,000 by the judge. Watson never collected a cent of the award and along the way was the subject of a failed murder plot by Patton West in August 2007 and a criminal conspiracy to bankrupt him in 2010.

Corinne Coffin is a Brazilian national. In, 2002 during capital restrictions put in place by the Brazilian government, Ms. Coffin illegally funnelled money to Patton West through an intermediary in New York. Additionally she left her credit card with Patton West and topped it up regularly as Patton West spent the money. Ms. Coffin remained involved with Patton West's criminal operations right up until 2021 as 'treasurer' to the corporation Patton West was using as a front for organized crime. Even though (as explained in Jack West's section above) she witnessed Patton West's two arrest warrants, her conviction for assault, her conviction for defrauding the whistle-blower (her business partner) and knew about the Sheriff's Sale forcing Patton West to pay \$2M in court fines and interest to other victims of crime. Geoffrey Reynolds CPA. His Specialty. A Pathological Liar. Reynolds announced the impending murder of a total stranger for going public about Patton West's crimes.
