

Then there are the threats of murder and several actual murders....

CRIMINALLY INSANE NARCISSIST



In March 2007 one of Patton West's employees, Rebecca, went public about the crimes being committed by Patton West on an industrial scale against her own employees. In response Patton West used her 'secret weapon' against Rebecca who asked the whistleblower for help dealing with Patton West's "Shamanic witchcraft." In her email Rebecca wrote about the huge turnover in employees. New recruits had their wages and benefits cut on day one of their employment. Patton West subsequently wrote to Rebecca stating that it was, and I quote, "A good day to die."

And..



Patton West's 'policy' is to offer employees high wages and conditions as an inducement to get them to give up their employment elsewhere and in some cases move from different parts of the country to work for her charity (cult). Within days of taking up employment the advertised wages are reduced and the advertised health insurance is withdrawn. By 2003 Joseph Costantino was owed \$20,000 in salary and overtime which Patton West refused to pay. After taking Patton West to an employment tribunal Joseph settled for \$10,000. In 2003 Joseph had facilitated multiple statements from employees about the crimes being committed by Patton West against them. Shortly afterwards Joseph died suddenly.

In 2005 Lisa Swidler, a student and teacher at Patton West's unaccredited school for occult studies, died suddenly and unexpectedly leaving behind two small children under the age of 10 years. Maybe it was a total coincidence that at the time of her sudden death Lisa had fled the cult and was likely going to the police to report three serious crimes she had witnessed Patton West committing against other 'students.' Dave Kushner was defrauded out of \$30K. Mike Hendrickson defrauded out of \$200K. And last but not least Marion Cantwell was kidnapped, held hostage and beaten until she agreed to make a large donation to Patton West from the sale proceeds of her house.

After Patton West's charity was struck off for fraud in January 2004 Patton West had no choice but to move her cult / criminal operations to a new location. Accordingly she wrote to all of her cult members telling them that she was moving to 'Shamballa' and that only those willing to commit 66% of their net worth were allowed to follow her there. Shamballa being Flathead Lake which was one hundred miles north of her previous location. Dr. Pat Cole signed up to give her wealth away. Unfortunately for Cole she did not give up her wealth as fast enough so Patton West initiated a campaign of violent beatings to speed things up. Another employee, Carlida Finch, overheard Patton West saying that she did not care if she murdered Cole as being an enlightened being Patton West could as easily live in a 6' X 6' jail cell as in a \$6M mansion.

In 2005, having just sold her home, Marion Cantwell was kidnapped by Patton West, falsely imprisoned and beaten until she agreed to make a large donation to Patton West's good causes (herself). Upon release Marion was told that she would be murdered if she went to the police. Some months later the whistleblower had a phone call from Marion's new employer. Apparently Marion had shared her experiences with her new employer who wanted to make sure that Marion was indeed a victim and not an active member of Patton West's cult / criminal racketeering gang. The whistleblower was happy to confirm that Marion was indeed a victim.

After being defrauded out of wages and shares fraud victim turned whistleblower sued Patton West a lawsuit he won in 2008. However along the way on August 9 2007 senior cult member Geoffrey Reynolds announced Watson's impending murder to a local newspaper reporter. The newspaper reporter took the threat seriously and shared it with a federal agent who was investigating Patton West at the time. Approximately one week later Patton West made a failed attempt to murder the whistleblower. As well as announcing Watson's impending murder Reynolds also announced a campaign of occult violence against Watson, his wife and children *which is ongoing*. More recently, in November 2023, Patton West made another attempt to murder Watson using a different tactic. Reynolds did not announce this in advance! We will share the details with law enforcement.

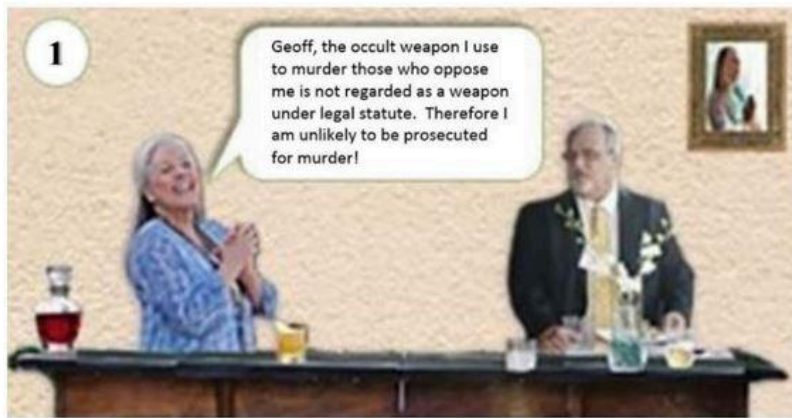


Between January 2002 & August 2002 the whistleblower worked as a business consultant for Patton West. Watson found rampant fraud. Patton West's husband Jack West told the whistleblower that those who opposed his wife had a habit of dying suddenly. A clear warning not to rock the boat.

Because the 'weapon' Patton West uses to rob, defraud, extort, embezzle, injure, make ill and murder is not recognized as a weapon the police and the law courts have so far been impotent. However after 33 year racketeering, thousands of acts of terrorism and several suspicious deaths we believe there is enough evidence to have Patton West (and her accomplices) tried under R.I.C.O. statutes if not for murder or attempted murder then for racketeering and thousands of acts of terrorism.

So confident was Patton West that she could prey on her victims with impunity she actually got one of her cult / gang members Geoffrey Reynolds to announce the impending murder of John Watson to a local newspaper. Watson a business consultant was defrauded by Patton West in 2002 (one of a score of professionals 'employed' by Patton West as potential victims). Watson an ex-marine launched a fraud lawsuit against Patton West in 2003 which he won in court in 2008. In 2007 Patton West's stooge Reynolds announced Watson's murder. Within a week Patton West launched a failed attempt on Watson's life. In October 2023 a second attempt on Watson's life was launched by Patton West. It too failed. The point being Patton West, and her accomplices, believe it will be impossible to link the violence and murders to Patton West so they are not afraid to go public with what is going to happen to those who oppose Patton West. Opposing Patton West being going to the police (useless so far), going to law or going public.

Constance See shared Reynolds' threat with an IRS criminal investigator who was looking into Patton West's finances after Watson reported massive fraud to the the Secretary of State for Montana. As a result Patton West's charity, a front corporation for fraud was removed from the Montana charity register in 2004. Unfortunately Montana and other western states are still the 'wild west when it comes to prosecuting crime. They either do not understand 'white collar' crime or do not have the resources to prosecute it. Hence Patton West moving from one western state to another and upon arrival she uses the same tried and tested business model. Claim to be an Ascended Master, offer enlightenment for a huge fee and, having identified the wealthy amongst the spiritual seekers use her occult weapon to rob, defraud and extort from them.

As stated above the senior members of her cult are not shy about going public as they believe they will never be called to account for their crimes. Take senior cult member Dr. Julio E Williams MD a 20 year member of Patton West's cult / criminal racketeering gang who has 'marketed' Patton West to the public as a "wellspring of living divinity." Williams has funded Patton West's crimes and after Watson sued Patton West Williams sent him a lengthy expletive laden email in a vain attempt to intimidate Watson into dropping his lawsuit against Patton West. Spiritual guru pleads guilty in assault

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.

Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.

After entering her plea, Devra West was sentenced to

a six-month deferred jail term and fined \$500.

Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.

Justice of the Peace David Ortley issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.

West's trial was postponed

from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.

West's trial originally was scheduled for April 2007.

Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.

CONVICTION FOR FOR ASSAULT

Above, an excerpt from Williams' email to Watson in January 2007. Note that Williams pledged \$2M to defend Patton West's crimes. Six months before Reynolds announced Watson's murder. Above right a statement Williams posted on Patton West's website in 2005 after Watson launched his fraud lawsuit against Patton West. Bottom right a newspaper article announcing Patton West's conviction for assaulting her business partner Dr. Pat Cole MD. Patton West launched a campaign of overt and covert violence against Cole whose objective was to extort Cole's entire net worth estimated at \$1.3 million. Patton West succeeded in extorting those funds. As for the campaign of violence Patton West was fined \$500 and given a 6 month suspended prison sentence. As explained above the authorities are totally inept at dealing with a violent criminal / murderer like Patton West. We know that after the judgement / conviction Patton West did not stop the violence. All she did was drop the covert violence. An example of which was to repeatedly hit Cole over the head with the heel of her shoe until blood ran down the victim's blouse. Instead she focussed on the covert violence using her occult (hidden) weapon. Examples of this we will give below.



We wish to make it very clear that Coffin, Williams & Reynolds knew exactly what was going on. How could Reynolds not know after announcing Watson's murder. How could Williams not know after issuing his threat to Watson and pledging \$2M of his personal fortune to defend Patton West in court against her scores of victims? How could Coffin, after 30 plus years of association with West and after funding her between \$1M & \$2M dollars not know what was going on? Documents (see below) show that both Coffin and Williams were 'officers' in Patton West's current 'front' corporation until 2021. They only resigned after Patton West defrauded the US government out of \$500K in SBA (Covid) disaster loans.

Unlike Watson and scores of other individual victims Coffin & Williams knew that the US government had unlimited resources to prosecute crimes.

There have been so many serious crimes committed against scores or hundreds of victims in NM, MT & AZ with little or no action brought against the perpetrators that we wonder if Patton West has been given a license to commit murder...

Here are some more examples of the attacks upon the whistleblower John Watson. These attacks are ongoing.

2005. In 2005 Patton West was defrauded out of \$600,000 by two con artists Wilson & Ross. Where did Patton West get \$600,000 from since she pays no tax? Patton West's response was to start 'harvesting' the wealth of the those trapped inside her cult.

Dave Kushner. Was manipulated into loaning Patton West \$30,000. He even got a signed loan agreement from Patton West promising to repay the loan within 14 days. He never got a cent back and the berder refused to even talk to him.

Marion Cantwell. Was kidnapped, held hostage and beaten until she agreed to give up part of the sale proceeds of her house to Patton West. When released she was told that if she went to the police she would be murdered.

2005. Mike Hendrickson was a long term member of Patton West's cult. Mike was a wealthy partner in a Colorado Accountancy firm. Mike was persuaded to sign a personal guarantee on the 'charity's' bank account. The charity being a 'front' for organized crime.

As stated elsewhere after the Wilson & Ross debacle Patton West decided to recoup some of her 'losses' by 'harvesting' as much as she could from her herd. In Mike Hendrickson's case Patton West emptied the charity's bank account which meant Mike had to honor the loan guarantee. Mike had to pay the bank \$200,000. Like Dave Kushner and Marion Cantwell Mike Hendrickson decided to walk away empty handed knowing he would be targeted / terrorized if he went to law.

2005. Lisa Swidler was a long term 'student' of Patton West's and was also a 'teacher' at Patton West's unaccredited school for occult studies. 2007. The following comments were sent to the John Watson the whistleblower by Patton West's then office manager Rebecca West in March of 2007. Rebecca is not related to Patton West.

"I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. I need support in how to deal with her shamanic witchcraft. Can you tell me more?"

She was 'terrorized' by Patton West's occult weapon!

And this...

27 January 2025. Woke up at 4.30 am to very loud hissing. I guess I was targeted overnight as my prostate area sore. Attack continued to grow in intensity. At about 9.00 am the 'burping attack' arrived. I took two Gas Ex pills which stopped the burping and vomiting but three bouts of diarrhea followed.

Clearly this level of intimidation did not work so Patton West added simultaneous attacks to my heart and head. The attacks to my heart manifest as a deep bruise feeling. Ditto attacks to the head which manifest either as a full blown headache or as a more focused 'spike' to a certain area in the brain. This has been going on for 18 years.

25 January 2025. Woken up at 4.00 am. Hissing really loud could not go back to sleep. Stinging sensation in prostate I guess that was the overnight target. Got up surfed YouTube etc.

Attack increased all morning. Mid-afternoon attack to my heart started and persisted until 6.00 pm (bruised feeling as per the last 18 years). Currently my head is being targeted. Spikey headache on my right side.

We were both in bed reading and both of us realized that we were each being targeted with the 'burping' attack. Fortunately we now know the drill and both took extra strong Gas Ex pills which seemed to mitigate it.

24 January. Woken up at midnight on 23 January. Could not go back to sleep because of the loud hissing. Had a meal at 2.00 am today (24 January). Tried to do Yoga after the meal. This involves lying flat in bed. Hissing too loud so abandoned that idea. Went to use the computer. The hissing got louder and the 'prostate / bottom' attack got more forceful.

The idea that anyone can decide how I use my computer and TV is totally unacceptable. This level of intimidation has happened to scores or hundreds of victims over the past three plus decades. Now I have lined up a mountain of compelling evidence maybe they will do their jobs and seek to protect the public from this 'apex predator'.

January 18 2025. Every time I used a keyboard I would get attacked in the bottom (prostate) and it would be uncomfortable sit down. So to use my computer I had to stand up and use the kitchen work surface.

I do not think Patton West spends 24 hours a day 'remote viewing' her victims. I believe that she sets up the equivalent of software programs for each of her targets to stop the truth getting out she sets up a series of programs. So if 'condition' (a) occurs (I get on my computer) it automatically sets off 'program' (b) (an attack to my prostate). Ditto if I lay down in bed at night to go to sleep that 'condition' being met 'program' (b) results in an attack to my prostate. etc. I said elsewhere that the response is sometimes within 3 minutes but can be as little as 30 seconds so it has to be a 'program.'

In this way she can set up dozens of 'programs' as required depending on whether she wants to slowly murder someone (Joseph Costantino prostate cancer). Or intimidate someone into remaining silent after being robbed, defrauded or violently assaulted (me and countless other victims).

January 04 2025. I came under one of Patton West's most draining attacks or it used to be until I learned how to neutralize it. If you saw the film the 'Witches of Eastwick' in which the nagging wife is the subject of an occult attack by the Jack Nicholson character. In the film the nagging wife starts retching then starts vomiting up frogs or toads. The toads did not materialize.

What is supposed to happened when one is subject to this attack is this. One begins burping uncontrollably and one has to rush to the bathroom where one proceeds to empty ones stomach contents. There is more. Over the next hour or so one is forced to walk around either with a glass in hand or with copious amounts of paper towel in ones hands to soak up the uncontrollable amounts of saliva that suddenly start pouring from one's mouth. I call it the 'burping attack.' This attack is draining both physically and emotionally. My wife and daughter have been subject to this attack many, many times.

September 18 2024. Woken up at 3.30 am. Loud hissing. Dozed off for a few minutes. At 4.15 am I awoke again. There was a loud hissing. Upon waking up I tried to move and found I was paralyzed i.e. could not move at all. I realized that I was under attack again by Patton West. The loud hissing was a give-away!

This was a repeat of the August 2007 attempt to murder me by Patton West and exactly what Tucker Carlson endured recently.

This was the murder attempt that Reynolds referred to when he announced my impending death in an 'off the record' discussion with Constance See, the Bigfork Eagle news reporter. Constance passed on the threat to John Nielson the IRS investigator.

However unlike the August 2007 attack which was very hard to break (I nearly did die then) this attack was much easier to break. With a little focus I was able to break the paralysis and rather than risk going back to sleep I got up.

The definition of terrorism is the use of force or intimidation to coerce someone into doing something against their will. In Patton West's case it is forcing victims to empty their bank accounts into hers otherwise known as 'donations.'
