So why has Patton West, AKA 'The Rishi,' AKA 'Surya Ma,' AKA 'Devra Ji' not been arrested for Murder, Attempted Murder, Racketeering and Thousands of Acts of Terrorism?

The answer is twofold.

Firstly, In spite of Patton West's obvious pedigree and background as a career criminal the Secret Weapon Patton West uses to manipulate, subdue, rob, defraud, extort money from and terrorize her victims with is not regarded as a weapon under legal statute. So the authorities just ignore the problem. Which is one reason why Patton West has not been arrested and tried for her crimes.

Secondly, The other reason is that most victims have been too afraid to go to law for restitution, to go to the police, or go public by sharing their experiences with the newspapers.



However not every victim is cowed into submission by the occult killer. Take the case of John Watson, a fraud victim at Patton West's hands in 2002, that took Patton West to court and won his fraud lawsuit against her. In 2008 Watson was awarded \$736,000 by a Montana court that Patton West never paid. The following is the strategy that Patton West uses against those who 'oppose' her by refusing to remain silent. As with John Watson, after he launched his fraud lawsuit against Patton West in 2003 she did not respond to the lawsuit directly. Why? because as with 95% of her victims she knew she could intimidate them or murder them before the matter got to court. Which is why in December 2006 Patton West launched a campaign of occult violence against Watson, his wife and his children.

Details of what those occult (hidden) violent attacks look like will be spelt out in some detail below in this bulletin.

For now we want to make it clear that Patton West has not acted alone. For example in the run up to Watson winning his lawsuit against Patton West senior cult / criminal racketeering gang members, acting on Patton West's instructions, tried to intimidate Watson into dropping his lawsuit against their cult / gang leader Patton West. The following is an excerpt from an email Julio Williams sent Watson in January 2007...



Julio Williams MD is one of Patton West's brainwashed and conditioned droids that has funded her for 20 years, marketed her to the public as a "virtual wellspring of living divinity" for 20 years and was used by Patton West to threaten victims who refused to remain quiet. Note above that Williams pledged \$2,000,000 of his own money so that Patton West could 'outspend' her victims in a multiple civil court proceedings brought against her (some of these court cases listed below in this bulletin).

Watson an ex-marine was not impressed by Williams' attempt at intimidating him. Watson being the plaintiff in a lawsuit brought against his cult / gang leader. When Williams' threat was ignored Patton West upped the anti by getting another brainwashed and conditioned droid in her cult to announce Watson's impending murder. He did not know Watson from Adam i.e. Watson was a total stranger to Reynolds but Reynolds gladly and confidently announced a future murder to a local newspaper. Just a few days later a failed attempt by Patton West to murder Watson occurred just as Reynolds had predicted. And just FYI the campaign of occult attacks that Reynolds announced against Watson and his wife and children continues to this day some 18 years later!

Brazil spooky goings-on Unexplained incidents unnerved cops. Detectives questioning the celebrity medium in the police station, accused of sexually abusing more than 300 women, have reported during their two hour interrogation. ranging from a 'bizarre' computer crash to wiring on electrical appliances suddenly 'short circuiting' appears to suggest supernatural forces were at play during the interview. The mysterious problems but didn't deter them from collecting the testimony from faith healer, João Teixeira de Faria, who is known as João de Deus – John of God on Sunday night in Goiânia.

Strange things started to happen the computer seemed to have a life of its own. Detective Karla Fernandes, responsible for coordinating the task force investigating the allegations, claimed that as the spiritual guru began to speak, .She said to Folha de Sao Paulo: 'Suddenly the computer that was being used to transcribe the suspect's answers to the allegations seemed to and the commands on the keyboard wouldn't work.

When the clerk tried to enter the medium's statement, the keys locked on a and '0000000' which was recorded continuously on the screen for a few seconds. 'Although this has never happened before, bemused agents put the incident down to a faulty computer. 'I plugged the lead into an extension shared with a mini-fridge and the 'electrical wiring suddenly exploded, burning out the fridge. Everyone in the room screamed with fright. 
Two. They both use the occult to manipulate their victims. So to make this very clear let me explain this 'Barney' style.







So it is not a problem for occult 'masters' (psychopthic killers) like Patton West to 'hack' their victims energy / astral bodies and, using Shamanic Vicioning in Patton West's case, induce illness, suffering, pain, serious illness and death. He has agreed to share portions of his journal with us. To be clear he and his wife and children have been subject to these attacks for 18 years. And there have been two attempts by Patton West to murder him for going public with the truth. Here are some excerpts from the diary the whistle-blower a victim of occult attacks by Patton West for 18 years and counting. This journal being created to shared with a judge and jury in a R.I.C.O. trial soon, hopefully, to be mounted against patton West and her cult / gang members Julio E Williams MD, Geoffrey reynolds CPA, Corinne Coffin and last but by no means least Jack West.





19 March 2025. Since last July my groin area has been attacked pretty much every day. To be clear if I sit on a chair my prostate / groin / testicles are targeted. It results in me getting so sore it is hard to sit down. I am attacked in the same way while in bed which makes sleep difficult. I am even attacked in the same way while lying in the bath. I would say that 97% of the attacks to my groin are designed to cause pain. Though I classify those attacks as rape because it feels like I have something placed / lodged inside my rectum. The other 3% are out right rapes that end in an orgasm.

08 April 2025. Recently the attacks have increased in tempo and severity. The attacks to my groin have continued and there have been several rape attacks upon myself that ended in a forced orgasm. Again sitting down, having a bath and while lying in bed is when it is worse. If I am moving around the apartment or out for a walk I feel little or nothing. Recently the 'full on' rape attacks have changed. Now, during the full on rape attacks, I can hear my heart thumping very loudly. Maybe a heart attack is her true objective. Recently another dimension to the attacks has occurred. While I always hear the 'hissing' (the carrier wave announcing an occult attack) in my left ear lately I have started to hear other sounds in my right ear. The most common sound appears to be like a cloud of mosquitos buzzing. Another sound is as though there are strong winds blowing. I have also heard music repeating, one song over and over again. The above is in addition to the regular attacks i.e. diarrhea, gas attacks migraine headaches, sleep deprivation etc.

My wife reported that four days ago she was attacked in the groin between her anus and vagina. She reported that it was as though she was being scratched badly. She also reported that, two days ago, she was subject to the full on psychic rape attack. As I type my wife is having a salt bath as a response to the latest attack which is causing her to experience extreme nausea. I guess Patton West is getting desperate.

09 April **2025**. Having gone to bed drugged up at 6.00 PM on the evening of 08 April I was awoken at just after midnight at 12:12 AM on the morning of the 09 April. I awoke to hear the hissing incredibly loud in my left ear with the buzzing sounding like a cloud of mosquitos in my right ear.

I got out of bed and immediately realized I was having trouble balancing. I was incredibly nauseous and could not think straight. My eyesight was also misty like everything was out of focus. I walked around the apartment a few times and decided to make myself a cup if tea and eat something to ground me. Over about an hour while watching TV my eyesight slowly improved. I went back to bed at about 1.45 AM and managed to get a couple of hours more of sleep before waking up again at 5.00 AM. I am writing this at 5.45 PM on the 09 April. My wife Lisa is in the bedroom dealing with the gas attack. She is currently belching and expects to either vomit or have diarrhea in the next 30 minutes.

April 28 2025. The last ten days have been bad especially for my wife.

April 30 2025. The attacks to my groin were followed by three hours of shamanic rape designed to cause pain and humiliation. This on top of migraine headaches, nausea etc. The sound of whirring insects / wind noise in my right ear accompanied by loud hissing in my left ear.

May 02 2025. The worst night so far. The shamanic rape started before I went to bed at 6.30 pm (we go to bed early hoping we will get some sleep). The rape started while I was sat in my arm chair. I went to bed at 6.00 pm and the rape continued until 2.00 am. This version of 'rape' designed to cause pain. I was very sore when I got up the following morning. The rape accompanied by loud buzzing insect sounds in my right ear. So whirring noise in my right ear with loud hissing in my left ear.

May 04 2025. Attacked at night as per above / preceding.

May 05 2025. Attacked in the groin / shamanic rape all day. Sitting down, having a bath, driving the car all day long the feeling I am being penetrated up the rectum. I am typing this at 6.00pm in the evening. Still getting attacked in anus / prostate.

May 08 2025. All day attack to prostate / shamanic rape. I was sat at the dentists for a 10.00 am appointment and while waiting I could feel my groin / genital area vibrating. It was very subtle but perceptible as an actual physical occurrence. This continued all day. At 6.00 pm local time my wife and I were subject to the burping / gas . diarrhea attack.

May 09 2025. Upon getting up at 6.00 am I perceived that my groin area was still vibrating. At 0900 I turned my computer on and immediately the subtle vibrations went to full on attack to my groin / shamanic rape. I got through most of the day by avoiding sitting down or lying down in bed. By evening the assault / attacks had escalated to the point where in the evening I had to walk around in my apartment without sitting down. After an hour of walking around in the apartment I realised that I was never going to get to bed so I gave in. I sat down and within 20 to 30 seconds I was physically raped which led immediately to an orgasm. I went to bed after that and was tormented for about half an hour before all the drugs I was using to send me to sleep kicked in.

May 10 2025. Attacked in the groin / prostate all day but low key compared to the past few days.

May 16 2025. A repeat of May 09 2025. 24/7 groin attack followed by another rape.

May 18 2025. A repeat of May 09 2025. 24/7 groin attack followed by another rape.

May 22 2025. Another groin / rape attack. The hissing suddenly got loud at 2.30 pm. It became obvious that it was heading towards rape within minutes. I walked around my apartment for two hours. If I stand still. Sit down or have a bath the rape starts immediately. After two hours I thought I would chance a salt bath. No go because as soon as I sit down or lay down in the bath I feel myself being penetrated. I got out of the bath and walked around some more. At about 6.00 pm I decided that I could not do this all night so sat down in my arm chair and was violently raped that led to an orgasm. The whole episode ,after sitting down, must have lasted about a minute. Violent but short lived. I was hoping that was it. But when I got into bed I was basically chased molested for two hours before my combination of sleeping pills, Valerian and Melatonin kicked in.

May 23 2025. At 1.30 pm today I thought I was getting a repeat of the previous days performance. I had to stand up and walk around the apartment which I did for a short while. Then I decided to go for a walk as it was a sunny day and I know that as long as I keep moving Patton West cannot focus on her intended target. After 10 minutes I decided that was not a good idea as I was feeling dizzy and weak either from another kind of attack or from the other aspects of her attack to my groin area. Weakness in the legs and dizziness. I got home and much to my surprise the attack to my groin seemed to reduce in intensity. That said I write this at 4.30 pm. Let me see how the night goes. The night was relatively quiet compared to the previous two nights.

May 24 2025. The attack to my groin started in the morning and went on all day it graduated to the rape attack but never quite got there (no forced orgasm).

May 25 2025. A repeat of yesterday in that the attack to my groin started in the morning and went on all day. I had a salt bath and I was penetrated several times while having a bath. As I approached bed time it seemed to ease off and although I had constant energy movement in my prostate / rectum area it never progressed to a quick and violent rape that led to an orgasm.

May 26 2025. Attacked all day, mainly my groin / prostate. The attack went on all day and as usual could not sit down, have a bath or lay down in bed without being attacked. I went to bed at 7.00pm but could not sleep. I think I got 2 or 3 hours sleep between 7.00 pm and 4.00 am when I got up. I was basically chased around the bed until I got exhausted and then just had to accept what was happening. Which was constant movement inside my rectum / prostate. As long as I keep moving it is OK but being exhausted I eventually had to give up. Very sore the next day.

May 27 2025. As stated I got up at 4.00 am. My groin / prostate was very sore. Took some pain killers and got on with another day of being targeted by the self-appointed 'Regent of the New Americas!'

May 28 2025 to June 04 2025. I see no point in repeating the same attacks day by day. In brief. The attacks to my groin continue daily for several hours. Though I have to admit the full on 'rape attacks' leading to a forced orgasm seem to have diminished somewhat. I have noticed that the attempts to wake me up at between 1.00 am and 2 am in the morning continue. Once awake I have to put on my ear buds and drown out the 'hammering' sound (a frequency designed to keep one awake) being projected into my head. In other words a frequency commensurate with being wide awake (as opposed to a frequency conducive to sleep) is being beamed into my head – to wake me up and disturb my sleep.

June 11 2025. Started off in the morning with the Burping / Gas / Diarrhea attack. Got two Gas Ex's in me and that seemed to stop the worst of it. A little saliva running in my mouth and two bout of diarrhea – no vomiting. The rest of the day followed by an attack to my groin. Started off as though it was going to be a rape attack (ending in orgasm) but petered out to just a non stop attack to my prostate with 'zuchinni' feeling inserted into my rectum.

Ditto June 12 & June 13 2025.

My wife and I have been taking a mixture of drugs (over the counter meds) to ensure we get some sleep. The over the counter sleeping pills are not supposed to be taken for long periods of time. My wife and I have been taking them for 15 years along with high dose melatonin and valerian. On the evening of the 13th June I decided to not take the two sleeping pills (a double dose) to see if I could get off them because I get leg cramps when I take them which keeps me awake for hours and kind of defeats the purpose of taking the sleeping pills.

Long story short having gone to bed at 7.00pm, we always go to bed early as we do not know how much sleep we will get, I was still awake at 3.00 am. Even after taking the melatonon and valerian. The reason why it is not possible to sleep is that my wife and I are being beamed with frequecies designed to keep us awake. Those frequencies are not subtle either. In the middle of the night I can clearly hear loud hissing in my left ear and a loud pounding in my right ear. When I say loud I mean it sounds like I am hearing, in my right ear, a distant diesel engine / generator. Then the last ingredient is being chased around the bed with my hand over my rectum trying to avoid the insertion into my rectum or the outright rape.

15 June 2025. We had a relatively uneventful morning. That is to say I had the 'zucchini' attack in my rectum all day on the 14th June but at a low level of intensity today. I guess the berder just wanted to make her presence felt! Of course the sleep deprivation, headaches and the feeling that spikes / needles were being inserted into my legs and arms every now and again is normal daily fare. However at 1.10 pm on 15 June the hissing suddenly git louder for both myself and my wife Lisa – both of us at exactly the same time at 1.10pm. Within two minutes my wufe rushed to the toilet and experienced four sudden bouts of diarrhea all within 15 minutes. The latter two bouts of diarrhea had blood in it. For my part I just had the usual rape attack, the zuchinni shoved up my rectum. This went on all day and into the evening. It never escalated up into a full on rape ending in a forced orgasm.

June 16, 17 & 18 2025. Each day a repeat of June 15 for me. As for my wife. The burping / gas / diarrhea attack is the most debilitating attack on the physical and mental body. For the 16, 17 & 18 of June each morning my wife had three or four bouts of diarrhea which included blood. Patton West is a cold blooded killer and as explained if the person she is targeting is strong she will go after the spouse or children. If I had lived in Arizona it would have been hard for me not to have taken direct action. Of course this is what Patton West wanted in 2007 when Reynolds announced my murder or jailing for reacting to what Patton West was going to do to my wife and children. It seems that law enforcement and the courts have been inept or powerless to deal with someone so incredibly evil. That said John of God got put away - now it is Patton West's turn.

Back to the attack on my wife. I would remind you that Lisa Swidler died suddenly and according to close friends she died of internal bleeding. And Joseph Costantino died of prostate cancer. Maybe he was being targeted relentlessly in that area?

June 19 2025. As usual for me. Internal rape like a zucchini deposited in my rectum. For my wife it was 24 hours of serious nerve pains. To make it clear my wife had all her nerves on fire and it was extruciatingly painful for her all day. So much so that she broke down and cried a couple of times.

June 20 2025. My wife had the regular attack on her nervous system. Extremely painful. I had the rape attack all day (the zuchinni up my rectum but no forced orgasm). Both I and my wife were subject to the 'burping attack' which resulted in copius amounts of saliva running into our mouths and for my wife four bouts or diarrhea with some bouts of blood. For myself I got the Gas-Ex pills into me guickly so I avoided the diarrhea.

June 21 2025. My wife's left eye swelled up very quickly this morning to the point it was totally blood shot. No reason why except the occult attacks from Patton West. For myself I was subject to the rape attack which I thought would lead to a forced orgasm but as I was standing up using my computer it never quite got there and as soon as I got off my computer the attack subsided. My wife and I went to bed at about 7.00 pm we never know how much sleep we are going to get. Tonight was a case in point. At 10.30 pm I awoke with the loud pounding in my ears. The frequency Pattin West uses to wake her targets out of sleep to wide awake in seconds. I got up and had a snack and almost exactly at 12.00 midnight I was the subject of the 'burping / gas / diarhea attack. I took two Gas-Ex tablets immediately and managed to avoid the diarrhea until morning when I had two short bouts of diarrhea.

June 22 2025. I was subject to a severe rape attack this morning. I had to stand up to use my computer but even then the pressure upwards on my rectum was at times overpowering. I was not lifted off my feet but it was very uncomfortable. In the mid afternoon at about 3.00 pm I took a bath and was molested while in the bath. Imagine Kendal Haywood being subject to this 24/7 for months in the run up to the child custody hearing at which she lost her infant daughter to Patton West's son because Patton West and her tame cult doctor Pat Cole MD made out Kendal was mentally ill. I had contact with Kendal and I am fairly sure she was driven close to being mad by the occult attacks sent by Patton West. The attacks, when added to cult member Dr. Pat Cole's testimony, sealed Kendal's fate. She lost her daughter to Patton West's porn loving, drug taking son with a criminal record for forgery, substance abuse and 'traffic' violations. Clearly this is a crime family...

June 23 to June 24 2025. Much of the same but not as severe as on June 22 2025.

June 25 2025. The berder must be getting desperate. This was one of the hardest days of the past 18 years of occult attacks. I got to my computer at about 9.0 am and within 30 seconds I was hit very hard in the rectum / groin. This immediately went to a full on rape while I was walking around thye apartment. I could not stop it and I had left getting the Rife frequencies too late. Long story short I just orgasmed within 20 minutes of the attack starting at about 9.00am. So violent was the 'conclusion' that I was left sore all day. Not only sore but the movement up and down inside my rectum / prostate continued all day and into the evening. My wife and I drugged ourselves up as usual and I probably got 3 or 4 hours sleep before being woken up hust before midnight. I probably drifted off once or twice but was basically chased ariound the bed all night until getting up at 5.10 am.

My wife was subject to a similar version of the attacks against me with the outcome that she developed cystitis over the past few days. This is very painful when she urinates and has meant she is drinking a lot of water and eating very little. Two reasons to go on a diet the burping / diarrhea attack and cystitis!


June 26 2025. Same as June 25 although this time I was prepared with pain killers and the appropriate Rife frequencies. The attacks against me started at 8.00 am and began to subside at around 3.00 pm. Though I guess the berder will ramp up the attacks near bed time. My wife dealing with her cystitis.

And sure enough the berder has decided to throw the kitchen sink at my wife. In addition to dealing with the cystitis she is now javing to deal with the gas attack / diarrhea / bloating / severe stomach attacks.

June 28 2025. My wife's induced cystitis was very painful. She took copius amounts of pills and drank a little brandy. I searched for a Rife frequency that I hoped would help and sure enough I found one. She put on head phones and after listening to this frequency for 5 minutes the pain started to subside and within 30 minutes the pain was completely gone. Proving this was not an organic condition. Not a virus of bacterial infection. As an organic, natural infection would not disappear in 30 minutes. Therefore it is obvious that Patton West was targeting my wife with a frequency that induced the cystitis condition with all the associated pain! Now think about a year of rape attacks against me.







Patton West has gotten away with 33 years years of doing this to countless other victims.

This amounts to literally thousands and thousands of acts of terrorism which should be met with the death penalty.

June 30 & July 01 2025. We have arrived a sort of 'balance.' The occult attacks continue full on. In my case it is the rape attacks and with my wife it is her cystitis or the burping / gas diarrhea attacks that results in diarrhea / burping or vomiting. We are both subject to these attacks at night while we are trying to get to sleep or while we are asleep. However we have found some frequencies that 'dilute' or weaken the effectiveness of Patton West's attacks. It works like this. During the day we both wear Bose headphones which play frequencies continually. Sometimes all day. They run on triple 'A' batteries so will run all day without issue. At night it is different. The Bose headphones 'cans' are large so while you can wear them in bed lying down flat you cannot lay on your side without taking them off. Both my wife and I have Apple Air Pods which are small and while not small enough to lay on one's side comfortable with a little preparation one can make a dip in the pillow and lay in one;s side and fall asleep.

The problem with this is that the rechargeable batteries in the Air Pods only last about 4 hours. Here is how I cope with the attacks overnight. Ditto my wife. I lay on my back with the Bose headphones until I get sleepy (about two hours). As I am near falling asleep I change the big Bose headphones for the Air Pods. I may fall asleep for 3 hours if

I am lucky. I wake up suddenly when the batteries run out of the Air Pods. When that happens I put the Bose headphones back on and lay there for an hour while the Air Pods recharge. After they have recharged I put the Air Pods back on and maybe get another 2 or 3 hours sleep and this is repeated until 4 to 5 am each morning. When the Air Pods run out I wake up more or less immediately as once the counter frequency being used by me ends there is nothing to stop Patton West's frequency attack from coming through. The main frequency used by her to keep me and her other victims awake sounds very much like a spin dryer on its last cycle or a distant diesel generator. It basically sounds like a rapid thump, thump.

The sleep deprivation frequency she uses may be mixed in with, in my case the rape attack frequency and in my wife's case the cystitis frequency. The CIA and other US government agencies have been using this for decades. Here is a link to a web page giving more information about this capability.

July 3 2025. The rape attack began at about 7.00 pm. After 15 minutes I could not sit down anymore as to remain seated would result in a rapid rape and orgasm. So I got up and started to walk around our apartment which I did for two hours. Eventually realizing I was not going to submit Patton West changed her focus to my head. I suddenly had a severe headache combined with nausea and a loud buzzing sound. Fortunately I had my Bose headphones on and was playing a frequency known to diminish occult attacks. Long story short Patton West's efforts eventually died off at around 11.00 pm. I eventually got to sleep.

July 4 2025. The rape attack started at 10.30 am. I guess Patton West was coming back to finish of what she could not do the previous night. The attack continued for several hours and eventually started to wane at about 3.00 pm.

July 5 2025. I got up at 5.00 am having woken up at around 3.00 am with the 'pounding' frequency in my ears which is designed to do just that. Designed to wake me up and keep me awake. I watched TV until about 6.30 am. However while sat in my lounge watching TV rape attack started again at around 5.30 am. Patton West uses this form of attack most because it demonstrates to her victims that she can reach them at any time. Also to the mind of a criminally insane psychopath like Patton West, humiliating her victims, by forcing them into having sex against their will is a real bonus!

The above is what the whistleblower has shared with us so far. Though we know he has recorded a full year of these attacks in his diary. Which will be shared with the judge and jury at Patton West's trial for attempted murder, thousands of acts of terrorism and three decades plus of racketeering in three western states.

In case the enormity of what has been happening for three decades has not yet hit home understand this..


