
failed, he waited three years to join Devra West in a conspiracy to bankrupt the whistleblower as part of a vendetta by West to avenge:-

## *Spiritual guru pleads guilty in assault*

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.

Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.

After entering her plea, Devra West was sentenced to

a six-month deferred jail term and fined \$500.

Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.

Justice of the Peace David Ortley issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.

West's trial was postponed

from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.

West's trial originally was scheduled for April 2007.

Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.



#### 4. 2008 Judgement awarded against Devra West for defrauding the whistleblower.

**ORDER**

IT IS THEREFORE ORDERED that Plaintiff John Watson's *Motion for Sanctions* is hereby **GRANTED** to the extent that West's answer is ordered stricken, and default judgment is entered in favor of Watson on his breach of contract and tort claims.

IT IS FURTHER ORDERED that a bench hearing on the amount of damages to which Watson is entitled is set for the 2<sup>nd</sup> day of October, 2008, at 9:00 o'clock a. m., as the first setting, for three (3) hours.

IT IS FURTHER ORDERED that Watson is entitled to his reasonable expenses including attorney fees incurred in bringing this motion and in preparing his proposed Pretrial Order. Counsel for Watson is directed to file an itemized statement of his fees within 20 days of the date of this order. A hearing on the reasonableness of the fees claimed will be held in conjunction with the bench trial on the date set forth above.

¶1 Pursuant to Section I, Paragraph 3(d)(v), Montana Supreme Court 1996 Internal Operating Rules, as amended in 2003, the following memorandum decision shall not be cited as precedent. It shall be filed as a public document with the Clerk of the Supreme Court and its case title, Supreme Court cause number and disposition shall be included in this Court's quarterly list of noncitable cases published in the Pacific Reporter and Montana Reports.

¶2 Chris Haywood (Haywood) appeals an order in the Eleventh Judicial District Court denying his motion to set aside a default judgment against him. We conclude the District Court did not err in denying Haywood's motion and affirm its decision.

¶3 Haywood and his mother Devra West (Devra) reside in Lakeside, Montana. Haywood states that he is the project manager for Sanctuary Environments, LLC (Sanctuary), a business which is involved in buying and remodeling homes and then selling them for a profit. In December 2006, Haywood contracted with plaintiff and appellee Matthew West (West), d/b/a Top to Bottom Construction, to have West build a concrete patio and deck at Devra's house which is located at 525 Political Hill in Lakeside.

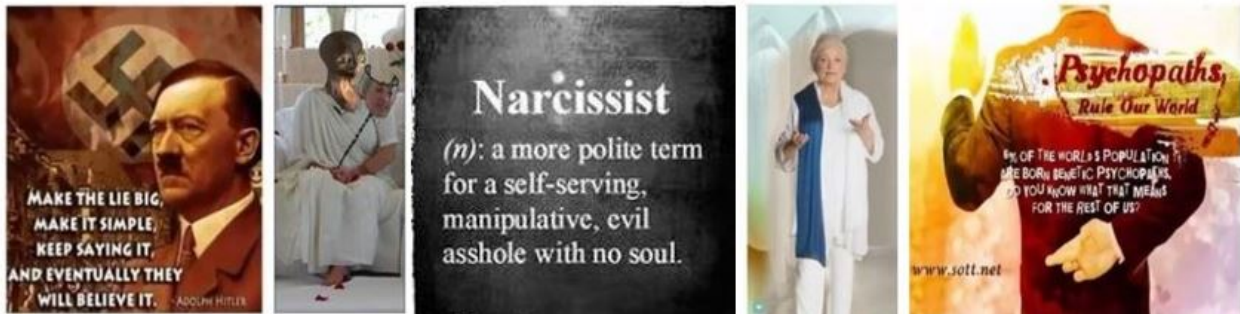


Of course Devra Patton West and her accomplices will vehemently deny that any of the above, well documented events, ever took place – you will find no mention of these items on her website in the pages dedicated to her totally fake [life story](#). In fact, during a meeting between Devra West and the whistleblower in March of 2003, wherein the whistleblower announced he was going to sue Devra West for fraud our wanna be Planetary Regent, unaware the conversation was being recorded, made the following statements:-

Note statement (4) above where Devra West, showing her true nature, states that the truth does not actually matter – if she can convince the public that her lies are their truth. So in this way, Devra West's expensive website and its contents (all lies, propaganda) are offered up as truth with her long list of violence towards women, two arrest warrants and a conviction for assault denied as 'religious persecution!'



Below is further proof of West's narcissistic behavior. The following is a statement she posted on her website in 2007 wherein she asserts that she is, and I quote, **“Holding open the gates of Universal Time.”**



Learn the principles and guidelines that will empower you to achieve your personal "tipping point in light", as major devastation inspires the collective heart of humanity to make the Great Decision for the Will to Good and unleashes the human spirit to reach for its full divine potential. Receive the steady influx of divine light as the Master Teacher Surya Ma holds open the Gateways of Universal Time at all new levels of potency for an ongoing increase of spiritual attunement, personal clarity and higher guidance, as new light is shed on specific world events and the spiritual attunements that will anchor your higher life purpose in the greatest degree of empowerment.

*Remember, the truth does not actually matter (if she can convince the public that her lies are truth!).*

Another assertion by the **'Regent of the Spiritual Hierarchy for the Western Hemisphere'** is that her two fake doctorates were awarded to her by the Christ in person! **The making of a Planetary Regent.** In 1995, Devra Patton West was chased out of New Mexico by a gun wielding victim – one of many victims of theft, fraud and extortion in that state. In 2010, and after several Montana newspaper articles had revealed her 'world service' efforts to be nothing more than a front for a criminal / racketeering business model, Devra Patton West and her gang were forced to leave that state! In 2011, she reincarnated herself in Carefree Arizona with yet another new identity, yet another fake **'life story'** and a new raft of titles and accolades that she awarded herself.

Devra West's power comes from the fact that:-

1. Under religious freedom laws she can tell as many lies as she wishes knowing that the likelihood of her being prosecuted for fraud is remote.

2. The occult weapon she uses to commit crimes and to intimidate victims and witnesses into silence is not regarded as a 'weapon' under legal statute. Put simply, Devra West, by the authority's inaction, has been given a license to commit theft, fraud, extortion, violent assault and even murder without fear of being called to account. In short, she has a license to kill which she is not afraid to use.

In Montana (and New Mexico before that) Devra West was being marketed by Williams, Reynolds and others as the Ascended Master Surya Ma, with members of her cult being forced to 'fund raise' for her good causes. Wealthy cult members were also targeted by West to give up their wealth - as is made clear in the excerpt below of an internal email sent to all cult members in 2005, **demanding that they give up 66% of their wealth.**

Presently, the balance of truth between myself as Master Teacher and the group has yet to be fulfilled, demonstrated and anchored. No less that 66% fulfillment of Truth in Balance between disciple and Master Teacher on the part of no less than twelve persons can serve as my container. There is no preconceived idea as to who these twelve persons will be. Purity of heart, mind and purpose in service to the Master Teacher's work and thus the work of the Ashram as assigned by Brotherhood of Light will be the determining factor.

Another excerpt also informs the members trapped in her cult that it will be **their privilege to 'seed her financial transition.'**

The problem of financial withhold and the mistrust of my ability to properly assign the direction of finances is not a suitable environment for me to unfold this work. It is toxic and limiting. I continue to hope that you will see the light and break free. **It will be your privilege to financially seed my transition.** It is not my need, but rather it is your need. My due is Truth of Balance with each of you. This is the criteria for standing as my circle of light. My needs will be met in any case. This is your window of opportunity to come clean, ~~xxxxxx~~ and innocent of the Dweller. As you do your mind will become clean and in White Light receptivity for the Lord's Holy Plan on Earth.

In 2007, after the whistleblower caused two newspaper articles to be published in the Whitefish Pilot and Bigfork Eagle newspapers, senior cult member Geoffrey Reynolds CPA, while being interviewed by the newspaper, forecast the imminent murder of the whistleblower, which had it succeeded would also have been ruled a 'death by natural causes.'

Clearly, murder is a tool West uses to silence her critics. And clearly, Geoffrey Reynolds was happy to be complicit in the murder of a total stranger, just to please the leader of his cult criminal gang! When the murder plot failed, Reynolds got to prove his loyalty again by fronting a criminal conspiracy to bankrupt the whistleblower by going in front of a Montana court and presenting a set of lies to that court that had been prepared for him by Devra West. Since 2014, Rat Reynolds has been working for [McSwain & Co.](#) a firm of accountants based in Olympia Washington – I am sure his criminal / racketeering skills were not declared to his new employer before he was hired!



The senior members of the cult are used to deny the truth should news of Devra West's criminality leak outside the cult into the public domain. This happened in July 2007, when news of Devra West's vicious assault on Dr. Cole MD became the subject of two newspaper articles. In brief, Devra West assaulted Dr. Cole as part of a campaign of violence designed to extort \$1.3 million from her. West admitted the assault in a letter she wrote entitled '[The Law of Severity on the Path to Purification.](#)' to her cult on April 17 2006; another witness to the crime, [Carlida Finch](#), overheard Devra West talking about

murdering Dr. Cole MD and made a statement to the authorities. West was eventually [convicted of that assault](#) in April 2008.

However, when the first of two newspaper articles focusing on the assault were published in July of 2007, senior cult members [Geoffrey Reynolds](#), [Julio Williams](#) and ex-husband [Jack West](#) all published statements of denial on West's website. In Reynolds case, he posted four statements of denial; even though at the time, he was desperately trying to force a copy of West's written admission of guilt (that she had assaulted Dr. Cole MD) from the whistleblower's website! Williams has a long history of collusion with Devra West in her criminal / racketeering business model, being wheeled out to defame and intimidate those victims of crime, like the whistleblower, who go to the police or law courts for justice. The above email from senior cult member, Julio Williams, was designed to intimidate the whistleblower into withdrawing his fraud lawsuit against cult leader Devra Patton West which he won in 2008. Not only was Williams promising to fund West's legal fees to the tune of \$2,000,000 but he also made a

donation of \$100,000 to her criminal / racketeering business model in that year; as ex-employee Rebecca West makes clear in her [harrowing email to the whistleblower entitled 'Help Me.'](#) Rebecca's email shows clearly and beyond any doubt that Devra Patton West was running a cult and that crime was being committed on a grand scale with the biggest victim at the time being fellow physician Dr. Pat Cole MD. 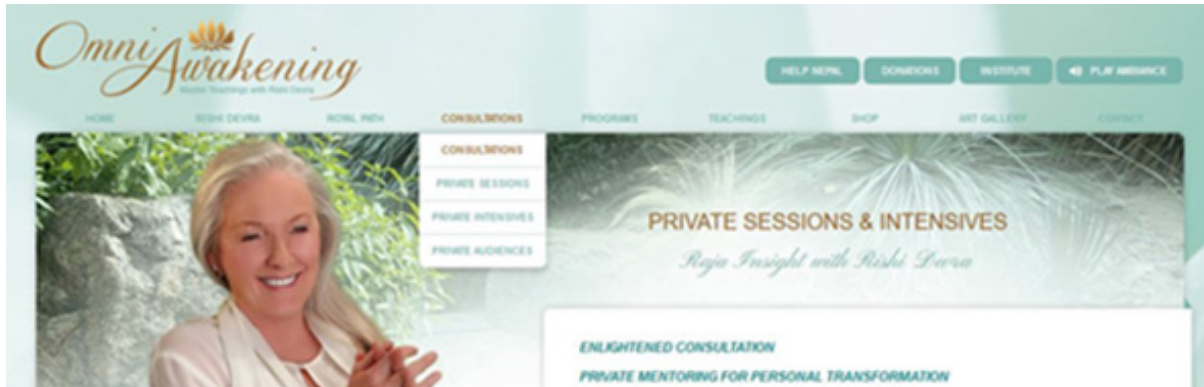

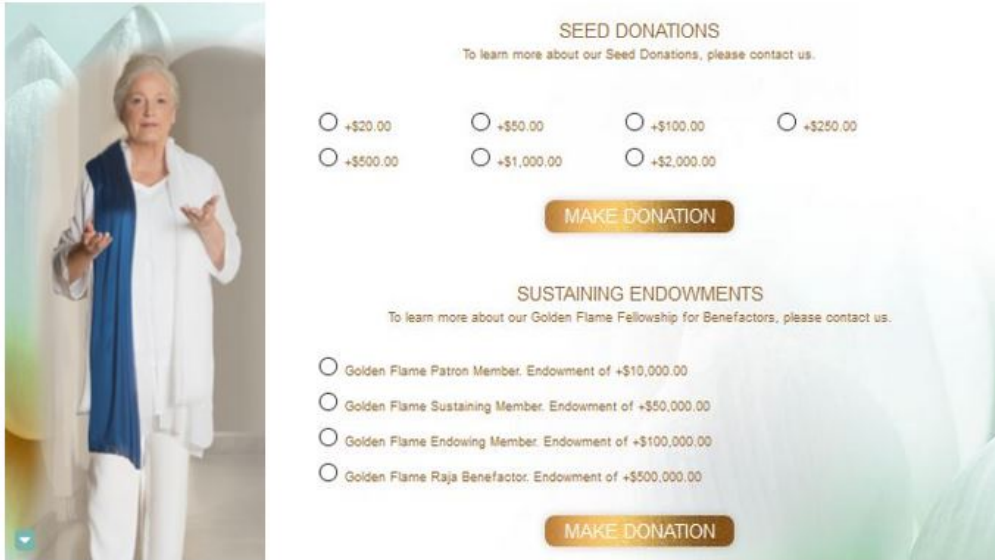
**Step 2.** You will be targeted and duped / manipulated / pressured into believing one of the following two scenarios.

1. That they are suffering from a totally non-existent brain tumor or a cancer which Devra West guarantees she can cure for a large fee.
2. That Devra West and the targeted individual were sisters in a former lifetime during which the target is persuaded that she betrayed Devra West in that lifetime and must now, in this lifetime, make financial reparations (for those nonexistent wrongs).
