Devra Patton West is a violent convicted criminal and quite possibly, a serial killer too. Her claim to be the Regent of the Spiritual Hierarchy of the Western Hemisphere is not based on anything other than her belief that she can say or do whatever she wishes, in the belief that her occult knowledge will be able to silence any who seek to contradict her psychosis / belief that she is a minor deity. This applies to victims, witnesses, police and even members of the judiciary who she is able to manipulate into getting the result she wants — in spite of the evidence against her. Her occult (hidden knowledge) is leveraged by the senior members of her gang / cult who are well aware that she uses murder as a tool against those who would seek to go public.

Let me give you two examples:-

1. In 2002, the whistleblower was defrauded out of salary and shares. He took Devra West to law and successfully sued her for fraud, getting judgement in 2008 in the amount of \$760,000. Devra West plotted to murder the whistleblower in August 2007, a fact that we know to be true because senior cult member, Geoffrey Reynolds CPA, announced the whistleblower's impending death to the Bigfork Eagle news reporter in what he thought was an 'off the record' conversation. When the whistleblower gave his research to a local newspaper and they went public with a story in the Whitefish Pilot on July 12 2007, Devra West immediately posted a statement of denial on her website accusing the whistleblower of trying to defraud her.

A classic move of psychopaths is to blame the victim for the sins they have themselves perpetrated on their victims! Here is a link to the <u>judgment and the award</u> handed down by the Montana court.

Millennia Mind Dispute with John Watson:

Devra Surya Ma's legal team has filed for an appeal for the sanction ruling stemming from a technical error and timing matter. Additionally, contrary to Watson's claims of a "Big Win", lawsuits have been filed against John Watson for his many threats and criminal acts against Dr. West and her family members and will be diligently pursued by Dr. West's legal team.

TRUTH: No business contract between Dr. West and John Watson has ever existed. **The legal dispute was fabricated by Watson to leverage an extortion scam**. Any and all business proposals made by Watson were declined. Dr. West has no intentions of enabling an extortion scam, therefore no settlement of any kind will be entertained.

When the murder plot failed, and when the whistleblower turned up to court to hear what he had been awarded, he was served for defamation for telling the truth about Devra West. Because he was unable to afford to travel to the US to defend the case Devra West and senior cult / gang member Geoffrey

Reynolds (who lied to the court making totally <u>false statements</u>) were awarded \$5,000,000 each in a default undefended judgement.

So, using the unlimited resources of decades of criminal activity, Devra West was able to neutralize the whistleblower's win in court against her by using her 'liar for hire' Geoffrey Reynolds CPA, to make <u>false</u> <u>pleadings</u> to the court on her behalf – this is a criminal conspiracy. For his part in the murder plot and conspiracy against a total stranger he had never met, Geoffrey Reynolds CPA has earned the accolade of 'scum.'

<u>Scum</u> (adj.) possibly the worst word you can have your name associated with. It is <u>hard</u> to define the word, but it is basically used to describe someone so disgraceful that they are seen as the lowest form of life.

Geoffiey Reynolds CPA

Reynolds is now working for McSwain & Co. a firm of accountants based in Olympia Washington – I am sure his criminal / racketeering skills were not declared to his new employer when he was hired!


The good thing about knowing where Geoffrey Reynolds works is that at any time he can be served for his lies and his part in the criminal conspiracy against the whistleblower.

After all, Geoffrey Reynolds CPA's (not the brightest bulb on the Christmas tree,) own website, clearly indicated that he could not have been defamed by the whistleblower between 2002 and 2006; as he did not travel from Cave Creek Arizona to Lakeside MT to take up 'employment' with Devra West and her cult until September 2006. So Geoffrey Reynolds did not know that the whistleblower existed until he was briefed by Devra West post-September 2006. Clearly, he lied to the Montana court because he was told to do so by cult / gang leader Devra Patton West. 2. In April 2006, Devra West viciously assaulted student and business partner, Dr. Pat Cole MD, while in the process of extorting \$1.3 million from her - which West succeeded in doing at little cost to herself. During these crimes, she was overheard by another employee, Carlida Finch, talking about murdering Dr. Cole MD. After the assault, and in an attempt to justify it, she immediately wrote to her mailing list and stated that the victim was a Nazi in the WWII death camps in another lifetime therefore the beating was justified and long overdue!

The police were called, West was charged with assault and convicted of assault in April 2008. In July 2007, when news of the assault and West's criminality went public, Devra West, then masquerading as the Ascended Master Surya Ma, denied the assault and accused the victim of being part of a fraud conspiracy against her!

Court Rules to Dismiss Bogus Assault Case:



when the <u>Whitefish Pilot</u> newspaper article was published on July 12 2007, both West and the senior members of her cult posted several statements of denial on West's website.





Do you think that Devra West and her criminal gang are focused on 'world service?' Or like me and countless others do you believe that these individuals are all acting together in unison in a criminal / racketeering business model predicated by West's knowledge of the occult which allows her to prey on wealthy spiritual seekers with impunity.

Why impunity? Because over and over again victims go to the police only to be told that the 'weapon' Devra West is using to commit these crimes (and intimidate victims and witnesses into not going to the police) is not regarded as a weapon by legal statute! Knowing this, the senior members of her cult, Reynolds, Williams and Jack West believe Devra West to be immune from prosecution. Reynolds felt so confident that he shared the murder plot in what he thought was an 'off the record' conversation with the press reporter working for the Whitefish Pilot and Bigfork Eagle newspapers. Which is why, even though Reynolds, Williams and Jack West are well aware of her criminality they still sell / market Devra West to the public as the 'second coming.'

THIS IS HOW ORGANIZED CRIME WORKS. THIS IS WHAT CRIMINALS DO WHEN THEY ARE CHALLENGED OR 'OUTED' PUBLICLY!

Devra West's knowledge of the occult has in effect, given her a license to kill and rendered the authorities impotent to stop her using it as victims appear to have died from natural causes and witnesses are too frightened to come forward. In 2005, shortly after her charity was struck off for fraud by the Secretary of State for Montana, Devra West decided to convert a couple of the livestock corralled in her cult into cash.



In quick succession, Devra West defrauded one student, <u>Dave Kushner</u>, out of \$30,000 and kidnapped, beat, and falsely imprisoned another, <u>Marion Cantwell</u>, until she coughed up tens of thousands of dollars for Devra West's expensive lifestyle costs. Marion was threatened that if she went to the police she would be murdered, and why not? When you are a God, who is to stop you getting away with murder? Ex-student Lisa Swidler, a witness to both crimes, tried to leave the cult and was allegedly murdered shortly afterwards.







Murder was likely used to silence Lisa Swidler and was intended to silence the whistleblower. According to Carlida Finch, Devra West was planning to murder Dr. Cole too but she received a reprieve after paying \$1.3 million to stay alive.

What are Devra West's motive for committing multiple murders (not that a deeply disturbed psychopath who believes herself to be God needs a motive)?

1. Undermining the Propaganda. Anyone telling the truth about Devra West or undermining the narrative that she is a 'divine being' must be silenced and in certain cases like the whistleblower, who

took her to court and 'proved' her to be a liar, murdered by her. Lisa Swidler, a close confident, knew where all the skeletons were hidden.



Then you add Devra West's own comments recorded by the whistleblower at a meeting in March 2003:-




- 1. That they are suffering from a totally non-existent brain tumor or a cancer which Devra West guarantees she can cure for a large fee.



- 7. Vicious Assaults on female members of her cult i.e. Susannah <u>Felder & Beatrice McGuire</u>, <u>Jamie</u> Haywood and Dr. Pat Cole MD.
- 8. The Students who took out loans for Devra West after being told, "They would be closer to God."
- West's son's criminal record. Like mother like son?
- 10. Arrest Warrant for felony theft.
