A self-styled clairvoyant and spiritual healer from Lakeside who claims the Osprey House on Angel Point as a future VIP spa faces criminal charges stemming from an alleged assault on a Whitefish doctor.

A temporary restraining order against West, who calls herself Surya Ma, was issued by Judge David Ortley last October after Dr. Patricia Cole, of Whitefish, requested protection. Cole was the director for one of West's ventures, The Sacred Archives Institute. They worked together for several years. In her statement to the county sheriff's office, Cole claims West abused her verbally and physically.

"She has told me that she has the 'spiritual' power and authority to 'take me out,' to be composted," Cole wrote in the temporary restraining order statement.

Cole claims West threw a lamp at her and hit her with a briefcase, cell phone and her hand. <u>"She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself."</u>

Photos taken after the alleged beating were submitted to the sheriff's office.

Trial scheduled in Lakeside assault case Posted: Thursday, Aug 09, 2007 - 07:32:24 am PDT

A Lakeside woman who claims to communicate with long-dead religious masters will face a jury trial Sept. 18 in Flathead County Justice Court on misdemeanor charges she assaulted a Whitefish doctor. A temporary restraining order against Devra Patton West, a self-styled guru who calls herself Surya Ma, was issued by Judge David Ortley last October after Dr. Patricia Cole, of Whitefish, requested protection. Cole claims West assaulted her in April 2006 and again in October 2006.

Cole said she first came to Montana from Minnesota to attend spiritual sessions at Naka Shela, West's facility in Victor, from 2002 through 2004. She moved to Montana to live in 2005 with the idea of combining West's spiritual teachings with medical knowledge. Cole eventually assumed management positions with several of West's for-profit and not-for-profit operations. As business fell in Victor and the Naka Shela property was foreclosed, West moved her business north to Lakeside.

Reynolds claims Cole owes West \$753,484 and that colors Cole's allegations. Cole's bills for 2004-2006 totaled \$1.3 million, including \$250,000 for an "internship" under West and \$213,750 in "therapy fees" for eleven months last year. Cole managed to pay West \$621,484, but it didn't come easy. At one point, Cole cashed out her IRA and paid West \$293,843.

Out of six businesses mentioned in West's literature, only one remains active and in good standing with the Montana Secretary of State office -- Sacred Environments LLC. Two were never registered -- Divine Unity Foundation and Millennium Mind Institution; two were involuntarily dissolved -- Surya Enterprises


Unlimited and Global Guardianship Initiative; and one was involuntarily revoked -- Sacred Archive Institute.

Besides being evicted from her Bayside home in Lakeside and bouncing a check for the purchase of the well-known Osprey House on Angel Point, West has a \$2,287 lien against her for failing to pay unemployment taxes for her Montana employees.

Devra Patton West, (whose arrest warrant photo can be seen above) was then posing as the Ascended Master 'Surya Ma.' West successfully extorted \$1.3 million from Dr. Pat Cole MD. Like many before and since, Dr. Cole MD was recruited into the cult after agreeing to take up the "**opportunity for private mentoring for initiates, world servers and spiritual protégées**" This is the same well-oiled fraud scam that con artists and violent convicted criminal, Devra Patton West is now operating now in Arizona - targeting wealthy spiritual seekers in Sedona & Scottsdale.

THE SATANIST 'CODE.' This is holy sacred knowledge! <u>Violent assaults on female members of her cult</u>. Susannah Felder, Beatrice McGuire and Dr. Cole MD (all employees and students). <u>Susannah partially scalped</u> after challenging Devra West after she caught her stealing \$80,000 from the charity. <u>Beatrice had part of her ear ripped off</u> in front of a crowd at a seminar after challenging West's lies. <u>Pat Cole was repeatedly hit over the head</u> with the heel of West's shoe until blood ran down the victim's blouse.

Now let us review one murder and one attempted murder by Devra West (both 'divine grace healings' to a Satanist) neither of which she was prosecuted for because the weapon she used to commit these crimes is not regarded as a weapon under legal statute. After witnessing these two crimes, Lisa Swidler decided to leave Devra West's cult, only to die suddenly and mysteriously of internal bleeding shortly after escaping. Many in the cult realized that she had been murdered by Devra West to keep her quiet. This played heavily on the minds of other victims in the cult, like Mike Hendrickson, who was defrauded out of \$200,000; rather than face death at the hands of Devra West, he too, decided to cut his losses and walk away empty handed.

The coroner ruled the death of this young mother of two children under age ten was of 'natural causes.' Along the way, he became the subject of threats, false witnesses, a campaign of occult attacks and a plot to murder him. As explained, Devra West has been thieving, defrauding, extorting and murdering people and getting away with it for some 27 years. It therefore came as no surprise that, while being interviewed by the <u>Bigfork Eagle</u> newspaper, and speaking on behalf of his 'employer' Devra West senior cult member, <u>Geoffrey Reynolds CPA</u> announced, in what he thought was an off the record conversation, that the whistleblower would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family.

The reporter, Constance See, took the threat seriously enough to report it to an IRS criminal investigations agent, John Neilson, who was at the time investigating Devra West's finances. Devra West's well-oiled criminal racketeering business model could not function without the help of accomplices 'liars for hire' like gang members <u>Geoffrey Reynolds, Julio Williams</u> and ex-husband <u>Jack</u> <u>West</u> whose role it is to lie to the public and to other members of the cult about West's crimes. Additionally, these three individuals also provide an endless source of propaganda, false testimonials and when required false witness statements designed to make it impossible for victims to get justice.

The three senior cult members are all willing accomplices and all aware that Devra West is running a criminal / racketeering business, and that her claims to 'divinity' are false and entirely predicated on her ability to 'take out' anyone who challenges her delusions of grandeur i.e. the 'divine being' narrative. Similarly, occult knowledge is used to commit serious financial crimes, like fraud and extortion and use that same knowledge used to intimidate and silence victims and witnesses who might go to the police. Geoffrey Reynolds CPA is the only member of the cult to actually share this fact with the media.

Let me share each member's role within the cult / criminal gang in brief.

<u>More holy sacred knowledge</u>! Senior Cult Member Geoffrey Reynolds CPA. Reynolds was coopted into the cult like many 'professionals' before him, the whistleblower included; believing that he was applying for a post at a normal corporation, Reynolds traveled from his former employment in Cave Creek AZ to join West's employ in Lakeside MT. Shortly after arriving, he was duped into loaning his life savings, amounting to \$300,000, to Devra West, after which he either became a willing accomplice in her criminal / racketeering business model or was blackmailed into joining her murderous crime spree. What follows are some of the crimes he participated in – these are the ones that we know about.

1. Fraudulently applied (with Devra West) for \$30,000,000 in CPEA grant money to build a Spa complex though correspondence from employee <u>Rebecca West</u> (no relation to Devra West) and West's own stepmother <u>Carol Patton</u> makes it clear West intended to use at least \$2,000,000 to pay off her debts.

2. Money laundered the proceeds of crime through Devra West's business as normal receipts; this after his predecessor resigned rather than be forced to 'manufacture' false invoices to make it look like approximately \$470,000 extorted from Dr. Cole to pay for an 'internship' and for 'therapy' was received as a result of 'normal' business activity. Admits as much in the <u>Bigfork Eagle</u> newspaper article where he was speaking 'on behalf of his employer.'

3. Posted four statements on West's website immediately following the publication of the Whitefish Pilot newspaper article on July 12 2007, wherein he asserted that Devra West had not assaulted Dr. Cole MD even though at the time, he was desperately trying to force the removal of copy of Devra West's written admission that she had assaulted Dr. Cole MD from the whistleblower's website.

You can review a copy of Devra West's missive to her cult mailing list entitled <u>'The Law of Severity on</u> <u>the Path to Purification'</u> wherein she admits assaulting Dr. Cole, admits that the assault was severe but administered by her with grace?? West also seeks to justify the assault by asserting that the victim was a Nazi in the WWII death camps in another lifetime.

You can review a copy of the <u>email Reynolds sent</u> to the whistleblower's web hosting service wherein Devra West claims copyright of her written admission that she had assaulted Dr. Cole while she, Reynolds and the rest of the cult were vehemently denying it and rubbishing the media for 'religious persecution.'

4. Reynolds was complicit in the plot to murder the whistleblower, announcing the plot to the press on August 9 2007, while being interviewed by the <u>Bigfork Eagle</u> newspaper reporter.



Devra West's criminal / racketeering business model is entirely based on her ability to commit murder multiple times and not be called to account. Clearly Reynolds was briefed about the murder of Lisa Swidler and thought that the murder of the whistleblower would also be a 'slam dunk' with no consequences for Devra West or himself. Why else would this scum bag announce the whistleblower's impending murder to a newspaper reporter two weeks before Devra West made her attempt.

5. In October 2009, Devra West was deposed by the whistleblower's lawyer, in an attempt to find out where she had hidden the millions of dollars she had acquired as a result of her criminal activities. During <u>her statement</u>, West repeatedly referred to Geoffrey Reynolds as the 'brains' behind the money, asserting that she was \$2,000,000 in debt and living in an RV in the back of Reynolds's property in Lakeside MT. West also said that Reynolds and his wife, Leslie, were funding her lifestyle, making them both complicit in Devra West's organized crime / racketeering criminal business model.



Shortly after giving her statement and pleading poverty, Devra West's fortunes changed suddenly for the better, in that she moved into a \$7,000 a month mansion inside a gated community in Cave Creek AZ where she now operates her criminal racketeering business model.

6. In 2010, while attending court to see how much he was to be awarded for <u>winning his fraud lawsuit</u> against Devra West in 2008, the whistleblower was served for defamation by West & Reynolds - for <u>telling the truth</u>. It shows how committed to West's criminality <u>Geoffrey Reynolds</u> was, that he was prepared not only to go before a Montana judge and make totally false statements about himself and his relationship to the whistleblower, but that having done that, he was then perfectly willing to 'front' the pair of frivolous lawsuits so that Devra West could remain in the shadows.

Remember, Geoffrey Reynolds traveled from Cave Creek AZ to join West's employ in Lakeside MT in September 2006, and yet in Reynolds' pleadings to the Montana court below, he states clearly that he was defamed by the whistleblower between 2002 and 2006??



As one can see from an excerpt of Reynolds' resume taken from his own website (full copy available <u>here</u>), at the time he made these false claims to the Montana court in 2010, Reynolds did not join Devra West's employ until September 2006, and so did not know that the whistleblower existed until he was briefed about West's vendetta against the whistleblower after September 2016.

In Devra West's case, she made it perfectly clear to the whistleblower in March of 2003, that if he took her to court and sued her for fraud, that she would use every dirty trick in the book and that the cost of fighting the lawsuit would come out of his pocket, not hers, because other members of the cult, like Julio Williams who had pledged \$2,000,000 to her legal fees, would pay her costs. 7. Like Devra West, or because of Devra West, Reynolds is a compulsive liar. In addition to not knowing that the whistleblower existed, pre September 2006, but still joining with Devra West in a criminal conspiracy to bankrupt him after their murder plot failed, Reynolds statements about his duties and achievements while working with Devra West are totally false. Below is a further excerpt from the resume posted on Reynolds' website.

Selected Accomplishments

Secured funding for company start up. Newly-formed Surya Enterprises needed funding. Prepared financial projections and developed strategy for five, ten, fifteen and twenty years of operation, and crafted business plan. Working in secondary financial markets, secured \$30M in wrap loans with no expenditure of company equity.

Reynolds states in the 'Selected Accomplishments' section at the top of his website that he, and I quote, "Prepared financial projections and developed a strategy for five, ten, fifteen and twenty years of operation, and crafted [a] business plan. Working in secondary financial markets, secured \$30M in wrap loans with no expenditure of company equity." End quote.

The above is a total pack of lies, as anyone can see from the following documents that were in the public domain as early as 2007.

A. The following is an excerpt from a news article published by the **<u>Bigfork Eagle</u>** on August 9 2007 – the same newspaper that Reynolds confided in that the whistleblower was about to be murdered for going public about West's criminal / racketeering business model.

Out of six businesses mentioned in West's literature, only one remains active and in good standing with the Montana Secretary of State office -- Sacred Environments LLC. Two were never registered -- Divine Unity Foundation and Millenium Mind Institution; two were involuntarily dissolved -- Surya Enterprises Unlimited and Global Guardianship Initiative; and one was involuntarily revoked -- Sacred Archive Institute.

Besides being evicted from her Bayside home in Lakeside and bouncing a check for the purchase of the wellknown Osprey House on Angel Point, West has a \$2,287 lien against her for failing to pay unemployment taxes for her Montana employees.

As for the '\$30M in wrap around loans' that Reynolds refers to, these loans were never granted because it seems that the con artist Devra West was herself conned out of a \$650,000 deposit that she paid to another pair of con artists, Wilson & Ross, who were going to provide these loans. Below are two short excerpts to the court documents, in respect of a case brought by the 'Securities Commission' against Edmund Wilson and Walter Ross.

20. The first sale of securities by Fountain Group occurred in September 2005. In the spring of 2005, Devra Patton-West ("West"), who had been looking for funding to build a medical spa as a high end resort, was referred to Wilson by Brennan.

So where are the \$30M in 'wrap loans mentioned by Reynolds in his resume?' The only other possibility was the fraudulent application of \$30M in CPEA grant money, but that too never materialized. Fraudulent, because Reynolds would not have declared in the application for the grants that the corporations were a sham, that if there were any other directors / shareholders apart from Devra West, they were impotent because the corporation was a front for a cult / criminal / racketeering business model.

Long story short, Reynolds' resume is a fiction, just like West's <u>life journey / history</u> as quoted on her current website.

8. In 2014, Reynolds oversaw the fencing of several million dollars of artwork and valuables that Devra Patton West had stolen from a Montana charity in 2004. The items, valued at \$4,000,000 in 2002, went missing after her charity was <u>struck off</u> for fraud but turned up ten years later in Arizona after the statute of limitations on theft had expired. In 2009, while being deposed by the whistleblower's lawyer, amongst other reasons to find out where these items had gone, West denied they existed and suggested that they had been "carried off."



Above left; millions of dollars of artwork and valuables closely matching the identity of those stolen from the charity turn up at auction and as for sale from West's website in 2014. Currently, these items are featured on West's website under the <u>'art gallery'</u> tab. Center; Reynolds overseeing the auction of stolen property in 2014. Far right; page 61 of the statement Devra West gave under oath in October 2009 wherein she states that the items were "carried away."

For his part in Devra West's criminal / racketeering business model, and in particular, the murder plot and conspiracy to bankrupt a total stranger to please Devra West, Geoffrey Reynolds CPA has earned the accolade of 'scum.'

<u>Scum</u> (adj.) possibly the worst word you can have your name associated with. It is <u>hard</u> to define the word, but it is basically used to describe someone so disgraceful that they are seen as the lowest form of life. "Worthlessness", "waste of skin", "dirt". "Nothing". Far worse than most other insults, where the victim is often <u>just</u> referred to as genitalia. Reynolds is now working for McSwain & Co. a respectable firm of accountants based in Olympia Washington. Here are a few of Julio Williams' outstanding contributions to his occult master's criminal / racketeering business model.

1. In 2005, Williams, along with two other cult members, were co-opted into <u>publishing a statement</u> on West's website designed both defame and to vilify the whistleblower because he had decided to sue Devra West for fraud.

Mr Watson, You will have your date in court. You fuck with me and you will meet your match.



3. When the Whitefish Pilot newspaper article appeared in July of 2007, Julio Williams, like Geoffrey Reynolds and Jack West, all senior members of West's cult, also published two statements of denial on Devra West's website, even though he knew full well she was guilty and had received her written admission of guilt over a year earlier.

4. Julio Williams is well aware that Devra West is a Satanist and an Occult Master, who uses her knowledge of the occult to prey on others. However, Williams grew up in the Dominican Republic where voodoo was one of the religions, so using black magic against others will seem quite normal to someone like Julio Williams. He is aware of Devra West's two arrest warrants, one in 2008 for criminal check fraud and one in 2009 for felony theft. 6. Below is a posting in 2017, showing that Williams actually rented a property close to Devra West's bullshit 'Abode of the Master's' in order to host a venue for new potential victims of Devra West's latest fraud scam i.e. 'Divine Grace Healings' selling at \$500,000 a go!

Finally, Devra West puts Dr. Julio Williams out front to recruit new 'blood' / victims for her cult because she believes that his perceived respectability as a heart surgeon will attract the 'sheeple.' Unfortunately for Dr. Williams, some of his patients do not rate him as a good doctor with one saying if you see him, "run the other way."

Currently, Williams is the contact point for West's latest recruitment drive to attract individuals into taking up employment positions for non-existent jobs. Over the past two decades, Devra West has deceived countless professionals / senior employees into taking up what are billed as 'great career opportunities' only to find out after commencing their employment that they have joined a cult and that they are expected to 'surrender' to the will of the Master Abuser and finance her non-existent good causes. Williams is a willing accomplice in this deceit but still agrees to work in concert with his cult leader to defraud and extort money from new recruits.

Past victims of 'special word of mouth job opportunities include the whistleblower - defrauded out of \$765,000, Mike Hendrickson - defrauded out of \$200,000, Dr. Pat Cole MD - defrauded out of \$1.3 million, with the vast majority of lower level employees defrauded out of smaller amounts (details elsewhere in the is email). <u>More holy sacred knowledge</u>! Senior Cult Member Jack West (ex-husband of Devra West). Jack West for the most part, plays a low profile role in Devra West's guru / cult / extortion business,

being used to recruit cult members from 'meditation' groups, social media and 'meet up' groups; although I noticed Devra West has been banned from Cave Creek's 'meet up' groups. Here are some examples of his activities within the cult. **1.** Victim of fraud, <u>Jeremy Samuelson</u>, describes how ex-friend Jack West, with little experience of women and being totally 'run' by Devra West, loaned them \$10,000 and never got repaid.

2. Another example of what Jack West does in the cult can be ascertained by reading <u>this statement</u> from AJ White, an ex-board member of West's so called charity, which was <u>struck off for fraud</u> in November 2003. 3. After the <u>Whitefish Pilot</u> published its story about Devra West's criminality and the assault on Dr. Cole MD on July 12 2007, Jack West reprised his role as 'liar for hire' by publishing a lengthy statement on his ex-wife's website. The statement asserted that the assault never took place and that the victim Dr. Cole, who been defrauded out of \$1.3 million by Devra West, was in fact part of an extortion scam (with the whistleblower) to ruin Devra West. Below is the statement of denial from Jack West posted on Devra West's website on exactly the same day as the other statements of denial posted by Geoffrey Reynolds CPA and Julio Williams MD.

Statement 1.

Clearly, Devra Patton West and her accomplices should be prosecuted under the 'Racketeer Influenced and Corrupt Organizations Act' (RICO).

Pattern of racketeering activity requires at least two acts of racketeering activity, one of which occurred after the effective date of this chapter and the last of which occurred within ten years (excluding any period of imprisonment) after the commission of a prior act of racketeering activity. The <u>US Supreme</u> <u>Court</u> has instructed federal courts to follow the continuity-plus-relationship test in order to determine whether the facts of a specific case give rise to an established pattern. Predicate acts are related if they "have the same or similar purposes, results, participants, victims, or methods of commission, or otherwise are interrelated by distinguishing characteristics and are not isolated events." (<u>H.J. Inc. v.</u> <u>Northwestern Bell Telephone Co.</u>) Continuity is both a closed and open ended concept, referring to either a closed period of conduct, or to past conduct that by its nature projects into the future with a threat of repetition.

And...

Under RICO, a person who has committed "at least two acts of racketeering activity" <mark>drawn from a list of</mark> <mark>35 crimes</mark>—27 <u>federal crimes</u> and 8 <u>state crimes</u>—within a 10-year period can be charged with <u>racketeering</u> if such acts are related in one of four specified ways to an "enterprise". Those found guilty of racketeering can be fined up to \$25,000 and sentenced to 20 years in prison per racketeering count. In addition, the racketeer must forfeit all ill-gotten gains and interest in any business gained through a pattern of "racketeering activity."

RICO predicate offenses

Under the law, the meaning of **racketeering activity** is set out at <u>18 U.S.C.</u> <u>§ 1961</u>. As currently amended it includes:-

- Any violation of state statutes against <u>gambling</u>, <u>murder</u>, <u>kidnapping</u>, <u>extortion</u>, <u>arson</u>, <u>robbery</u>, <u>bribery</u>, dealing in <u>obscene matter</u>, or dealing in a controlled substance or listed chemical (as defined in the <u>Controlled Substances Act</u>);
- Any act of <u>bribery</u>, <u>counterfeiting</u>, <u>theft</u>, <u>embezzlement</u>, <u>fraud</u>, dealing in obscene matter, <u>obstruction of justice</u>, <u>slavery</u>, <u>racketeering</u>, <u>gambling</u>, <u>money laundering</u></u>, commission of <u>murder-for-hire</u>, and many other offenses covered under the Federal criminal code (<u>Title 18</u>);
- <u>Embezzlement</u> of <u>union</u> funds;
- <u>Bankruptcy</u> fraud or <u>securities fraud</u>;
- <u>Drug trafficking</u>; long-term and elaborate drug networks can also be prosecuted using the <u>Continuing Criminal Enterprise Statute</u>;
- Criminal copyright infringement;
- Money laundering and related offenses;
- Bringing in, aiding or assisting <u>aliens</u> in illegally entering the country (if the action was for financial gain);
- Acts of <u>terrorism</u>.
