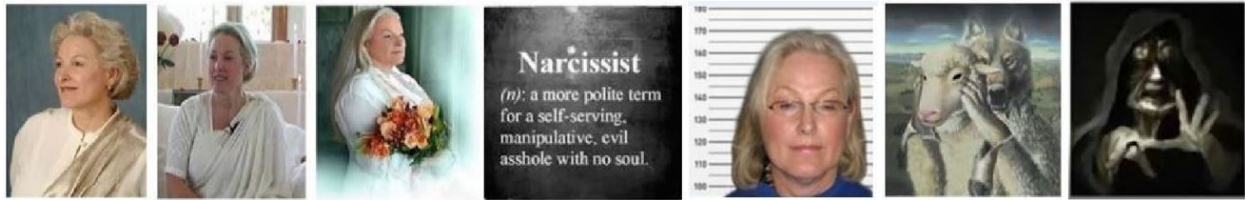

## Rishi Devra AKA Devra Patton West – Her Cult / Criminal Racketeering Gang. A Family Affair.



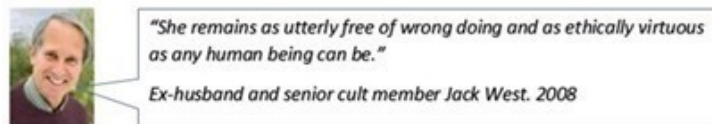

In the two previous editions of these bulletins we focused on the role of senior cult / gang members Geoffrey Reynolds CPA and Dr. Julio Williams MD. However, Devra Patton West's cult / criminal racketeering business is very much a family affair involving ex-husband, Jack West, and occasionally her children i.e. her son Chris Hayworth, her daughter Anna West and her eldest son Rob Meador.

However before getting into the role of Jack West in his ex-wife's criminal racketeering business model predicated by her knowledge of the occult let us make some comments about the three children and their role in their mothers criminality.



**Chris Haywood** has an [FBI record](#) for forgery, substance abuse and traffic violations. Clearly following in his mother's footsteps Haywood was involved in an attempt, with his mother, to defraud a contractor out of payment. This matter went to the Montana Supreme court who awarded judgment to the plaintiff Mathew West (no relation to Devra West) trading as Top to Bottom Construction. Follow [this](#)

Chris Haywood also benefitted from his mother's knowledge of the occult in that during two divorces / custody battles his mother, Devra West, used her knowledge of the occult to terrorize both mothers. She / they succeeded in forcing one mother into believing she had mental health problems who, as a result of their conspiracy, lost custody of her infant daughter to West's porn loving wife beating son. Bottom feeder Geoffrey Reynolds having been in Devra West's employ since Sept 2006, was wheeled in as a character witness for Devra West's son, Chris Haywood.

**Anna West** is obviously aware of her mother's criminal business model not least because of her mother's constant appearances in court as the defendant in fraud related lawsuits, her mother's [conviction for assault](#) and two arrest warrants one for [criminal check fraud](#) and one for [felony theft](#). Anna West will also be very much aware that several friends she acquired between 1995 & 2005, while being associated with her mother's un-accredited school for occult studies, left under a cloud, were physically and mentally abused, violently assaulted or in the case of [Lisa Swidler](#) murdered. 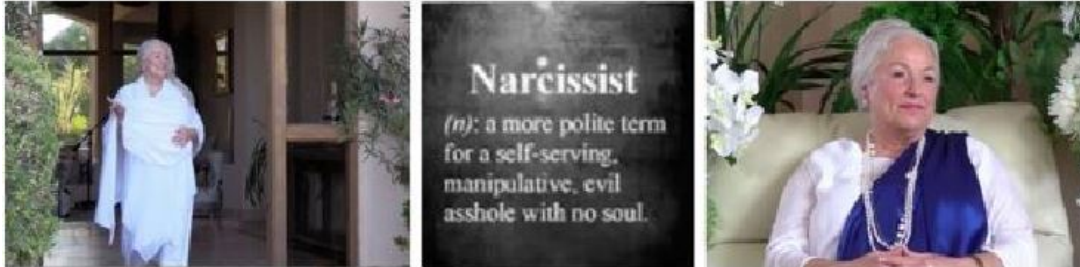

Anna West may or may not be aware that her mother lives in a gated community for her own protection. Anna West was probably too young to remember that she, her mother and father were chased out of New Mexico by one gun wielding victim who took the law into his own hands after realizing that the police would not believe him or help him with Devra West's use of occult 'under the radar' violence against him. This, according to her father, Jack West, who shared this information with him in 2002. He also shared the fact that people who opposed Devra West had a habit of dying suddenly. Anna West probably does not realize that Devra West repeatedly targeted the whistleblower's children in an attempt to intimidate him into withdrawing his lawsuit against her and as revenge for him going public about her criminal racketeering business model. A less spiritual victim might be tempted to go after Devra West's children in response to having their children targeted.

Indeed, this is probably what Devra West intended, as stooge Geoffrey Reynolds made clear when being interviewed by the [Bigfork Eagle](#) reporter on 9 August 2007. To be clear, Reynolds stated that the whistleblower (someone he had never met and did not know) would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family. Now while the whistleblower had no intention of walking into that trap, a lesser person, not able to get to Devra West, would likely go after her children / grandchildren i.e. Anna West and her children, who presumably do not live in a gated community for their protection like Devra West does. Of course, Devra West will deny she is targeting anyone in spite of the evidence from her ex-office manager, Rebecca West, (no relation to Devra West) who in a harrowing email entitled '[Help Me](#)' made it clear that she and Dr. Cole and others

were being targeted with shamanic witchcraft, just as Reynolds made clear that the whistleblower and his family would be.

**As with Reynolds, Williams and Jack West, I am sure her daughter is a sacrifice she is prepared to make; after all, like any narcissist, Devra West is a self-serving manipulative, evil asshole with no soul.**

In spite of the above, and including all of the well documented crimes listed below, Anna West still posted a statement on the 'Meet Up' social media site in 2013 (see below) with the usual suspects in the cult with the hope of attracting new victims to the cult that she knew would probably be subject to mental and physical abuse, violent assaults (both overt and covert), theft, fraud and extortion or worse. However, as one of the main beneficiaries of the \$30,000,000 to \$50,000,000 extorted from scores of victims over the past 27 years since 1991, why not pay her part in her mother's 'world service' efforts?!

Below is a small part of the 2013 social media blitz for the latest iteration of Devra West's criminal racketeering business model after she and the cult were chased out of New Mexico by a gun wielding victim when Anna was a small child and after her mother, father and the rest of the cult were 'obliged' to leave Montana after their criminality was revealed by three newspaper articles, namely in the [Whitefish Pilot](#), [Bigfork Eagle](#) and [Ravalli Republic](#). The following postings were made on the Cave Creek AZ 'Meet Up' site in 2014; Devra West the ring leader at the top pulling the strings with Anna West, Jack West and the other senior members of the cult playing their part. Devra West and her cult have since been banned from this site.

**Robert Meador** became involved when his mother defrauded 'The Circle of Divine Unity' charity out of several million dollars' worth of assets in 2004, acquired largely by public donation. This charity was struck off for fraud in January 2004. You can view the Certificate of Revocation by following [this link](#). The main asset, a property worth \$1,250,000, was put in a personal trust fund for her and her eldest son Robert Meador. In 2008, that trust fund was 'broken' open by a Montana judge with the contents of the



trust, which included the property and \$200,000 defrauded from ex-student Mike Hendrickson, being used to pay Devra West's creditors \$2,000,000 in court fines and interest. To see a copy of the [Sheriff's Sale document](#) announcing the sale of goods at auction follow the preceding link where you will find Devra West and her son named.

At the same time she stole the above property from the charity in 2004, Devra Patton West also stole \$4,000,000 worth of artwork and valuables (as valued in 2002) belonging to the charity, which were also largely paid for by public donation. In a 2009, a [statement](#) given to a Montana court while being deposed under oath, Devra West denied any knowledge of the missing items claiming they were lost, stolen or carted off. In 2014, after the statute of limitations on theft had expired, these items turned up in Cave Creek AZ for sale at auction, for sale from her website and the remainder are currently advertised on her website under the ['The Rishi Collection'](#) tab.

## **Jack West. Now let us look at Jack West a founding member of Devra Patton West's cult / criminal racketeering gang.**

During the time that the whistleblower had his websites up (between 2005 to 2010) he received many statements from other victims of crime at the hands of Devra West and her then husband, Jack West. One such statement that he received was from Jeremy Samuelson, who attested to the fact that he was defrauded out of \$10,000 by Devra & Jack West. Here is a copy of that statement; the square brackets are mine.

### **1. The defrauding of Jeremy Samuelson out of \$10,000**

Dear John

*I read your site with amusement I knew Deborah West back in the 70's and early 80s' when she was Deborah Patton. She had no spiritual powers and was merely another person living the "hippie lifestyle" in Huerfano Valley, Colorado.*

*She subsequently married my land partner Jack West, a timid man with little experience with women. Suffice it to say she overwhelmed him and was soon "running him." [1] She had a jewelry making business with him (they were also marijuana growers) [2] I unfortunately loaned them \$10,000 and was of course never repaid; [3] I had trusted Jack who was a moral man until she twisted his mind. [4] There are many others who remember Deborah West as a powerful personality, willing to do whatever to achieve her ends. [5]*

*She never had any spiritual powers then or even claimed to and absolutely no one thought her a healer. It just goes to show that there is always someone willing to believe.*

My involvement with Divine Unity and specifically, Devra West, began in 1998-99 when I attended sessions of the Sacred Arts Institute. I attended bi-annual sessions and decided to come to Montana in the fall of 2000 to assist the Foundation in its spiritual pursuits.

I first became involved with the office in the spring of 2001 when I went to Jerusalem as a support person. At that time I became aware of the extravagant lifestyle and personal catering needed by Ms. West. She required a suite when the whole project was a money loser and also required several people to be at her beck and call. [1] In fact, all of the personal assistants that I encountered in my time with Divine Unity were verbally, emotionally, spiritually and sometimes physically abused. [2] There were rumors spread around the departure of the Director, Roger Hill, disparaging his name when he had decided to resign as Director of the Foundation at the end of March, 2001. Devra West insisted that he remain through April even though she was the instigator of the rumors. He refused. I then became the Director of the Foundation for a very short period, approximately 4 months. Roger Hill was most helpful in passing on information but could not really pass on the difficulties that he encountered: the secrecy, questionable financial practices and institutionalized abuse. [3]

I soon realized that the position of Director was in name only. All decisions were made by Devra. There was no possibility of handling the personnel issues within the office, as Devra would countermand any or all of my decisions. I was denied signatory on the checking account and access to financial statements. The controls of all the monies were in the hands of Devra and Jack West. [4] When people approached me wanting to know where the donations they had made went, there was no trail. When I insisted on having this information, like monthly financial reports, I couldn't get them and my investigating caused angst within the office. There was one specific circumstance concerning a donation of \$80,000 by Tanmayo (Corrine [I don't remember her last name]) from Brazil. I became aware of the donation when Devra called me at 10:00pm at home to inform me that she called her "little kitty" (referring to the donor), for some money that she needed. Cheryl O'Brien, DU accountant, was specifically told by Devra that she was not to tell me or Mike Hendrickson (volunteer auditor) that this money had come in. Because of our close relationship and her discomfort, she did disclose this to me and asked for my secrecy. To my knowledge this money did not show anywhere on the books. [5]

From a business standpoint, DU makes its money by putting on conferences. I chaired the June 2001 bi-annual Sacred Arts Institute. I found there was no clear methodology in preparing for the 2-week event. It truly was a fly-by-the-seat-of your-pants organization, at the whim of Devra West. I was able to track the monies in and receipting of funds for that 2-week period. It was one of the largest conferences and the gross funds taken in for that major event was approximately \$95,000. The immediate expenses written off against that conference brought profits well below \$50,000. In screening the expenses of the association coupled with the huge personal expenses of Devra, the organization was on shaky ground financially. In trying to attract donations, and trying to put in place some controls of fund usage, I proposed to earmark donations specifically for specific programs i.e. the Children's program etc. There was major resistance to this as all monies were to be given to Devra personally for her use as she saw fit. [6]

She stated at that time that she needed to spend over \$100,000 on legal fees for her son and a custody hearing. [7] I do not know the truth of that statement but was puzzled on how this in any way related to the Foundation. I do know that the handling of monies was shrouded in secrecy. When I asked her why she always called the monies hers and not God's or for the Foundation, she told me how important she

was and without her there would be no Foundation, and it all belonged to her. There was an obvious blurring of lines between her personal ownership and that which belonged to the Foundation. [8]

Her outbursts and tirades existed both within spiritual sessions and at those who worked for her. I personally only experienced the verbal abuse and the screaming over the phone was so intense that I told her that I would not speak to her until she got in control of herself. I hung up on her, a first for me in my life. I observed many occasions of verbal cruelty in which she ranted at people, threw water in their faces and caused severe emotional anguish, all in name of assisting them in their spiritual quest.

[9] In late July 2001, while I was on a business trip to Denver, Susanna Felder, a committed assistant for over 9 years and editor of Devra's writing, called me. She called me in severe distress as she had gotten into a heated discussion with Devra on whether or not I should be put on the BOD – there was no Foundation BOD at that time. Devra became so incensed that she attacked her and ripped clumps of hair out of Susanna's head. This was severe abuse and ultimately led to Susanna leaving DU within the month. [10] I returned to the office several days later and the first thing I did was to address this abuse in a staff meeting with Susanna in attendance. Jack West, who was present at the event, categorically denied it happened while Anandra accused Susanna of causing the problem. This collaborative deception was so shocking that I resigned, effective immediately. The cover-up was endemic and serious abuse issues were lied about and swept under the rug. The lack of integrity by Devra, her impropriety around money and her physical and verbal abuse of individuals were the reasons for my leaving. [11]

I make this statement as I feel a responsibility to those who may become involved with Divine Unity, to those with whom I worked and to those who were affected by these behaviors. I do this in the clearest and most truthful manner.

1. Like all narcissist's Devra Patton West believes herself to be superior to everyone requiring servants and first class accommodation often to be paid for by the sheeple she has brainwashed and conditioned to playing serf to her impression of royalty. 2. The whistleblower also confirmed, as do many other witnesses, that Devra West is dangerous psychopath who lashes out at anyone around her who fails to jump high enough when called upon and is especially cruel to anyone who challenges her authority and delusions of grandeur. Three such victims were Susannah Felder (see below), [Beatrice McGuire](#) and [Marion Cantwell](#).

3. Secrecy, questionable financial practices and institutionalized abuse.



**4.** All the financial controls were in the hands of Devra & Jack West who were defrauding the charity. The charity's bank account did not even have the charity's name on it all check books simply had Devra & Jack West on them. This and many other fraudulent practices led to the charity being struck off the Montana charity register. Here is a copy of the [Revocation Certificate](#).

**5. & 7.** The \$80,000 donation referred to was stolen by Devra West to pay for her son's legal fees in the matter of his custody battle against his first wife Kendal. Along with the money stolen by Devra West to pay for his legal fees, she also mounted a campaign of occult 'under the radar' violence against Kendal which resulted in her having mental problems with the result that Devra West's porn loving wife beating son, Chris Haywood, gained custody of Kendal's daughter in spite of [his FBI record](#). A few short years later, Devra West reprised her role targeting Chris Haywood's second wife, although this time the conspiracy to 'throw' the custody hearing by intimidating Haywood's wife and unfavorable witnesses failed. To review the transcript for the second custody hearing held in 2007 and to get an insight into Devra West's sordid home life go here [1, 2 & 3](#). Clearly, Devra West had tried to get the bookkeeper Cheryl O'Brien to conceal the fact that she had stolen the \$80,000. A few short years later when Devra West got wind that the IRS were going to investigate her finances she both emptied the [charity's bank account](#) and got her employees to [shred as many incriminating documents](#) as possible.

**6.** The whistleblower confirmed the conspiracy that AJ White points out above. Put simply, after the expenses were deducted leaving, in the example above \$50,000, Devra West would take the \$50,000 and leave an I.O.U. behind of another \$50,000 to \$100,000. Over a period of years this amounted to a huge sum of money. Eventually, as happened, Devra West bankrupts the charity then takes the charity's main asset, the property the property valued at \$1,25,000 in 2002, in lieu of several fake 'loans' she saddled the charity with. On top that, she also stole \$4,000,000 worth of artwork and valuables as mentioned in detail in the [bulletin mentioned two weeks ago dedicated to Geoffrey Reynolds CPA](#).

**8.** Again the qualities of a narcissist come to the fore. 'A self-serving manipulative, evil asshole with no soul.' See below here.

9. Verbal cruelty, ranting at people, throwing water in their faces and causing severe emotional anguish, all in name of assisting her victim's in their spiritual quest. My favorite has to be the comments that [Carlida Finch](#) overheard Devra West saying about Dr. Pat Cole MD. Basically, she said that she did not mind if she killed Dr. Cole as being an enlightened being she could as easily spend the rest of her life in a 6' X 6' prison cell as in a \$6,000,000 mansion. Of course it would not occur to this narcissist arsehole that enlightened people do not commit murder they nurture all living things!

10. "Devra became so incensed that she attacked her and ripped clumps of hair out of Susanna's head." Like scores of other violent and financial crimes this crime went unpunished probably because the victim knew that if she went to the police she would become the target of a campaign of occult 'under the radar' violence as administered by Devra West to other employees and Devra West's two daughter's in law and subsequently to the whistleblower and his family. Clearly Devra Patton West does not acknowledge state or federal law believing that she is above both because the 'weapon' she uses to commit crimes, intimidate witnesses and enforce a code of silence is not recognized by legal statute.

11. Now we get to Jack West, the Jack West that Jeremy Samuelson said was being 'run' by Devra West. The Jack West that Jeremy Samuelson said had lost his morals. According to AJ White Jack West categorically denied the events occurred and blamed the victim. The cover up was endemic and serious abuse issues were lied about and swept under the rug.

### **3. Jack West making false statements to a Montana court on behalf of his narcissist criminal wife who was defendant in a fraud lawsuit.**

When the whistleblower's fraud lawsuit against Devra West was being heard in court in Montana, Jack West was called as a witness and questioned about the letter he had written to the Immigration & Naturalization Service (INS) for the whistleblower on March 13 2002. When asked about the letter, by the whistleblower's lawyer, Jack West lied saying that he had been asked to write the letter against his will by the whistleblower and the contents of the letter were not true. What he was doing was following instructions from Devra West who had denied that she had entered into any business dealing with John Watson.

When the whistleblower's lawyer pointed out to Jack West that making false statements to INS was punishable by 10 years in prison, Jack West withdrew his false statement.

**Let us now take a closer look at how Jack West, working in unison with two other senior members of the cult (Geoffrey Reynolds CPA and Julio Williams MD) acted on Devra West's instructions to defame, character assassinate two victims while trying to deny and derail court proceedings both had brought against Devra Patton West.**

**VICTIM 1.** The Whistleblower John Watson – Victim of fraud, attempted murder, a criminal conspiracy to bankrupt him and an eleven year campaign of occult ‘under the radar’ intimidation (ongoing) directed at him and his family.

In January 2002, the whistleblower John Watson, was recruited by Devra West’s ex-husband, Jack West, via a meditation group which was run for the express purpose of recruiting new blood into Devra West’s cult. This method of recruitment along with ‘[meet up](#)’ groups advertised on social media is still used today in Arizona. After being recruited as a business consultant (like many before and since) the whistleblower was tasked with setting up a number of for-profit and non-profit corporations which he proceeded to do on the understanding that when the work was done he would be rewarded with pay and shares in the for-profit corporation known as Millennium Mind Inc.

On completion of the work, Devra West announced that God had spoken to her and told her that shares in corporations were a thing of the past, and as a result of that conversation (with God) the whistleblower would not be paid for the 6 months work he had completed or be granted shares in the Millennium Mind Corporation that he had formed using his own New York accountants. After realizing that Devra West had no intention of honoring the agreements she had made with the whistleblower, he decided to launch a fraud lawsuit against Devra Patton West, which he announced to her early in 2003 – several months after his constructive dismissal by her in August 2002. [A lawsuit he won in 2008.](#)

**The following events occurred after he announced he was going to sue Devra West for fraud. These events show beyond any doubt, that Devra West is not a guru but a dangerous criminal masquerading as a guru, using religious freedom laws as a cover for her lies, deceit and propaganda.**

**1.** Devra West requested a private meeting with the whistleblower at his home in March 2003, which unbeknownst to Devra West, the whistleblower recorded. You can listen to the entire recording by going [here](#). During the meeting, she admitted defrauding him but did not see herself writing out a cheque for what she owed him. Other highlights of the meeting were the following statements by Devra West which show her in her true light:-

**WARNING FOUL MOUTHED SERPENT MASQUERADING AS THE PLANETARY REGENT!**

1. [The truth does not actually matter \(if you can convince the public and a court of law that your lies are truth!\).](#)

2. [If you sue me I'll get so f\\*\\*king down and dirty, huge expenses coming out of your pocket and not mine \(because cult members would pay for her legal expenses\).](#)
3. [Yes I dispose of people like Kleenex.](#)
4. [My agreements are not worth anything.](#)

**2.** Devra West announced during their meeting (see point 2 immediately above here) that she would get so down and f\*cking dirty. An email sent from ex-cult member [Anandra George](#) years later to the whistleblower's lawyer revealed that following their meeting, all of West's employees were forced to write false statements about the whistleblower on pain of being fired.

**3.** Intimidation was directed at the whistleblower in the form of statements posted on West's website in 2005, by three members of her cult (two of whom had never met the whistleblower). These statements were a blatant character assassination of the whistleblower's character while at the same time declaring Devra West to be the second coming. The statements were posted by [Messrs. Williams, Cole and Cornell.](#)

**4.** In January 2007, senior cult member Julio Williams MD, not content to be a party to the defamatory statement posted on Devra West's website (see above), and fearing that the whistleblower's lawsuit was gaining traction, wrote a [threatening email](#) to the whistleblower; a short excerpt of which is below here.

If you want to wrestle with me in the legal arena know that I will do everything in my power to bring you down.

Mr Watson, You will have your date in court. You fuck with me and you will meet your match.

**5.** In March 2007, the whistleblower started to receive a series of harrowing emails from [Rebecca West](#), no relation to Devra West, which graphically explained the circumstances she and Pat Cole found themselves trapped inside Devra West's cult. As explained in previous bulletins, Devra West advertises fake jobs and on the basis of what appear to be good employment opportunities, applicants travel from all over the US to take up those vacancies only to have their pay cut by 20% on day one then also told that the health benefits that were advertised were also not available. The new employees were given a stark choice: accept the lower pay and no health benefits or travel back across the US to where they had come from!



Those that stayed and took up their employment with Devra West, were then brainwashed and conditioned into joining her cult and submitting to her will or being fired before the end of the first 90 days after which West would have to pay employment insurance. The following excerpt from Rebecca West's email entitled '[Help Me](#)' makes it very clear that Devra West had a 'revolving door' policy to employees and consultants alike. *After more than 30 employees coming and going, (16 just since I started May 1, 2006, not counting myself, current employees or contract labor), there are currently three employees remaining. Two of the three are very much in her control due to fear and/or ignorance and have proven to me, I cannot trust them. I have been trying to get the monies she owes me before I end my contact with her, specifically a missing paycheck, overtime, overdraft charges and (wishful thinking) the bonus she promised me for the hundreds of hours of overtime I incurred.*

It is clear from the above, and the rest of the [emails sent by Rebecca West](#) and scores of other witnesses, that Devra West was running a cult which was disguised as a quasi-religious organization. It was in fact, a well-oiled criminal racketeering business model with Devra West at its head. After receiving these emails from Rebecca West and others trapped inside the cult, the whistleblower took the decision to go public about Devra West's criminal racketeering business model and shared what he had learned while researching his lawsuit with two local newspapers the [Whitefish Pilot](#) & [Bigfork Eagle](#) which published stories about West's criminality on July 12 2007 and August 9 2007, respectively. A further news article about the whistleblower's win in court against Devra West was published by the [Ravalli Republic](#) in October 2008.

**6.** On August 9 2007, while being interviewed by the [Bigfork Eagle](#) newspaper, and during what he thought were 'off the record' comments, senior cult member Geoffrey Reynolds CPA announced that the whistleblower, John Watson, would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family. The reporter, Constance See for the [Bigfork Eagle](#), took his comments seriously enough to share them with the IRS criminal investigator who was looking at Devra West's finances at the time.

**[We have made it clear in other bulletins that the secret of Devra West's power over others, is her use of occult knowledge. Knowledge that she obtained while attending the '[Robert Jaffe School for Energy Mastery](#)' between 1990 & 1991 for the specific purpose of preying on others. A longer explanation follows towards the end of this email].**



***Devra West's criminal / racketeering business model is entirely based on her ability to commit murder multiple times and not be called to account. Clearly Reynolds was briefed about the murder of Lisa Swidler and thought that the murder of the whistleblower would also be a 'slam dunk.'***

**Several days after Geoffrey Reynolds made his statement to the press on August 9 2007, Devra West made an unsuccessful attempt to murder the whistleblower. Her motives were twofold:-**

- 1.** After the whistleblower went public about Devra West's cult and her criminal activity in Montana, it rendered that state useless for her activities because after all the negative publicity, no one was buying the 'divine being' routine anymore which formed the basis of her narcissistic fraud scam.

As one can see below from an excerpt of Reynolds' resume taken from his own website (full copy available [here](#)), at the time he made these false claims to the Montana court in 2010, Reynolds did not

join Devra West's employ until September 2006, and so did not know that the whistleblower existed until he was briefed about West's vendetta against the whistleblower after September 2016.

Note the sub-heading above, 'Response to the call of Master Surya Devi for Review,' what Devra West asserts in this missive to the mailing list of her cult is that she, as an Ascended Master, is putting forth her actions (multiple violent assaults and extortion) for review by some imaginary long dead Ascended Master. This is all a huge deceit by West to justify her actions to the rest of the brainwashed and conditioned members of her cult. Clearly, Devra West is either mentally ill or more likely criminally insane.

Like all narcissists and psychopaths, Devra West uses ‘projection.’ A definition of ‘projection’ is as follows. ***The attribution of one’s own ideas, feelings or actions to other people. Especially the***

**externalization of blame, guilt or responsibility.** Below here are two examples of projection used by Devra West during her reign of terror as the Ascended Master 'Surya Ma.'

Example 1. After the whistleblower received [judgment against Devra Patton West](#) for defrauding him in 2008, a fact that the [Ravalli Republic published a news article about](#) Devra Patton West in another example of 'projection' issued the following statement from her website.

**Millennia Mind Dispute with John Watson:**

Devra Surya Ma's legal team has filed for an appeal for the sanction ruling stemming from a technical error and timing matter. Additionally, contrary to Watson's claims of a "Big Win", lawsuits have been filed against John Watson for his many threats and criminal acts against Dr. West and her family members and will be diligently pursued by Dr. West's legal team.

**TRUTH:** No business contract between Dr. West and John Watson has ever existed. **The legal dispute was fabricated by Watson to leverage an extortion scam.** Any and all business proposals made by Watson were declined. Dr. West has no intentions of enabling an extortion scam, therefore no settlement of any kind will be entertained.

Firstly, Devra West states that the whistleblower's victory against her was a technical error! Then there was the matter of the [business cards](#) printed that showed John Watson and Devra West as shareholder / directors of the corporation that Devra west maintained he was not a part of.

#### **4. Jack West’s statement of denial and the defamation and character assassination of two of his wife’s victims; posted on her website in July of 2007.**

Now let us review the statement that Jack West posted on Devra West’s website in denial of her obvious guilt while impugning the victims of the very crimes his wife has committed against them.







Let me compare some of Jack West's obvious lies point by point with the **FACTS**.

**1.** He starts off with the statement, "**To all who value the truth.**" Jack West, as we are about to see, would not recognize the truth if it hit him between the eyes.

**2.** "**She remains as utterly free of wrongdoing and as ethically virtuous as any person can be.**" If you the reader have got this far you will know that Devra West is a compulsive liar, has allegedly committed acts of theft, fraud, extortion, violent assault, attempted murder and quite possibly murder.

**3.** In his statement above, Jack West does was all compulsive liars attempt to do which is to assert that the victim is guilty of the crimes committed by the perpetrator! 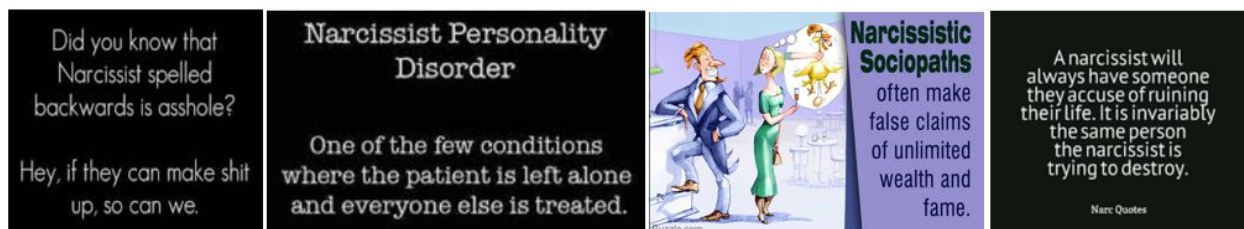
**5.** If Devra West had any money of her own it was derived from crime and once acquired by her it was salted away into precious gems or precious metals or into offshore bank accounts and was never put back into her 'business model.' This can be easily proven by reading **A. J. White's** statement wherein it speaks about Devra West stealing \$80,000 from the charity to fund her son's legal fees and then read the **Whitefish Pilot** and **Bigfork Eagle** newspaper articles wherein it is made clear that Devra West has a lien against her for unpaid employment insurance and that the whole point of the vicious beatings she gave Dr. Pat Cole MD was to extort her entire net worth estimated at \$1.3 million that Geoffrey Reynolds then money laundered through her business.

White and related to an incident well before the whistleblower was recruited as a consultant in 2002. It became clear from the investigation by the Montana government, that Devra West was defrauding her charity. This is why it was struck off the register in November 2003. After the charity was struck off, Devra West stole the charity's main asset, a property on 20 acres at Fred Burr Road, Victor MT and put it in a personal trust for her and her son, Rob Meador. Additionally, and at the same time, Devra West stole \$4,000,000 in artwork and valuables (as valued in 2002) belonging to the charity and hid them in a storage unit, only to have them reappear in 2014

at auction in Carefree AZ and for sale from her [omniawakening.org](http://omniawakening.org) website. Like the property, the artwork and valuables were paid for mainly by public donation. While being deposed by the whistleblower's lawyer in 2002 and while giving [her statement](#) under oath, Devra West stated that the items she later sold from her website at auction did not exist! **7.** As established here and elsewhere, Devra West **never had an income** from other sources other than the charity and the students and employees that she bled dry. As explained in the ['Devra Ji'](#) tab on this website, Devra West took every penny she could from the charity, all the while leaving behind bogus invoices. She did this knowing that at some point, the charity would be bankrupted / run into the ground financially, at which point she would then 'clean up' by claiming the charity's remaining assets (paid for by public donation) as payment for the bogus invoices. Which is exactly what happened. Later in 2007, while extorting \$1.3 million from Dr. Cole MD, Devra West tried to force her bookkeeper to 'manufacture' false invoices to make it look like the money stolen from Dr. Cole MD was received as part of normal business revenue - the [bookkeeper resigned](#) rather than falsify the records. Along comes 'bottom feeder' Geoff Reynolds, who has no qualms about money laundering, murder or criminal conspiracy.

**8.** The whistleblower never had a greed driven scam; this is just another attempt by 'liar for hire' Jack West to attribute the crimes of Devra West to the victim. Similarly this statement from West's personal secretary of 6 years, [Barbara Costantino](#), makes it clear that after each victim leaves, Devra West lies about the circumstances of their departure in an attempt to rewrite history. This statement from student, [Deborah Coffey](#) explains how West uses students / cult members to gang up on the victims selected as targets for extortion, or mental and physical abuse.

There were no 'profane' emails, as if there had of been, Jack West would have produced them. The only profane email was sent by fellow senior cult member, Julio Williams to the whistleblower (see above). Again, Jack West knowing full well that Devra West is an occult master who uses the threat of death and attempted murder as a weapon, seeks to assert that the victim, the whistleblower, is guilty of those crimes. The whistleblower has no criminal or civil record of trouble with the courts, save his involvement with Devra West. ## Left Employment Due to Dissatisfaction with Working Conditions

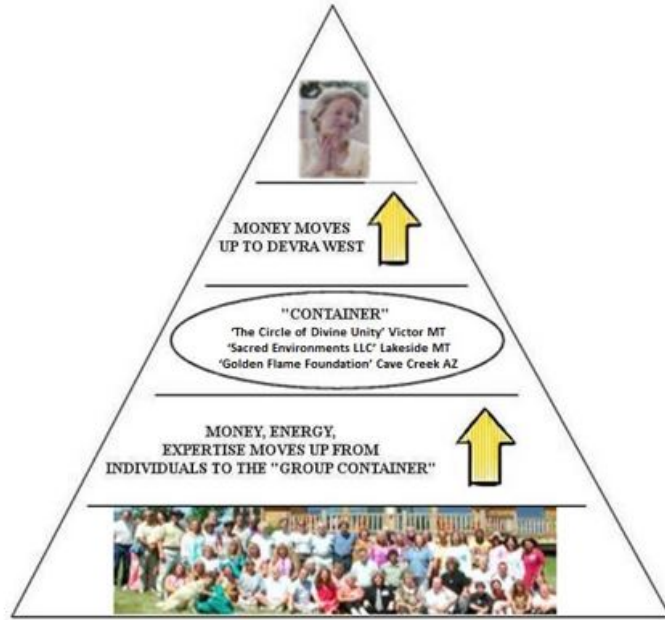
What working conditions were you not satisfied with?

Oh, the cult wrote to the newspaper pointing out that Ms. West had never pled guilty, therefore she could not be found guilty to which the editor of the Whitefish Pilot replied thus.

I was not working at the Pilot that week. I went to see my father in Washington. After I returned, the publisher, Tom Kurdy, asked me to run a clarification. He wrote the clarification and e-mailed it to me. This is what ran on May 1, 2008:

A headline in the April 24 issue of the Pilot said that Devra West had pleaded guilty in an assault case in Flathead County Justice Court. West actually entered a no-contest plea, as noted in the story. The Associated Press Stylebook says that when a defendant enters a no-contest plea, "it means that he is not admitting guilt but is stating that he will offer no defense. The person is then subject to being judged guilty and punished as if he had pleaded guilty or had been convicted." Because imposition of the sentence was deferred, the charges will be dropped in six months and expunged from West's record.

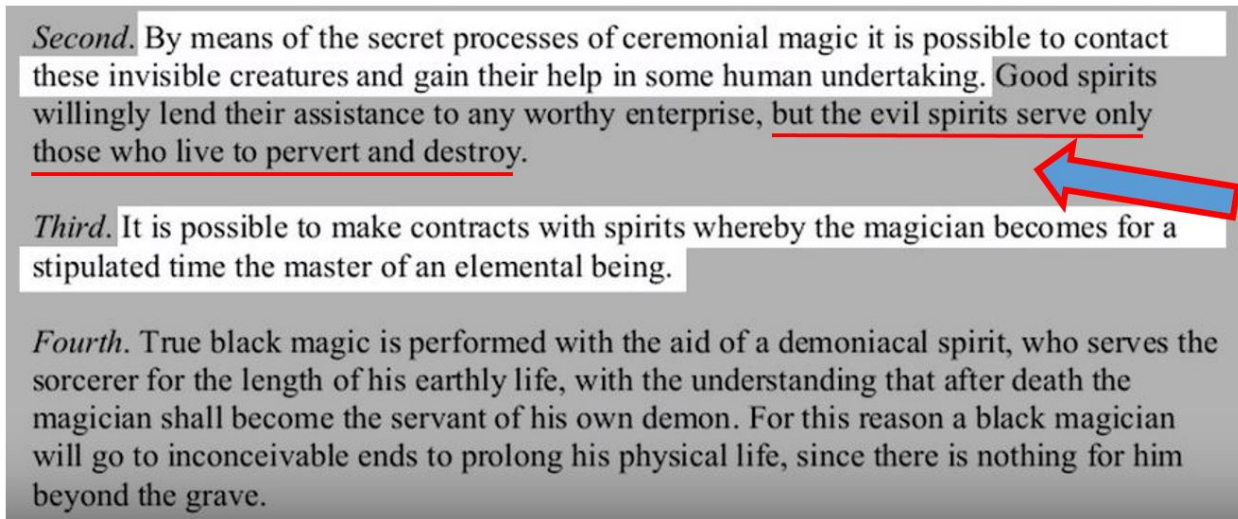
In summary. 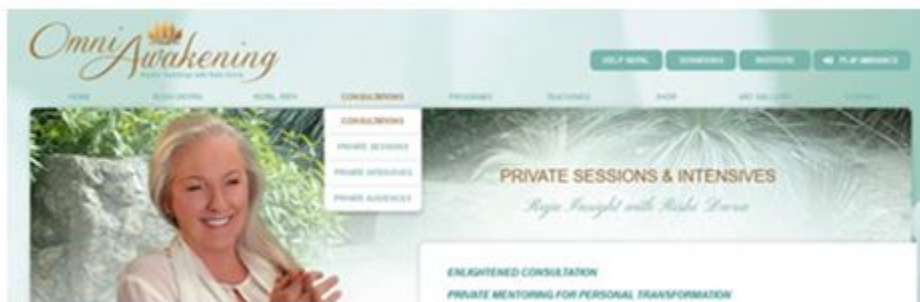
