If Devra West is a "blessing to all souls" and is an "instrument of mercy" then tell me...

1. Why was she chased out of New Mexico in 1995 by one victim wielding a large loaded gun?

A victim of crime and of Devra Patton West's signature weapon i.e. occult 'under the radar' violence that the victim knew the police would believe, not understand and not be able to help him.



Above from left to right: Dave Kushner defrauded out of \$30,000. Marion Cantwell kidnapped, falsely imprisoned and held captive until she agreed to give part of the sale proceeds to Devra West. Lisa Swidler murdered by Devra West as after witnessing both crimes tried to leave the cult and shortly afterwards died suddenly and mysteriously.

2. Why in 2005, did she murder ex-confident and ex-senior student Lisa Swidler, who witnessed Devra West commit two serious crimes against two other ex-students?

Ex-student [Dave Kushner](#) was defrauded out of \$30,000 after Devra West used Lisa to negotiate a fourteen day loan from Kushner, which Devra West refused to repay. Lisa also witnessed Devra West kidnap, falsely imprison, beat and extort tens of thousands of dollars from ex-student [Marion Cantwell](#). The whistleblower was told about these crimes by Dave Kushner in 2005, but a year later, he got independent corroboration from Marion's new employer who phoned him to discuss posting on the whistleblower's website about these crimes and to assure himself that Marion was a victim and in no way part of Devra West's criminal business model.

As we shall see, the threat of murder and actual murder is regularly used by Devra West as a way of silencing victims and witnesses of crimes she commits and then describes later as 'World Service.'



Above from left to right: [Susannah Felder](#) ex-employee partially scalped By Devra West. Ex-student [Beatrice McGuire](#) needed plastic surgery after part of her ear was ripped off by Devra West. Ex-student and business partner [Dr. Pat Cole MD](#) was repeatedly hit on the head with the heel of Devra West's shoe until blood ran down onto her blouse. [Ingrid Smith's](#) 6 year old son was assaulted by Devra West.

3. Why between 2001 and 2006, were numerous acts of violence perpetrated upon students and employees by Devra Patton West?

In July of 2001, when challenged by employee Susannah Felder about an \$80,000 donation that Devra West intercepted and stole from her charity to pay for her sons legal fees, Devra West launched herself at Susannah and ripped clumps of hair from her scalp. Ex-board member of the charity, A J White, gave the whistleblower a statement about the incident which can be read by going [here](#). In 2002, while giving a seminar to students in Montreal, Devra West was challenged by student Beatrice McGuire, who challenged some of the statements that Devra West was making. In front of tens of students Devra West leaped at Beatrice and ripped part of her ear off. Later, Devra West agreed to pay the cost of Beatrice getting plastic surgery to repair the damage but stated that her recollection of the events was different from Beatrice's (and presumably the other 30 students present who saw the incident. Student Debra Coffey gave the whistleblower [a statement](#) about the assault on Beatrice and explained how the brainwashing and conditioning of new members of the cult was orchestrated by Devra West.

After Devra West's charity was struck off in January 2004 for defrauding the charity out of cash donations from the public, she quickly doubled down on her criminality by defrauding the charity out of the charity's largest single asset; a property and 20 acres worth \$1,250,000. She did this by calling in fake loans that she had planted over the preceding years that to all intents and purposes, made it look like the charity was in debt to her. The property was put in a personal trust fund for her and her eldest son, Rob Meador, but was broken out of the trust in 2008 and sold at auction at a [Sheriff's Sale](#) to pay her creditors, past victims of crime, \$2,000,000 in court fines and interest. At the same time, \$4,000,000 worth of artwork and valuables were stolen from the charity, hidden in a lock up for ten years, then reappeared in 2014 after the statute of limitations on theft had passed. These incidents are both covered in detail in a previous bulletin.

Short of money to fund her expensive lifestyle and close to bankruptcy for the second time, Devra West, a pathological liar, told her students that she was experiencing difficulty, not because she was a criminal, but because she was in the process of moving from the [5th dimension to the 7th dimension!](#) As a consequence of this shift, she had to move to the more rarified vibrational setting of Shamballa. The move to Shamballa actually involved a move north by 100 miles from Victor MT to Flathead Lake MT! Additionally, Devra West told her brainwashed students that she could only take 12 disciples and only those willing to [donate 66% of their net worth to her!](#) Dr. Pat Cole MD was one of those students who became a disciple, but unfortunately Dr. Cole took too long in emptying her bank account into Devra West's bank account. Sometime in early April 2006, Devra West got tired of waiting for her disciple Cole to act so she launched a campaign of violence, both overt and covert, designed to force Cole to hand over her entire net worth amounting to \$1.3 million – which she succeeded in doing.



Above: Devra West a narcissist asshole with no soul who believes that her ability to intimidate and murder her fellow human beings and get away with it makes her into a God so she dresses accordingly. Scum like Geoffrey Reynolds, Julio Williams and ex-husband Jack West, lacking a moral compass and any shred of integrity, are willing accomplices in the self-appointed Planetary Regents 27 year crime spree.

Below, is how Dr. Pat Cole MD described the last of many assaults by Devra Patton West to [Whitefish Pilot](#) newspaper on July 12 2007.

"She has told me that she has the 'spiritual' power and authority to 'take me out,' to be composted," Cole wrote in the temporary restraining order statement. Cole claims Ms. West threw a lamp at her and hit her with a briefcase, cell phone and her hand. "She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself."

Photos taken after the alleged beating were submitted to the sheriff's office.

Several emails that were sent to the whistleblower by ex-employee [Rebecca West](#) (no relation to Devra West) and ex-employee [John Mark Young](#) make it clear that Devra West's corporation was a front for a cult / criminal racketeering business model that sucked in employees and students at one end, and after relieving them of their wealth, spat them out at the other end. Those who went public or to the police, were targeted with threats of murder and became the subject of a campaign of 'under the radar' violent occult attacks by Devra West. Those that did make complaints to the authorities were seldom successful, as Devra West would field a number of fake / false witnesses who would contradict what the victim was saying, thereby making justice very difficult to attain. One such victim was Carlida Finch, an employee of Devra West's who was given the stark choice in 2006 of either joining West's cult as a low paid or no paid slave or being fired.

Carlida went to the authorities and made a claim for employment insurance on the basis that Devra West's corporation was a 'dangerous' working environment. Her claim was denied even though she had overheard Devra West planning the murder of Dr. Cole MD as was made clear in the '[Statement of Fact](#)' she supplied to the authorities. Clearly, Carlida Finch's working environment was dangerous as was made clear in Rebecca West's emails and the assault upon Dr. Pat Cole MD but Devra West fielded a number of false witnesses and Carlida's claim was denied. Using false witnesses or having false witnesses generate entirely fake witness statements about West's adversaries is a strategy that Devra West uses often, as we shall see in the next incident described below.

4. Why did Devra West defraud the whistleblower John Watson in 2002, try to murder him in 2007 and when that failed conspired to bankrupt him using a pair of frivolous defamation lawsuits?

As mentioned at length in previous bulletins the whistleblower, one of scores of victims of theft, fraud and extortion at Devra West's hands, was defrauded in 2002. After announcing he was going to sue

Devra West for fraud in March 2003 in 2005, he was met with a [defamatory statement](#) that was posted on Devra West's websites authored by cult member Julio Williams MD and others. He became the subject of false witness statements that Devra West forced her employees to manufacture on pain of being fired from their jobs if they did not comply. One such statement, later retracted, was from student / employee [Anandra George](#). In December 2006, both John Watson and his wife and children became the victims of a sustained and vicious campaign of occult 'under the radar' violence at the hands of Devra West clearly intended to intimidate John Watson into dropping his lawsuit against Devra West.

In January 2007, senior cult member Dr. Julio Williams sent John Watson a [threatening email](#) telling the whistleblower not to f*ck with him and promising to give Devra West \$2,000,000 for her legal fees. On August 9 2007, while being interviewed by the [Bigfork Eagle](#) newspaper senior cult member and 'liar for hire' [Geoffrey Reynolds CPA](#) told the reporter, Constance See (in what he thought was an 'off the record conversation) that John Watson would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family. Several days later Devra West made an unsuccessful attempt to murder the whistleblower.

From the statement made by Reynolds we can infer two things.

1. That Geoffrey Reynolds had been briefed by Devra West on her ability to use occult knowledge to commit murder indeed she may have shared details of other victims that she had successfully killed such as the murder of Lisa Swidler just two years earlier in 2005.
2. It was apparent from the 'matter of fact' way that Reynolds shared the information with the reporter that he not only believed that John Watson was going to be murdered by Devra West, but that he was quite comfortable being complicit in his murder.



Above: The secret of Devra West's power over victims and witnesses of the crimes she commits, and her hold over the members of her cult is her ability to use occult knowledge she acquired between 1990 & 1991 to intimidate and murder targets at a distance with plausible deniability. Hence Reynolds confidence that the whistleblower would either be murdered or be jailed for reacting to what West was going to do,

If Devra West is not a "Blessing to All Souls" and is not an "instrument of mercy" what is she?

We maintain that Devra Patton West is a 'cold blooded killer' who, using gaps in the law, has managed to operate her murderous criminal racketeering cult / gang for the past 27 years so far with impunity! Let us review the evidence.

We know certain facts about what Devra Patton West and her then husband, Jack West, were doing prior to 1990. We know from witness [Jeremy Samuelsson](#) that Devra and Jack West were both small time con artists defrauding individual victims out of several thousands of dollars at a time; Jeremy was defrauded out of \$10,000 by the couple. We know from another victim, Satya who attended [The Robert Jaffe School for Energy Mastery](#) in 1990 to 1991 with Devra West, that she too was defrauded out of \$6,000 by Devra West. We also know that [Satya](#) described Devra West as a deeply troubled psychopathic person/personality. We also know that prior to 1990, both Jack & Devra West were pot growers, drug dealers and that Devra West's only business venture went bankrupt. At some point, Devra West decided to combine her prolific substance abuse and ventures into altered states of reality with formal energy training and so enrolled in a course of training at the energy mastery school mentioned above here. Upon completing her training in 1991, Devra West declared herself to be an Ascended Master and that anyone not agreeing was 'blocking the energies.'

It is obvious from her actions (Ye shall know them by their fruits) that Devra West, with the full cooperation of her husband Jack West, used the occult (hidden) knowledge she had acquired, not for the good of humanity, but to leverage her life long criminal tendencies. It is said that a leopard cannot change its spots it is clear that Devra West could not change hers either! It appears that Devra West adopted some of the bad practices she learned at The Robert Jaffe School for Energy Mastery, itself a cult, when creating her own cult which was built around her self-proclaimed divinity. Below, is an excerpt from a website entitled '[Cult Education Institute](#)' by following the link you can review statements given by those who escaped from that cult. Here is an excerpt from one ex-cult member.



In the group we were urged to adopt Islam as our religion. I took that seriously and set about learning the five-times-a-day prayers, etc. I became extremely straight-laced and wore a scarf on my head as much as possible, since I was told I needed to protect against astral beings. On top of following Islamic practices, we were given a number of Sufi practices, such as chanting in Arabic thousands of times each morning and evening. It was quite time-consuming. And we were often asked to participate in costly events and give sizable donations to the group. [Ex-members of Devra West's cult will know this happened regularly to them.]

We were told that all sorts of things were "against God". Things like Reiki healing, which I had been involved in for some years. Over time I would learn that homosexuality and eastern religions were also "against God". By then, I had become quite disgusted with all that was being asked of me and I wrote an email to Dr. Jaffe announcing that I was leaving the path.

Jaffe responded months later and threatened that I could become sick and die from something like cancer for leaving. That did not happen. Instead, I discovered some years later that Jaffe's own wife got ill with cancer and died from it. [Ex-members of West's cult who went public will know about sudden deaths and threats of murder.]

So, in Devra West, we have someone who prior to 1990 was a drug addict / drug dealer, a bankrupt and a small time con artist and who, post 1991, declared herself to be a minor deity and, totally mirroring the behavior she learned at the Robert Jaffe School for Energy Mastery, formed a personality cult around herself. And just as in the Jaffe School, those inside her cult were subject to a strict code of discipline and forced to fund raise and make large donations to fund her expensive lifestyle. And, just as we learned from the witness statement above where Robert Jaffe threatened death to his ex-student

who left his cult, Devra West is known to use the exact same strategy against those members of her own cult who oppose her, go public about her criminality or who refuse to empty their bank accounts into hers in a timely manner.

To prove this is so, we need look no further than the statements made by [Rebecca West](#) (no relation to Devra West) who wrote a harrowing email to the whistleblower in March 2007 entitled 'Help Me' asking for help with Devra West's 'shamanic' witchcraft. Then, there is Devra West's daughter-in-law [Jamie Haywood](#) who was targeted in 2007, with the clear objective of intimidating her into giving up her infant daughter to Devra West's son, Chris Haywood. Then, there is the whistleblower [John Watson](#), who after a failed murder attempt on his life, he and his family have been targeted relentlessly by Devra West for the past 12 years. Lastly, let us review a statement that Devra West gave to the [Whitefish Pilot](#) on July 12 2007, which makes it very clear that Devra West was trained in Shamanism and that this deeply flawed and dangerous psychopath uses that very same knowledge to silence victims and witnesses of crime just as her mentor allegedly threatened to do according to the witness above. Here is an excerpt of Devra West's statement to the Whitefish Pilot newspaper.

An author and speaker, West claims she recognized her clairvoyant and healing gifts at age six when she began "interacting and communicating with archangel Michael," according to her book "The Christ Heart." West claims to have **been trained in shamanic visioning and healing** by Native American elders and to have been both a Cheyenne medicine woman and General George Patton in past lives.

She also claims her "gifts" can heal people with various illnesses, including leukemia, and she plans to teach what she knows to cardiologists and other physicians when her plan for healing spas unfolds. "If you ever saw me heal, you'd be down on your knees crying like a friggin' baby," West said.

It is clear that there are many similarities between the behavior that victims experienced while attending The Robert Jaffe School for Energy Mastery (and subsequently shared with the [Cult Education Institute](#)) and what Devra West has inflicted upon those inside her own cult since then. In a recent bulletin, we compared the activities of Devra Patton West with those of John of God who was recently arrested in Brazil. During his arrest the police were met with many examples of unusual phenomena such as news reporters fainting, computers and printers taking on a life of their own and one officer crashing his car on the way to taking his statement. Long story short, 'John of God' made it very clear to everyone that he possessed occult knowledge and that this knowledge was the secret of his power over others. At about the time of his arrest, a whistleblower and key witness to the Brazilian authorities, Mrs. Bittencourt, (who was under protective custody at the time) was 'suicided' that is to say it appears she took her own life. After his arrest, 300 women came forward saying they were sexually assaulted by 'John of God' presumably they were too afraid to come forward while he was still at large fearing what might happen to them if they went public. At the bottom of this bulletin we share the names of tens of victims of crime at the hands of Devra West, with most too afraid to go to the police.

The whistleblower has shared some of his experiences with us and it is clear that Devra West has a whole range of options to use in her occult arsenal to both keep the members of her cult in-line, and to silence critics. Clearly, murder is one option as made clear in the sudden death of Lisa Swidler in 2005, and the attempted murder of the whistleblower in 2007. Marion Cantwell was threatened with murder and Dr. Cole MD, according to witness [Carlida Finch](#), was destined to be murdered. If the conversation that the whistleblower had with ex-husband Jack West in 2002 is anything to go by there may be many more dead bodies who appeared to die of 'natural causes' like Lisa Swidler. Devra West's ex-daughter in

law, Kendal Haywood, was the subject of a lengthy and vicious campaign of occult 'under the radar' violence such that she sought psychiatric help believing that she was going mad. This was exactly the outcome Devra West intended because a court was not going to award her porn loving wife beating son, who had an FBI record for forgery, substance abuse and motor vehicle violations, custody unless they considered the mother to be a greater risk than her son. The plan worked perfectly and Kendall lost her infant daughter to West's son Chris Haywood in fact this playbook worked so well that Devra West and her son used it again a few years later after her son Chris Haywood's next marriage to Jamie Haywood broke down only on this occasion it did not work.

To come to the point, whether it is Devra West's mentor Robert Jaffe, Devra West herself, or John of God, all of these psychopaths used occult (hidden) knowledge to convince the sheeple (the spiritually confused) that they were 'divine' beings who could deliver miracles in the form of healing and or enlightenment. In reality, the sheeple were being herded into a cult so that psychopaths Jaffe, West and John of God could prey on them at their leisure knowing that fear of retribution in the form of occult 'under the radar' violence or fear of being murdered would keep the victims silent about the crimes committed against them.

To be clear, Robert Jaffe, Devra West and 'John of God' all regarded themselves as 'apex predators' because their use of occult (hidden knowledge) allowed them to operate above and beyond the reach of the law.



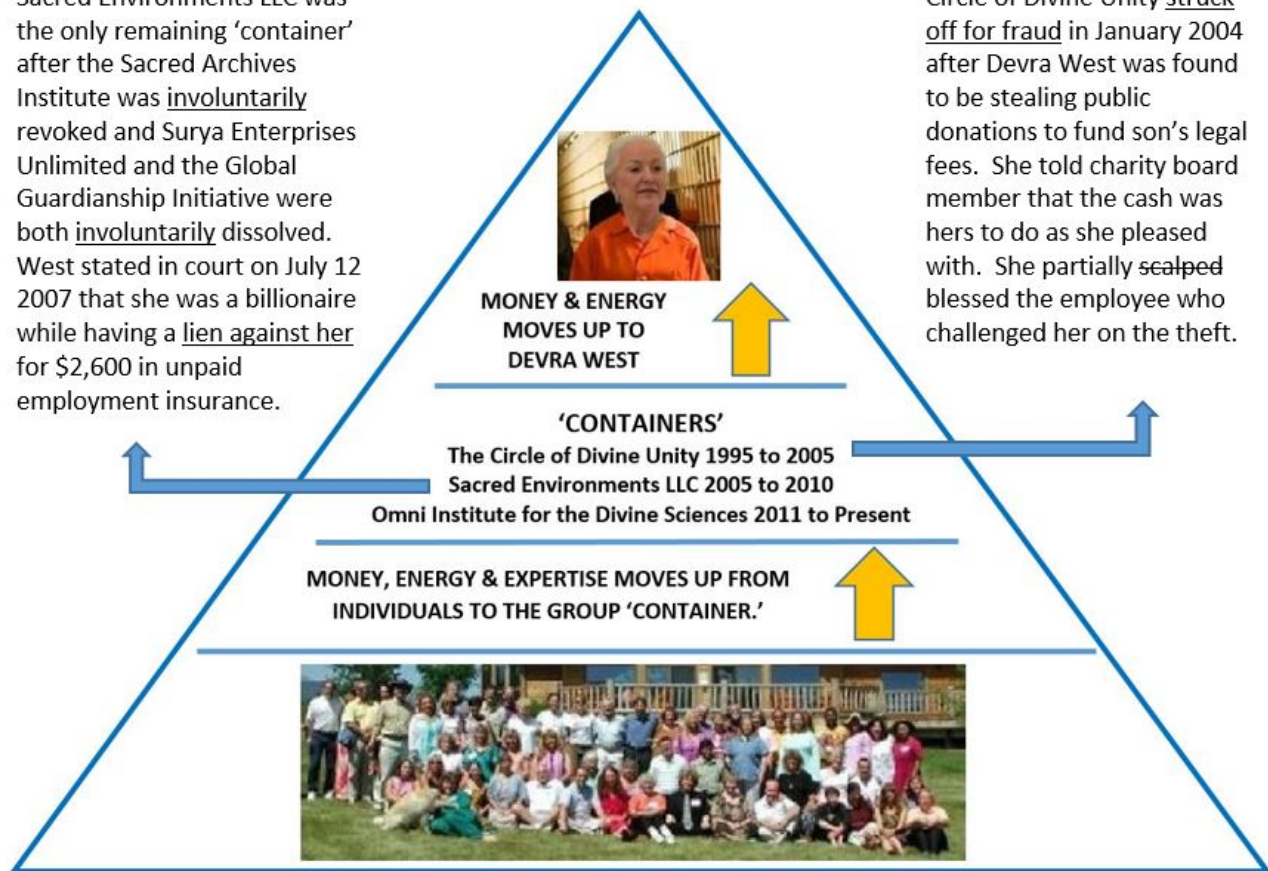
Above: Apex predators herd their victims into a small group (cult) and then harvest them as when they need nourishment. In Devra West's case 'nourishment comes in the form of total control over others' lives and the endless financial resources she is able to acquire in the form of donations AKA theft, fraud and extortion.

So how has Devra West's narcissistic psychopathy manifested itself since she declared herself to be an Ascended Master in 1991? We do not know much about her time in New Mexico other than what Jack West shared with the whistleblower in 2002 which was that people who opposed his then wife Devra West had a habit of dying suddenly and that they (Jack West, Devra West and their young daughter Anna West) were chased out of New Mexico in the middle of the night by one gun wielding victim who came to the obvious conclusion that the police could not help him stop the campaign of occult 'under the radar' violence being directed at him by Devra West.

What we do know about Devra West's criminal racketeering business model comes to us from the whistleblower John Watson and the scores of other victims and witnesses who have been the beneficiaries of Devra West's so called 'blessings' and 'mercy!' Amongst the latest claims are that she can deliver divine grace healings and dispense with past karma all for a large fee of course. The whole point of this charade is to convince spiritual seekers that she can deliver enlightenment to them in exchange for large fees and their total submission to her will. Let us look at the illustration below which shows the three 'containers' used in the last three iterations of her guru / cult / extortion business model.

Sacred Environments LLC was the only remaining 'container' after the Sacred Archives Institute was involuntarily revoked and Surya Enterprises Unlimited and the Global Guardianship Initiative were both involuntarily dissolved. West stated in court on July 12 2007 that she was a billionaire while having a lien against her for \$2,600 in unpaid employment insurance.

Circle of Divine Unity struck off for fraud in January 2004 after Devra West was found to be stealing public donations to fund son's legal fees. She told charity board member that the cash was hers to do as she pleased with. She partially scalped blessed the employee who challenged her on the theft.



Above: A schematic of Devra West's well-oiled criminal business model. With promises of enlightenment, the ability to deliver 'Divine Grace Healings and be able to dispense with past karma (all for a large fee) the spiritually confused flock to her feet like moths to a flame and often with the same result.

In reality, Devra West can deliver none of what she promises, nor would she if she could, as being a narcissist and card carrying Satanist her only two objectives are to bind and control people to her will and to relieve them of their wealth so as to fund her lavish lifestyle. In that regard, Devra West has to very distinct advantages over your average run of the mill criminal / serial killer.

1. Her lies, deceit and propaganda however ridiculous are all protected under 'religious freedom laws.' Put simply there is nothing to stop Devra West describing herself as being the Regent of the Spiritual Hierarchy of the Western Hemisphere and more senior in status than the Christ himself even if it is obvious from her actions that she is a vile despicable serpent and likely a serial killer. Nor does the concept of 'Mail & Wire' fraud apparently exist if you are masquerading as a quasi-religious figure which is why Devra West is inviting single donations of \$500,000 from her website; these donations based on her totally false life journey / bio and the her claims to be working for humanity.

2. The 'weapon' she uses to murder and intimidate her victims is not regarded as a weapon under legal statute, so Devra West can kill, maim, injure and intimidate victims and witnesses of theft, fraud and extortion to her heart's desire with little chance of ever being called to account for those crimes. This is why Geoffrey Reynolds rather casually announced to the [Bigfork Eagle](#) reporter that John Watson would

be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family.

Which brings me to the senior members of Devra West's cult / criminal racketeering business model, each of whom know that Devra West is probably a serial killer and in spite of this are willing accomplices in her criminal racketeering business model and why not she has been getting away with it for 27 years right under the authorities noses so what could possibly go wrong?

We looked at Reynolds and Williams' contribution to Devra West's criminal racketeering business model in the [previous bulletin](#). This week let us take a closer look at Jack West's role in his ex-wife's guru / cult / extortion business model.



Above left: Devra West sits on her throne lording over the sheeple. Above right: Jack West sits amongst the new intake gathering data on who amongst the flock are wealthy, who amongst the flock might be useful as envelope stuffers i.e. low paid or no paid slaves so that their energy can be used by Devra West to enrich herself.

Jack West is also used to counter the truth when Devra West's psychosis comes to the surface and she lashes out violently at one of the sheeple in her cult. In 2001, Devra West partially scalped employee Susannah Felder who challenged Devra West about the \$80,000 donation she stole from the charity, 'The Circle of Divine Unity,' (see above pyramid illustration) to pay her son's legal fees in a custody

battle. The following day, Jack West gave a totally false account of what occurred laying the blame for the assault squarely at the feet of the victim. In 2007, after Devra West viciously assaulted Dr. Pat Cole MD and after the whistleblower, John Watson, sued Devra West for fraud, Jack West posted a lengthy statement of denial about both events which can be read by [going here](#). The following illustration best describes her business model....



Above the class of 2002 when the 'container' was the charity 'The Circle of Divine Unity.' As per what she learned at the Robert Jaffe School for Energy Mastery between 1990 & 1991 people are herded into a personality cult with Devra West playing the role of 'divine being.' They are brainwashed and conditioned and after being separated from their wealth expelled from the cult with those remaining behind forbidden to contact the departed.

As further proof that Devra West is not a divine being, or even a guru but a narcissist occult thief / suspected serial killer, here are some further pieces of information to consider; bearing in mind most of the victims mentioned below, were featured in the photograph above which includes the whistleblower top left wearing the hat. 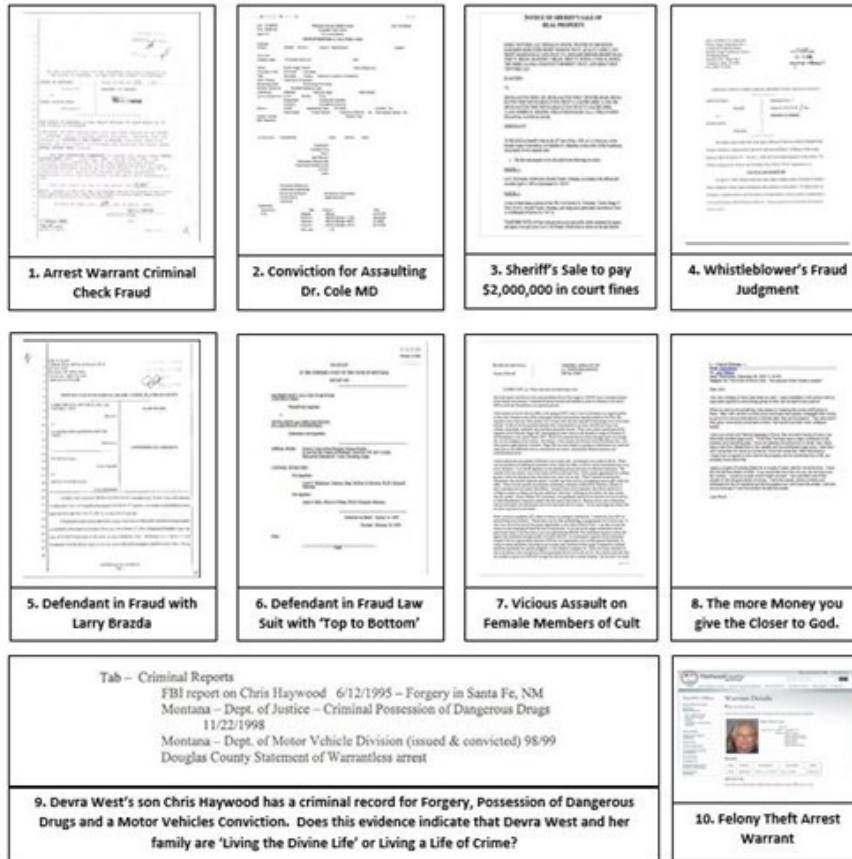

8. The Students who took out loans for Devra West after being told, "[They would be closer to God.](#)"
9. West's son's [criminal record](#). Like mother like son?

In light of the above facts, it must be obvious that Devra Patton West is at the very least, a compulsive liar, and at worst, a cold blooded killer who believes she is totally beyond the reach of the law and the justice system.

She knows that if any one contradicts or challenges her version of reality she has the ability, using occult knowledge, to intimidate or murder them into silence.

What have we learned about Devra Patton West?

It is clear from the information above that the narrative / propaganda about being a “ **blessing to all souls**” and “ **being an instrument of mercy**” is just that - propaganda put out as part of narcissist Devra Patton West’s delusions of grandeur. The Hollywood style production, paid for by millions of dollars acquired through 27 years of organized crime, include expensive websites, a palatial mansion, and an expensive and extensive wardrobe. Add to this a plethora of teeth-whitened and airbrushed staged photoshoots to show it all off to good effect to the target audiences in Sedona and Scottsdale AZ.

After drinking her own Kool Aide for 27 years and perhaps getting away with multiple murders, Devra West has begun to believe that she is a minor deity and therefore dresses accordingly. However, when paying one of her regular visits to court she always dresses down to give the impression that she is a harmless granny and not what she really is a vicious cold blooded killer.

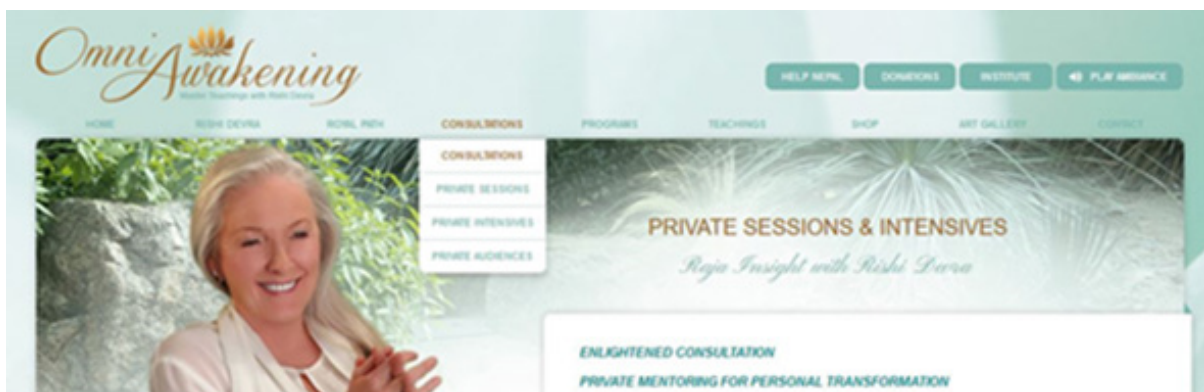
Remember, Devra Patton West, while attending the Robert Jaffe School for Energy Mastery between 1990 & 1991 acquired exactly the same occult knowledge that her mentor Robert Jaffe possessed. You may recall that he threatened to murder one of his ex-students because she later criticized her treatment while a student at his cult / school. Put simply, she uses her wealth to create a Hollywood style production, a compelling illusion, a trap into which wealthy spiritual seekers walk and then, with the help of Jack West who moves amongst the new intake, she sort out the wheat from the chaff and then proceeds to target them in the manner described below. In doing so she uses the same occult knowledge that she and her mentor use to murder and intimidate those who get in their way.

Here is how the latest con works:-

Step 1. Those identified as wealthy targets are invited to attend a **'Private' Sessions** or a **'Private' Intensive'** as advertised on her website below.



Step 2. Those targeted are duped / manipulated / pressured into believing one of the following two scenarios.

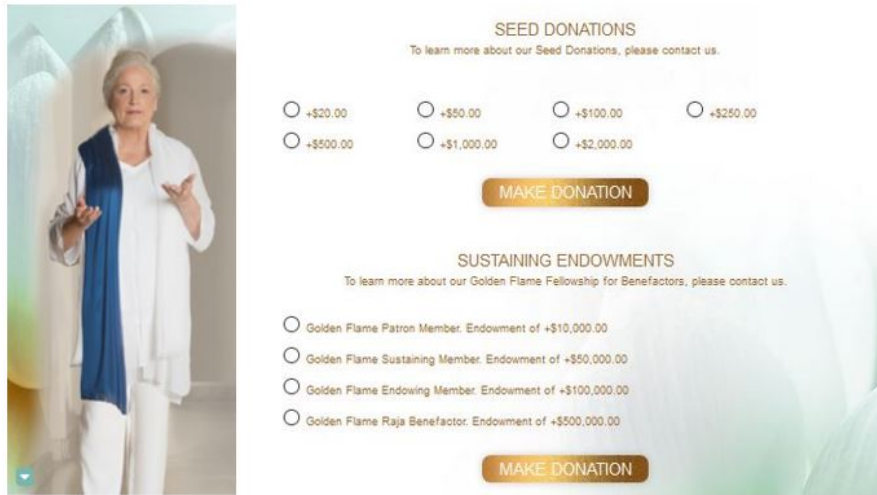
1. That they are suffering from a totally non-existent brain tumor or a cancer which Devra West guarantees she can cure for a large fee.
2. That Devra West and the targeted individual were sisters in a former lifetime during which the target is persuaded that she betrayed Devra West in that lifetime and must now, in this lifetime, make financial reparations (for the nonexistent wrongs the target committed).

Devra West has been perpetrating this extortion racket for at least two decades; two of her admin staff who worked for in 2002 overheard her say, after receiving a phone call, that she had just made \$500,000. Apparently, this was the fee paid by one victim who thought they had been cured of a condition that Devra West had in fact given them! Listen to [two of her admin staff](#), Diane Stoner and Kathleen Francisco talking about one this.

Remember, Devra West is an Occult Master who can, using Shamanic Visioning, induce illness, injury and even death in those she targets with little chance of the crimes being connected back to her. In the above scam, she 'induces' the symptoms in those who do not believe or do not pay and then miraculously cures them after they go to her 'Pay Portal' and make a large six figure 'donation.'

Step 3. The victims go to the Sage of Sedona's ['Pay Portal'](#) which is set up to receive single donations of up to \$500,000 or more by pressing a single button or a combination of buttons. In this way the target

receives an imaginary cure and in return [The Regent of the Spiritual Hierarchy of the Western Hemisphere](#) gets to empty the targets bank account into hers. Note her standing there with her hands out saying “give me, give me.”



This has been going on for 27 years right under the noses of the FBI and the IRS. It is illegal for a lay person to assert that they are able to cure someone of a health condition. Apparently not so for Devra West! At \$500,000 a go, it is no wonder she can afford the trappings, clothing, lifestyle and home of a multi-millionaire even though she claims to be penniless and the funds she extorts from victims are nowhere to be seen, let alone declared to the IRS as income in her tax returns.
