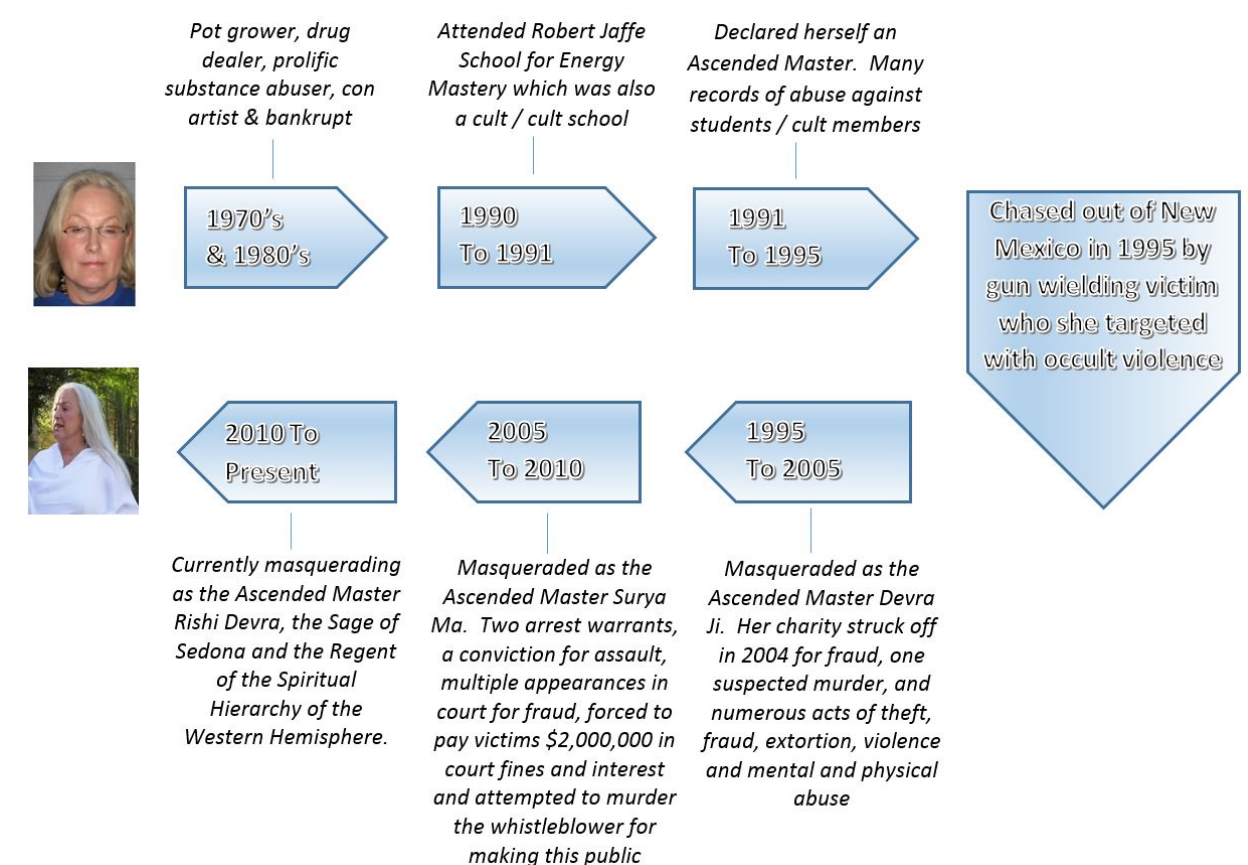
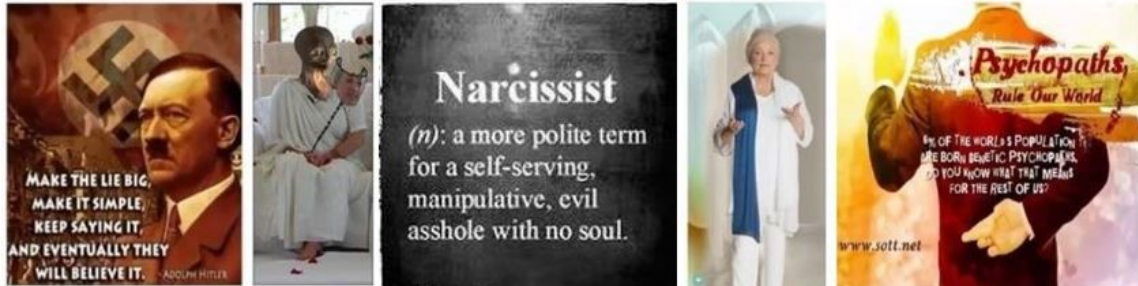


Subject: Rishi Devra – The evolution of a small time crook and con artist Devra Patton West to narcissist serial killer and planetary regent!

## Rishi Devra AKA Devra Patton West – The evolution of drug dealer, small time crook and con artist to narcissist, suspected serial killer and planetary regent!



We know certain facts about what Devra Patton West and her then husband, Jack West, were doing prior to 1990. We know from witness [Jeremy Samuelsson](#) that Devra and Jack West were both small time con artists defrauding individual victims out of several thousands of dollars at a time. Jeremy was defrauded out of \$10,000 by the couple. We know from another victim, Satya who attended [The Robert Jaffe School for Energy Mastery](#) in 1990 to 1991 with Devra West, that she too was defrauded out of \$6,000 by Devra West. We also know that [Satya](#) described Devra West as a deeply troubled

psychopathic person/personality. We also know that prior to 1990, both Jack & Devra West were pot growers, drug dealers and that Devra West's only business venture went bankrupt. At some point, Devra West decided to leverage her criminal tendencies by combining her prolific substance abuse and ventures into altered states of reality. Accordingly, she enrolled in a course of training at [The Robert Jaffe School for Energy Mastery](#) mentioned above. Upon completing her training in 1991, Devra West declared herself to be an Ascended Master and that anyone not agreeing was 'blocking the energies.'

Let us now go to the [Cult Education Institute](#) which is a website dedicated to giving the public information about cults and sharing the experiences of those who survived / escaped from cults.



*I arranged for a telephone session with someone trained by Dr. Robert (Ibrahim) Jaffe. Just as my friend said, the session was very deep. Frankly it was too deep. I felt rather traumatized by the emotional places this healer, a medical doctor, took me to. [Is this why Devra West has Dr. Julio Williams MD as a senior member of her cult?] Which set me up to feel a need for more sessions.*

*In the group we were urged to adopt Islam as our religion. I took that seriously and set about learning the five-times-a-day prayers, etc. I became extremely straight-laced and wore a scarf on my head as much as possible, since I was told I needed to protect against astral beings. On top of following Islamic practices, we were given a number of Sufi practices, such as chanting in Arabic thousands of times each morning and evening. It was quite time-consuming. And we were often asked to participate in costly events and give sizable donations to the group. [Ex-members of Devra West's cult will know this happened regularly to them.]*

*We were told that all sorts of things were "against God". Things like Reiki healing, which I had been involved in for some years. Over time I would learn that homosexuality and eastern religions were also "against God". By then, I had become quite disgusted with all that was being asked of me and I wrote an email to Dr. Jaffe announcing that I was leaving the path.*

*Jaffe responded months later and threatened that I could become sick and die from something like cancer for leaving. That did not happen. Instead, I discovered some years later that Jaffe's own wife got ill with cancer and died from it. [Ex-members of West's cult who went public will know about sudden deaths and threats of murder.]*

And this....

*That is some heavy stuff. Just from the text above, it appears they are using "modern" methods of indoctrination, with very "ancient" ones, like animal blood sacrifice? [New members of West's cult are immediately brainwashed and conditioned into submitting to her will.] I guess those guys in the Middle East learned they can generate some serious cash from the west. Who knows where that money is going and what it is being used for?*

*I once knew a girl who worked in the office for one of these spiritual groups that "healed" people. After a few years she quit in disgust. She was a smart girl, and she realized that the people in the clinic were dying at the same rate as anyone else with those diseases. There was NO EFFECT. The fake "doctor" at the New Age healing clinic knew that as well. [Devra West uses PhD & D. D. two fake doctorates that she said the Christ awarded her in person.] He knew they were dying like flies on a daily basis. But hey, making \$500,000+ a year in income is pretty tempting. [Devra West was charging \$500,000 per single fake 'healing' in 2002.] Too bad the money is coming from desperate, wonderful people who don't want to die, who are willing to sell their homes on any bogus New Wage treatment that promises them a healing. Then, after their death, their family is left with nothing.*

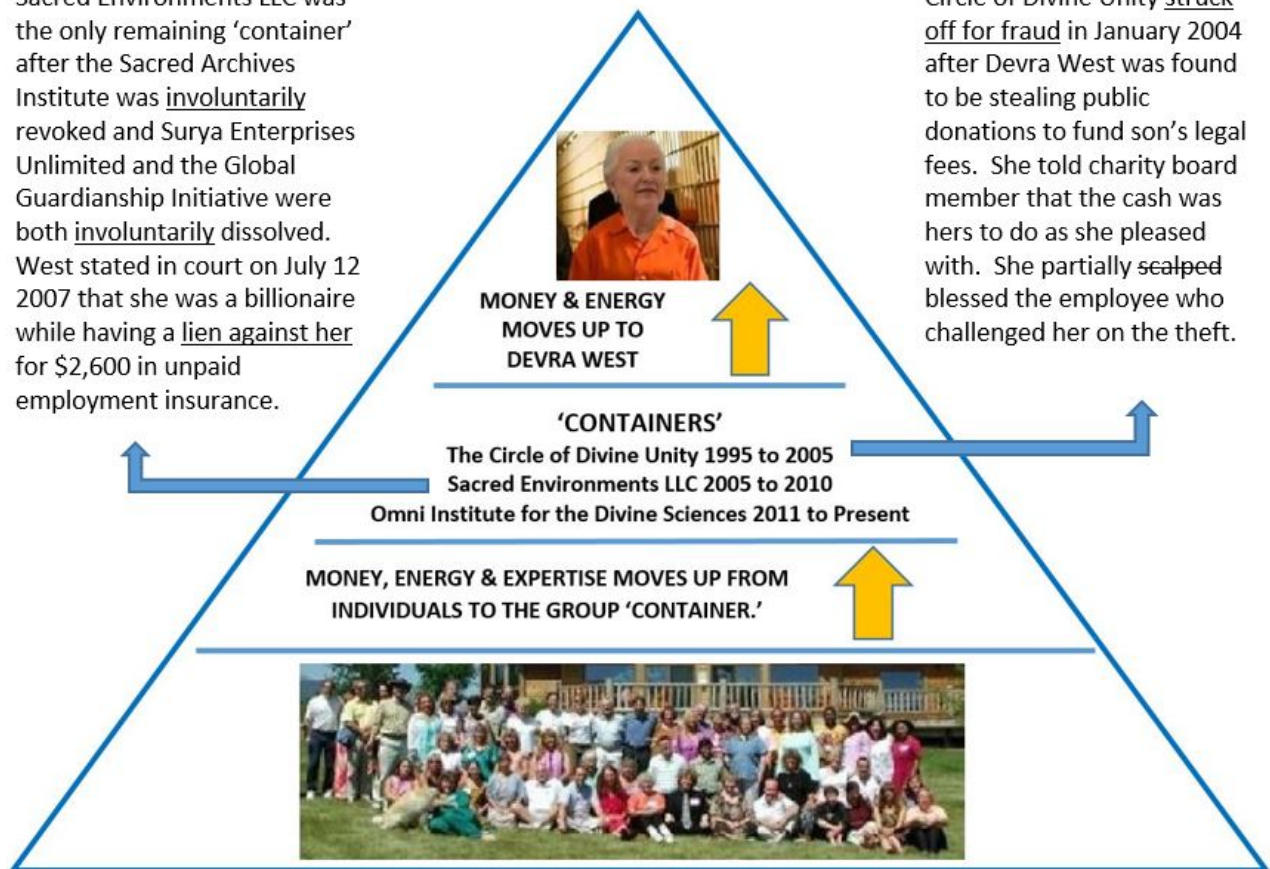
Only the most ruthless and sociopathic stay in that business for years. [As you will see Devra West is a dangerous psychopath / suspected serial killer masquerading as a guru.] If you are a decent person, after a few years at most, you realize you are exploiting dying people, and you quit, your conscience can't take it. So the ones who keep doing it for years, know it doesn't work due to the death stats, but the money is just too good.

**It is clear that Devra Patton West's criminal racketeering business model is based on what she learned at the 'Robert Jaffe School for Energy Mastery' between 1990 & 1991.**

Let us look at the illustration below, which shows the three 'containers' used in the last three iterations of her guru / cult / extortion business model between 1991 to present day.

Sacred Environments LLC was the only remaining 'container' after the Sacred Archives Institute was involuntarily revoked and Surya Enterprises Unlimited and the Global Guardianship Initiative were both involuntarily dissolved. West stated in court on July 12 2007 that she was a billionaire while having a lien against her for \$2,600 in unpaid employment insurance.

Circle of Divine Unity struck off for fraud in January 2004 after Devra West was found to be stealing public donations to fund son's legal fees. She told charity board member that the cash was hers to do as she pleased with. She partially scalped blessed the employee who challenged her on the theft.



Above: A schematic of Devra West's well-oiled criminal business model. With promises of enlightenment, the ability to deliver 'Divine Grace Healings and be able to dispense with past karma (all for a large fee) the spiritually confused flock to her feet like moths to a flame and often with the same result.

In reality, Devra West can deliver none of what she promises, nor would she if she could, as being a narcissist and card carrying Satanist her only two objectives are to bind and control people to her will and to relieve them of their wealth so as to fund her lavish lifestyle.



## IT'S ALL ABOUT THE MONEY



**Devra West has two very distinct advantages over your average run of the mill criminal / serial killer.**

**1.** Her lies, deceit and propaganda, however ridiculous, are all protected under 'religious freedom laws.' Put simply there is nothing to stop Devra West describing herself as being the Regent of the Spiritual Hierarchy of the Western Hemisphere and more senior in status than the Christ himself even if it is obvious from her actions that she is a vile despicable serpent and likely a serial killer. Nor does the concept of 'Mail & Wire' fraud apparently exist if you are masquerading as a quasi-religious figure which is why Devra West is inviting single donations of \$500,000 from her website; these donations based on her totally false life journey / bio and the her claims to be working for humanity.

**2.** The 'weapon' she uses to murder and intimidate her victims is not regarded as a weapon under legal statute, so Devra West can kill, maim, injure and intimidate victims and witnesses of theft, fraud and extortion to her heart's desire with little chance of ever being called to account for those crimes. This is why Geoffrey Reynolds rather casually announced to the [Bigfork Eagle](#) reporter that John Watson would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family.

**Devra Patton West maintains that she was called to 'World Service' at age seven! This propaganda piece can be reviewed on her website by following the link to a tab entitled '[Rishi's History.](#)' It is all lies but all allowed under religious freedom laws!**



**Her Dedication to the Great Masters...** She received her first spiritual initiation at the age of seven, being spontaneously flooded with wave after wave of light, future prophecy and revelation of her life purpose. The presence of the Great Masters, flooded her with divine illumination for many months thereafter, during which time she received her "call to serve the world."

**Below is a summary of her dedication to organized crime and some examples of Devra West's ACTUAL "World Service" as delivered to scores of victims in Montana.**



Suspected murder of student Lisa Swidler in 2005; defrauded student Dave Kushner out of \$30,000; kidnapped, falsely imprisoned and beat student Marion Cantwell before extorting tens of thousands of dollars from her - both incidents in 2005. Was convicted of assaulting Dr. Pat Cole MD in 2008; the subject of a Sheriff's Sale to force her to pay past victims of crime \$2,000,000 in court fines and interest in 2008. Several visits to court in Montana as the defendant in fraud related lawsuits including one John Watson the whistleblower won in 2008. Two arrest warrants one for criminal check fraud and one for felony theft in 2008 and 2009 respectively.

Devra West's many appearances in Montana courts as the defendant in fraud related lawsuits, her two arrest warrants (one for [criminal check fraud](#) and one for [felony theft](#)), her [conviction for assault](#), the forced sale of her assets at a [Sheriff's Sale](#) to make her pay her creditors \$2,000,000 in court fines and interest resulted in no one believing the 'divine being' routine which was at the core of her criminal business model. The last straw, making it obvious to all that Devra West was at the head of a criminal cult / gang, came when three very negative articles were published in the [Whitefish Pilot](#), the [Bigfork Eagle](#) and the [Ravalli Republic](#) newspapers.

Amongst the latest claims are that she can deliver 'Divine Grace Healings' and 'Dispensation of past Karma' all for a large fee, of course. The whole point of this charade is to convince spiritual seekers that she can deliver enlightenment to them in exchange for large fees and their total submission to her will.

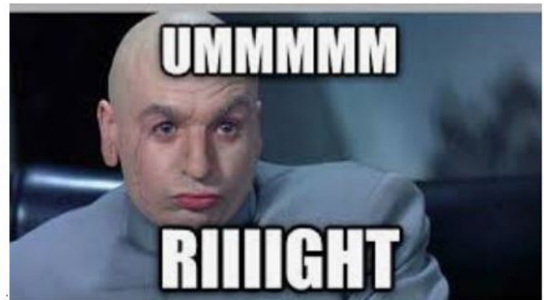

4. She is able to deliver ‘karmic resolution of divine dispensation.’

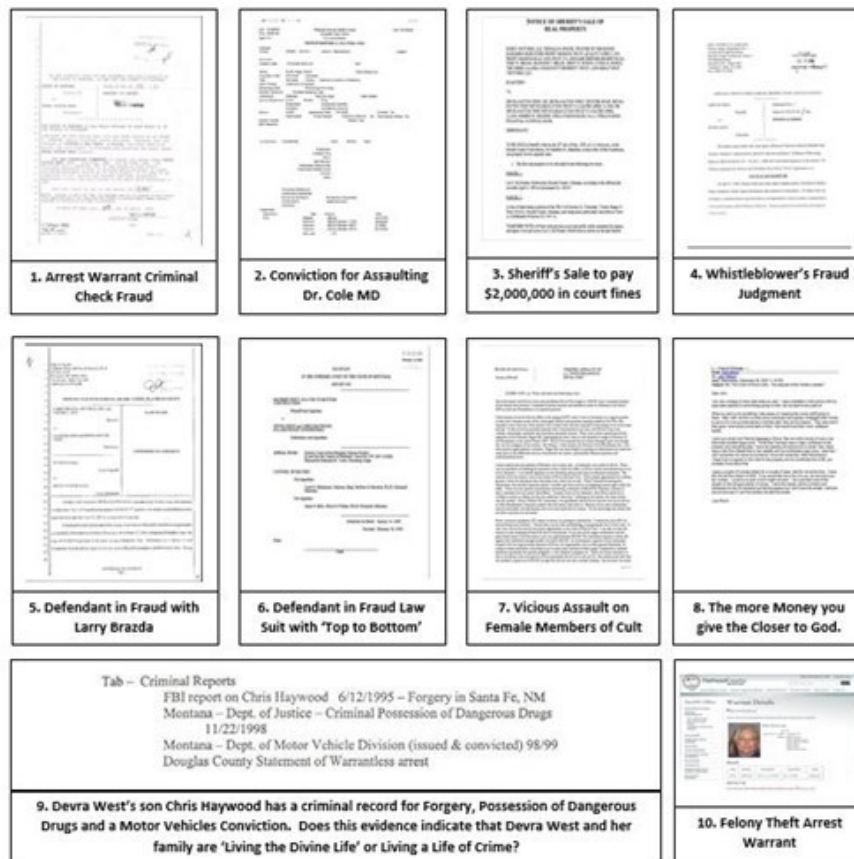

**When Devra West has worn out her welcome she, and the senior members of her cult / criminal gang, just move to another western state and spend some of the millions of dollars acquired through organized crime since 1991 to create yet another totally false identity.**

**THE MOVE TO ARIZONA.** However, before she could reincarnate herself anew, Devra Patton West and her accomplices had to silence the whistleblower and force his website off the internet. Victims tend not to walk into a trap if they know it is there and for her 'divine being' routine to work in Arizona and be believed she had to remove all evidence of her past criminality from the internet. The following paragraphs without a doubt demonstrate that Devra Patton West was / is coordinating the actions of the senior members of her cult / gang to act against the whistleblower John Watson.

**THE ATTEMPTED MURDER OF THE WHISTLEBLOWER.** As mentioned at length in previous bulletins, the whistleblower John Watson was one of scores of victims of theft, fraud and extortion at Devra West's hands he being defrauded by her in 2002. After he announced he was going to sue Devra West for fraud in March 2003, she promised to get so f\*\*king down and dirty with huge expenses coming out of his pocket and not hers. Good to her word, the dirty tricks started in 2005 when he was met with a [defamatory statement](#) that was posted on Devra West's website, authored by cult member Julio Williams MD and others. He also became the subject of false witness statements that Devra West forced her employees to manufacture that she intended to use in court against him. Her employees were forced to 'manufacture these false statements on pain of being fired from their jobs if they did not comply. One such statement, later retracted, was from student / employee [Anandra George](#).

In December 2006, both John Watson and his wife and children became the victims of a sustained and vicious campaign of occult 'under the radar' violence at the hands of Devra West clearly intended to intimidate John Watson into dropping his lawsuit against Devra West. She obviously learned how to use this occult knowledge against individuals at the Robert Jaffe School for Energy Mastery between 1990 & 1991. She obviously believes that possessing this information makes her a minor deity!

In January 2007, senior cult member Dr. Julio Williams sent John Watson a [threatening email](#) telling the whistleblower not to f\*ck with him and promising to give Devra West \$2,000,000 for her legal fees. On August 9 2007, while being interviewed by the [Bigfork Eagle](#) newspaper senior cult member and 'liar for hire' [Geoffrey Reynolds CPA](#) told the reporter, Constance See (in what he thought was an 'off the record conversation) that John Watson would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family. Several days later Devra West made an unsuccessful attempt to murder the whistleblower.

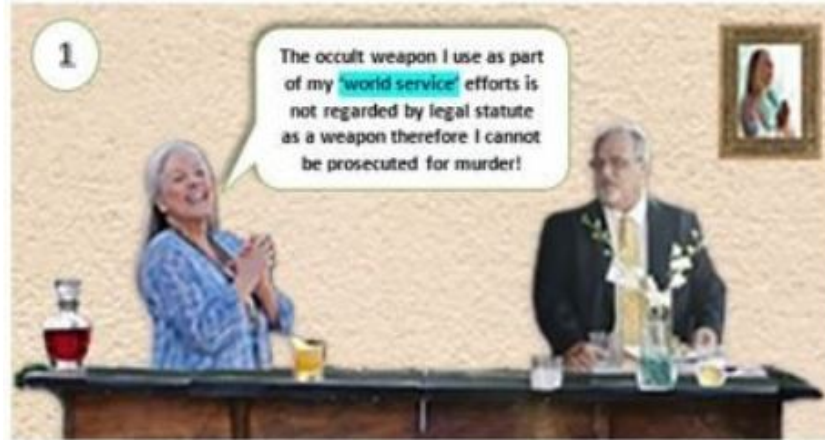

From the statement made by Reynolds we can infer two things.

- 1.** That Geoffrey Reynolds had been briefed by Devra West on her ability to use occult knowledge to commit murder indeed she may have shared details of other victims that she had successfully killed such as the murder of Lisa Swidler just two years earlier in 2005.
- 2.** It was apparent from the 'matter of fact' way that Reynolds shared the information with the reporter that he not only believed that John Watson was going to be murdered by Devra West, but that he was quite comfortable being complicit in his murder.

Geoffrey Reynolds CPA has since tried to leave the cult and his past behind. Reynolds believes that there will be no consequences for being complicit in the failed murder attempt and subsequent attempt to bankrupt the whistleblower. Reynolds believes that the [totally false statements](#) he made to a Montana court in 2010 will not come back to bite him.

Reynolds is currently working for Olympia accountants [McSwain & Co](#) though since these bulletins have started appearing, Reynolds' resume on the firm's website has been 'sanitized to remove all mention of Reynolds' time with the cult between 2006 & 2014, and more recently his photo has been removed from the website.

A total stranger to the whistleblower John Watson but complicit in Devra West's plot to murder him in 2007 and when that failed Reynolds agreed to 'front' Devra Patton West's conspiracy to bankrupt the whistleblower so that his website's would be forced down off the internet. With no information to contradict her claims to being a divine being Devra West was free to reincarnate herself in Cave Creek AZ in 2011.*

More recently to counter the TRUTH about West's past that is in these bulletins and on this website, Devra West ordered senior cult member Dr. Julio Williams to post a dishonest, deceitful propaganda piece alleging that the injunction that she 'bought' to silence the whistleblower came about as the result of a judge "investigating a cyber-extortion scam" against her! The purpose of cult member Dr. Julio Williams' hatchet piece was to try to persuade the public (and the members of her current cult) to ignore any information about Devra Patton West's past criminality; the logic being that they were not supposed to have access to that information!

What Dr. Julio Williams also fails to mention is that he is in receipt of 300 plus emails sent to him by the whistleblower over the past few years, which sets out a clear 'paper trail' of the occult 'under the radar' violence directed at him and his family DAILY by Devra West. This campaign of violence (West's secret weapon) started in December 2006, and has continued to this day some 13 years later. Why has Julio Williams not shared these emails with the police or the FBI? The truth is that Williams, like Geoffrey Reynolds, hopes that West might yet be successful in murdering the whistleblower. As for the occult, Dr. Williams grew up in the Dominican Republic where one of the official religions is voodoo. Is it any wonder that Williams has been a 'student' of Devra West's since the year 2000?

Yet more corroborating evidence of Julio Williams' collusion in organized crime and murder.



*Above left: Dr. Julio Williams a senior member of Devra West's cult / criminal racketeering gang getting a 'blessing' from his Satanist cult leader. Above center and right: Williams in his day job posing as a respectable physician his patients unaware that he is a co-conspirator in scores of criminal acts including perhaps several murders.*

We can get the measure of 'liar for hire' and co-conspirator Dr. Julio Williams MD, a student at Devra West's school for the occult studies, by comparing his words with his deeds. In 2005 Williams, at Devra

West's request, posted a [defamatory statement](#) about the whistleblower on Devra West's website. This occurred (shortly after the whistleblower announced he was suing Devra West for fraud) in the statement Williams made the following comment.



**I, Julio Williams MD have been a long time student of Surya Ma (now calling herself the Ascended Master Rishi Devra) and I stake my honor and credibility on defending her personal integrity and establishing the truth.**

Statement by Dr. Julio Williams posted on Devra West's website March 23 2005.

Fourteen years later, and after Devra Patton West has been the recipient of two arrest warrants, a conviction for assault, was forced to sell her assets at a [Sheriff's Sale](#) to pay past victims of crime \$2,000,000 in court fines and interest and after scores of acts of mental and physical abuse listed above it is clear that Dr. Julio Williams has no integrity or honor. It is clear that Dr. Julio Williams MD, like Geoffrey Reynolds CPA, is a fully willing accomplice in organized crime and the multiple murders committed by Devra West.

If Devra West is not a "blessing to all souls" and is not an "instrument of mercy" what is she?

**We maintain that Devra Patton West has always had criminal tendencies but after attending the Robert Jaffe School for Energy Mastery and acquiring occult knowledge she became a 'cold blooded killer' who has operated for the past 27 years in three western states.**

Here is an excerpt of Devra West's statement to the [Whitefish Pilot](#) newspaper.

*An author and speaker, West claims she recognized her clairvoyant and healing gifts at age six when she began "interacting and communicating with archangel Michael," according to her book "The Christ Heart." West claims to have **been trained in shamanic visioning and healing** by Native American elders and to have been both a Cheyenne medicine woman and General George Patton in past lives. She also claims her "gifts" can heal people with various illnesses, including leukemia, and she plans to teach what she knows to **cardiologists and other physicians** when her plan for healing spas unfolds. "If you ever saw me heal, you'd be down on your knees crying like a friggin' baby," West said.*

It is clear that there are many similarities between the behavior that victims experienced while attending The Robert Jaffe School for Energy Mastery (and subsequently shared with the [Cult Education Institute](#)) and what Devra West has inflicted upon those inside her own cult since then.

In doing so, she uses the same occult knowledge that she and her mentor use to murder and intimidate those who get in their way.

**To be clear, Robert Jaffe, Devra West and 'John of God' all regarded themselves as 'apex predators' because their use of occult (hidden knowledge) allowed them to operate above and beyond the reach of the law.**

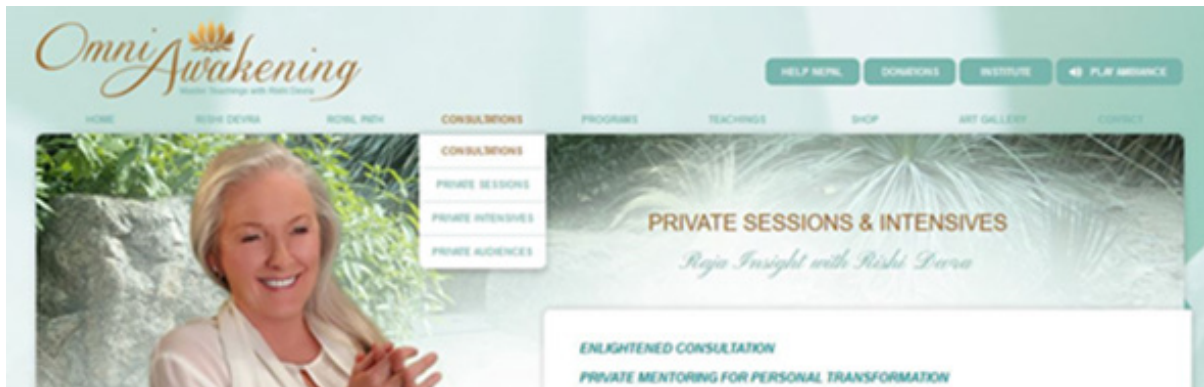

Here is how the latest con works:-

**Step 1.** Those identified as wealthy targets are invited to attend a **'Private' Sessions** or a **'Private' Intensive'** as advertised on her website below.



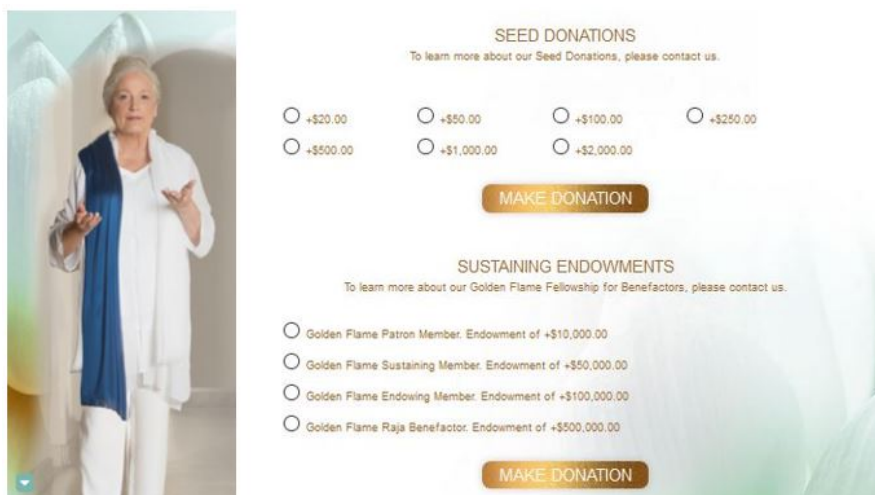
**Step 2.** Those targeted are duped / manipulated / pressured into believing one of the following two scenarios.

1. That they are suffering from a totally non-existent brain tumor or a cancer which Devra West guarantees she can cure for a large fee.
2. That Devra West and the targeted individual were sisters in a former lifetime during which the target is persuaded that she betrayed Devra West in that lifetime and must now, in this lifetime, make financial reparations (for the nonexistent wrongs the target committed).

Devra West has been perpetrating this extortion racket for at least two decades; two of her admin staff who worked for in 2002 overheard her say, after receiving a phone call, that she had just made \$500,000. Apparently, this was the fee paid by one victim who thought they had been cured of a condition that Devra West had in fact given them! Listen to [two of her admin staff](#), Diane Stoner and Kathleen Francisco talking about one this.

**Remember, Devra West is an Occult Master who can, using Shamanic Visioning, induce illness, injury and even death in those she targets with little chance of the crimes being connected back to her. In the above scam, she ‘induces’ the symptoms in those who do not believe or do not pay and then miraculously cures them after they go to her ‘Pay Portal’ and make a large six figure ‘donation.’**

**Step 3.** The victims go to the Sage of Sedona’s [‘Pay Portal’](#) which is set up to receive single donations of up to \$500,000 or more by pressing a single button or a combination of buttons. In this way the target receives an imaginary cure and in return [The Regent of the Spiritual Hierarchy of the Western Hemisphere](#) gets to empty the targets bank account into hers. Note her standing there with her hands out saying “give me, give me.”



This has been going on for 27 years right under the noses of the FBI and the IRS. It is illegal for a lay person to assert that they are able to cure someone of a health condition. Apparently not so for Devra West! At \$500,000 a go, it is no wonder she can afford the trappings, clothing, lifestyle and home of a multi-millionaire even though she claims to be penniless and the funds she extorts from victims are nowhere to be seen, let alone declared to the IRS as income in her tax returns.
