## Essentia Health Welcomes Dr. Julio Williams

Dr. Julio Williams, a cardiothoracic surgeon, has joined the Essentia Health-32nd Avenue Clinic in Fargo, North Dakota.

"I've known I wanted to be a cardiothoracic surgeon from a very young age, and I've always been fascinated by the heart and its ability to sustain the rest of the body by itself," says Dr. Williams. "The treatment I provide can have long-lasting positive effects for patients who otherwise may have a very poor quality of life and/or life expectancy, and that is very rewarding to me as a physician."



It is unlikely when interviewed for the position at Essentia Health, that Dr. Williams declared that he was a senior member of a cult / criminal gang whose leader, Devra Patton West, is suspected of at least one murder, at least one attempted murder and numerous counts of theft, fraud, extortion and violent assaults. It is unlikely that he declared to his employers that he too was guilty of funding organized crime, witness tampering and failing to report serious crimes to the police being committed right under his nose.

It is not known whether Dr. Julio Williams MD still has an association with Hendrick Medical centre but it is clear that at one time he was associated with that medical facility.

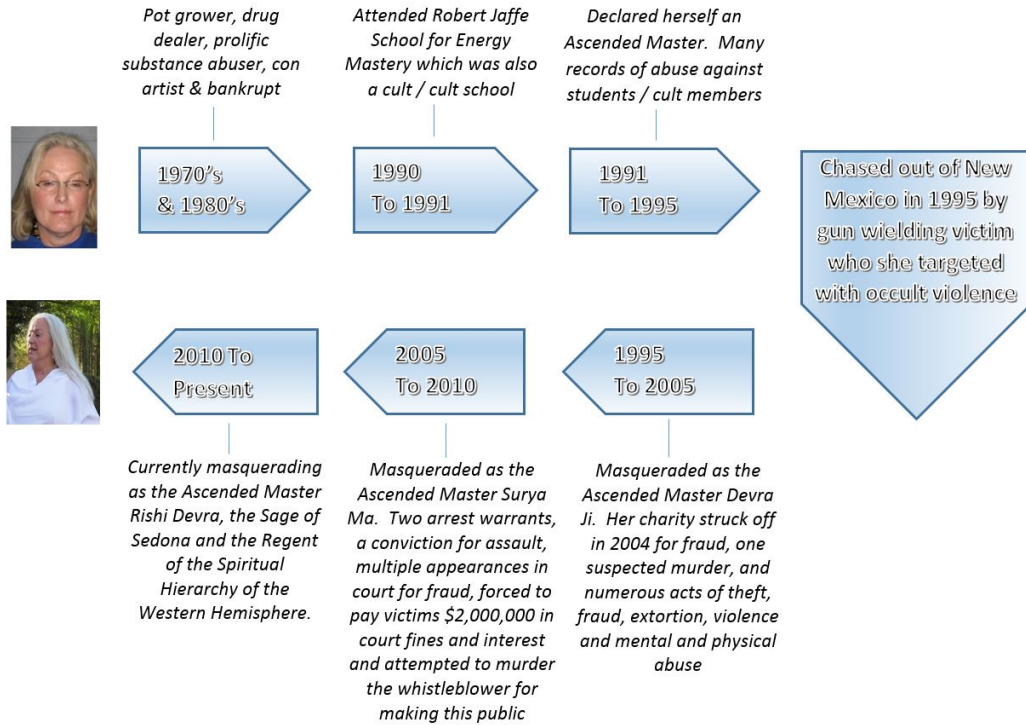

Before we get into irrefutable documentary evidence that Dr. Julio Williams MD is part of a cult / criminal racketeering gang and that he is fully aware of the serious crimes being carried out by Devra Patton West, which includes murder and attempted murder, some history about Devra Patton West and her cult would be helpful to give the reader context. If we look into Devra West's past we see that prior to acquiring occult (hidden) knowledge in the early 1990's, she was already a common criminal operating pretty much outside the law. As witness / victim Jeremy Samuelson relates, in the [statement](#) he sent the whistleblower John Watson in 2007, Devra West and her husband, Jack West, were pot growers / drug dealers who had defrauded him out of \$10,000. In 1991 Devra West defrauded [Satya](#), a classmate of hers at the 'energy mastery' school, out of \$6000. In other words, West's desire to manipulate, rob, defraud and extort money from others was already ingrained in her before she decided to announce her ascendancy to the status of an Ascended Master.



As a consequence of acquiring occult (hidden) knowledge while attending [The Robert Jaffe School for Energy Mastery](#) between 1990 & 1991, Devra West achieved two important objectives.

1. As a narcissist who thought she was superior to everyone else, Devra West now had some tricks up her sleeve which she could use to convince spiritual seekers that she was a 'divine being,' a Master Teacher to be worshipped and obeyed.
2. After acquiring a certain level of skill at Shamanic visioning, she was able to exponentially leverage her criminal tendencies. She could do this because the Shamanic skills she had acquired could be used as a weapon to manipulate the sheeple (spiritually confused persons who cannot tell a devil from an angel) into doing her bidding. It could also be used to facilitate theft, fraud, extortion and to intimidate victims and witnesses into silence, or murder her victims and witnesses, all with plausible deniability. The first link leads to a bulletin that explains how she uses the occult to intimidate victims and witnesses and murder those who challenge her. The other is a link to her Brazilian counterpart 'John of God', who was recently arrested for child sex trafficking and a range of other offenses. Note when reading the article his use of the occult at the time of his arrest. No wonder victims were afraid to come forward until after he had been arrested. I suspect the same will be true of Devra Patton West.

Dr. Julio Williams grew up in the Dominican Republic where Voodoo is one of the recognized religions. Perhaps this is why in the year 2000 he joined Devra West's 'Sacred Arts Institute,' an unaccredited school for occult studies. To be a member of that school, one has to 'surrender' to the will of Devra Patton West and become a member of her cult / criminal gang. Given his status as a physician / thoracic surgeon, Williams was of great public relations value to West, as were the large financial donations he made to her which included a \$100,000 donation in 2007 alone.

**To come to the point, Devra Patton West was never a guru but was always a criminal. A criminal who masqueraded as a guru because, as the head of a quasi-religious organization, she could lie, fabricate and deceive members of the public while claiming protection of 'religious freedom' laws.**

After leaving [The Robert Jaffe School for Energy Mastery](#) in 1991, Devra Patton West declared herself to be an Ascended Master and set up a personality cult around herself. Not much is known about her time in New Mexico between 1991 & 1995, although [documents handed to the Flathead Police department](#) in 2007 by Dr. Pat Cole MD, allude to the fact that many of her students and employees were mentally and physically abused. In 1995 Devra Patton West, her husband Jack West and their young daughter Anna West, were chased out of the state in the middle of the night by one gun wielding victim who realized that the police would be unable to help him (or anyone else for that matter).

**Upon arriving in Victor MT in 1995, Devra Patton West announced herself to be the Ascended Master Devra Ji and proceeded to build a personality cult around herself there, which included recruiting Dr. Julio Williams MD.**

After nine years of constant fundraising to save the world, her charity was struck off for fraud in January 2004. Facing bankruptcy for the second time, Devra West announced to her mailing list that the difficult time that she was going through were entirely related to her move from the [fifth dimension to the seventh dimension](#). She further stated that she was moving to Shamballa and that she could only take 12 disciples and only those who were prepared to [commit 66% of their net worth](#) to her good causes (herself). In reality, Devra West moved from Victor MT to Flathead Lake MT some 100 miles north. Upon arriving in Flathead Lake MT, Devra West changed her name again; this time to the Ascended Master Surya Ma.



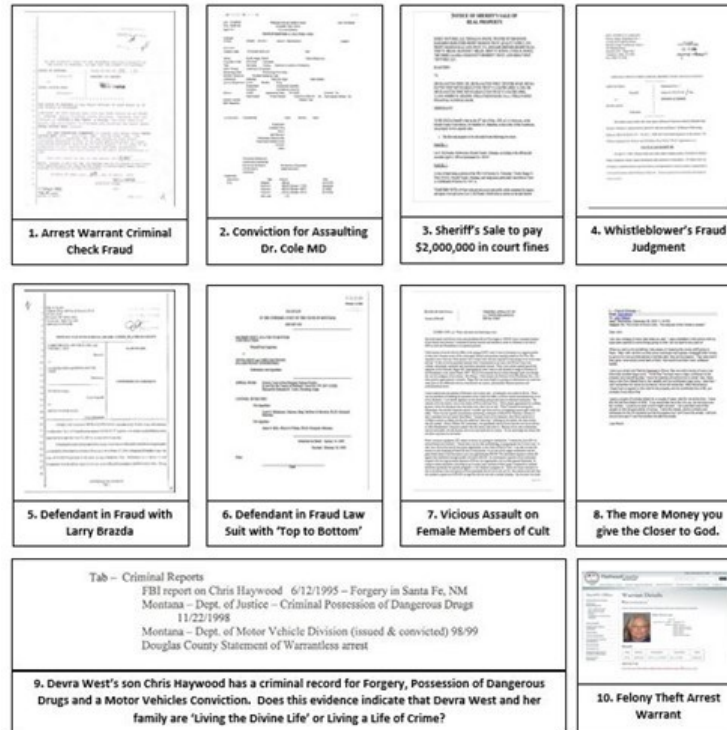

Having established beyond reasonable doubt that Devra Patton West is not a guru but a dangerous psychopath sitting at the head of cult / criminal gang, I would like to lay out Dr. Williams' role in aiding and abetting Devra Patton West's criminality in two well documented crimes. The main crime featured in this bulletin was against John Watson, who was defrauded by Devra Patton West in 2002. The other crime was against Dr. Pat Cole MD, who was viciously assaulted by Devra Patton West in 2006 as part of a campaign to extort \$1.3 million from the victim. Dr. Julio Williams' actions in defense of his cult leader included the following:-

**1. Defamation.** Julio Williams intervened in a legal dispute between a total stranger and the leader of his cult because the stranger had launched a fraud lawsuit against the leader of his cult. At Devra Patton West's request, Dr. Julio Williams MD published [a defamatory statement](#) about John Watson on Devra West's website in 2005. In 2007 Julio Williams would publish two further statements on West's website this time denying that West had assaulted Dr. Cole and vilifying the victim – a fellow physician!

**2. Witness Tampering.** In 2007 Dr. Julio Williams [threatened John Watson by email](#). John Watson was the plaintiff in a lawsuit who had justifiably gone to law after the defendant Devra Patton West had defrauded him. The clear objective of Dr. Julio Williams MD in sending that email was to intimidate the victim into withdrawing his lawsuits against Devra West; the leader of his cult. The victim won his lawsuit in 2008. **3. Funding Organized Crime.** In 2007, while Devra West was committing half a dozen crimes in the Flathead Lake area of MT, Julio Williams gave West \$100,000 so that she could finance some of those crimes. **4. Failing to report an ongoing campaign of intimidation and attempted murder to the police.** Dr. Julio Williams MD has received some 400 emails over the past 3 to 4 years detailing the [ongoing campaign of intimidation](#) being directed at John Watson and his family by Devra Patton West. He refuses to pass these emails on to the police because doing so will implicate himself in attempted murder and racketeering.

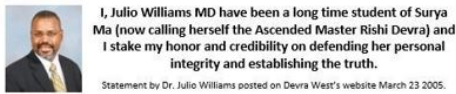

### Spiritual guru pleads guilty in assault

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.

Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.

After entering her plea, Devra West was sentenced to

a six-month deferred jail term and fined \$500.

Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.

Justice of the Peace David Ortlej issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.

West's trial was postponed

from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.

West's trial originally was scheduled for April 2007.

Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.

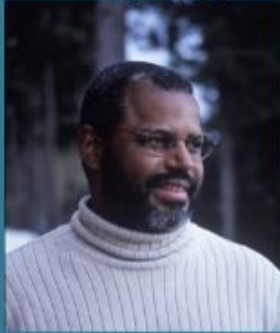

## Biography



### Julio Williams, MD

A gifted cardiothoracic surgeon, Doctor Williams graduated Cum-Laude from Madre & Maestra Catholic University in the Dominican Republic. During his training as a medical student, his rotations for "social medicine" involved treating the poor and disadvantaged in the city slums and the Sierra Mountains of the Caribbean Islands, and as a result he felt drawn to the holistic concept of medicine.

"Because economic and cultural influences were so obviously at play, I could not help but view the patients not only as the disease process they exhibited, but also from the holistic causative stand point: the Bio-Psycho-Social triad that allows us to access the root cause of the disease process. This early experience of medicine in an underdeveloped country awakened within me the sensitivity for serving those in need. From the day that I graduated I have perceived medicine and health care as a God given right belonging to all of humanity."

Dr. Williams then completed his residency in general surgery at Albert Einstein College of Medicine and Bronx-Lebanon Medical Center in New York city, during the peak years of the Aids epidemic, and he shares, "This was a trying time emotionally and a time of enormously hard work, however I was a witness to the evolution of medicine and the disease process. I also had the privilege of working in scientific research for a year with Dr. Stanley Levenson, professor Emeritus of Surgery at the Albert Einstein College of Medicine, who is considered to be a pioneer in wound healing research. Reading about the great minds of early science was mandatory prior to engaging our actual work project, and this inspired a keen interest in the work of Louis Pasteur, Dr. Dubois among others. But what I remember the most about Dr. Levenson was the wisdom he passed to us as surgeons, residents, and students, as he shared the stories of his exodus from Russia as an orphan Jewish immigrant traveling a post holocaust Europe and coming to America to become a leading authority in the world of academic Surgery and Basic Science research and the recipient of awards from the American College of Surgeons. His wisdom and perseverance instilled in me the courage to seek beyond conventional norms."

During his senior years in his surgical training, Dr. Williams received the mentorship of Dr. Robert Frater, Acting Chairman of the Cardiothoracic Surgery Department at Einstein, who introduced him to the world cardiothoracic surgery and who endorsed him as a potential candidate for fellowship training in cardiothoracic surgery. Dr. Williams then went on to train in cardiothoracic Surgery at the University of Medicine and Dentistry of New Jersey (UMDNJ- New Jersey Medical School) Newark campus.

"The cardiothoracic surgery training was intense and demanding but full of rewards for the heart. Again, working in the inner city and its population help me see the other part of society with its continuous problems like a vicious cycle with no end in sight. As I came face to face with this every day, it made me see clearly and first hand the problems that plague our health care system." Dr. Williams completed his board certification in General Surgery in 1997(American Board of Surgery) and Cardiothoracic Surgery in 2001(American Board of Thoracic Surgery)

After completion of his surgical training, Dr. Williams began his private practice.

It was during the beginning of my practice that "I heard the call to service".

It became clear that for him path of medicine would lead him to a higher purpose and that caring for those in need went far beyond the financial rewards in which our health care system is entangled at this time.

It was in the fall of 2000 when I first came into contact with Dr. Devra West, whom we graciously and fondly call "Surya Ma" (a name reflecting high honors on the spiritual path) during a transformational training at her retreat center in Montana. I quickly came to recognize that she is one of her kind among the few contemporary illumine minds here in the west. She is a modern day pioneer and visionary who lives her life as an example in service for the greater good of humanity. It was as if I had been ignited to see and know and experience at all new levels of possibility, and as a physician, I felt privileged to receive the gold that her teachings have to offer. And I have been inspired to pass on to society at large, the tools that have empowered me to engage the philanthropic spirit in service to humanity and more over into my medical practice. She is a Master Healer because she is a Master Soul. Her very presence is a healing presence. Because she heals from a greatness of heart, she has opened my sight to my own greater capabilities as a human being.

I am delighted and honored to further her work in all ways possible and for the opportunity to serve as board member of the Global Guardianship Initiative and look forward to becoming a dynamic force in the implementation of the different projects on a long-term basis.

If you view the penultimate paragraph in the above statement by Williams, he states that it was in the fall of 2000 when he first met Devra Patton West "whom we graciously and fondly call Surya Ma, a name reflecting high honors on the spiritual path." This statement is one of many sycophantic, gushing and totally misleading testimonials that Williams has given Devra Patton West, with the obvious intent of misleading the public in an attempt to attract new victims of crime and new blood to West's cult.

#### **A few FACTS to put Dr. Julio Williams' 2007 & 2008 statement into context.**

**1.** In 2000, when Williams first came into contact with "Dr. Devra West" she was calling herself the Ascended Master Devra Ji – not Surya Ma. 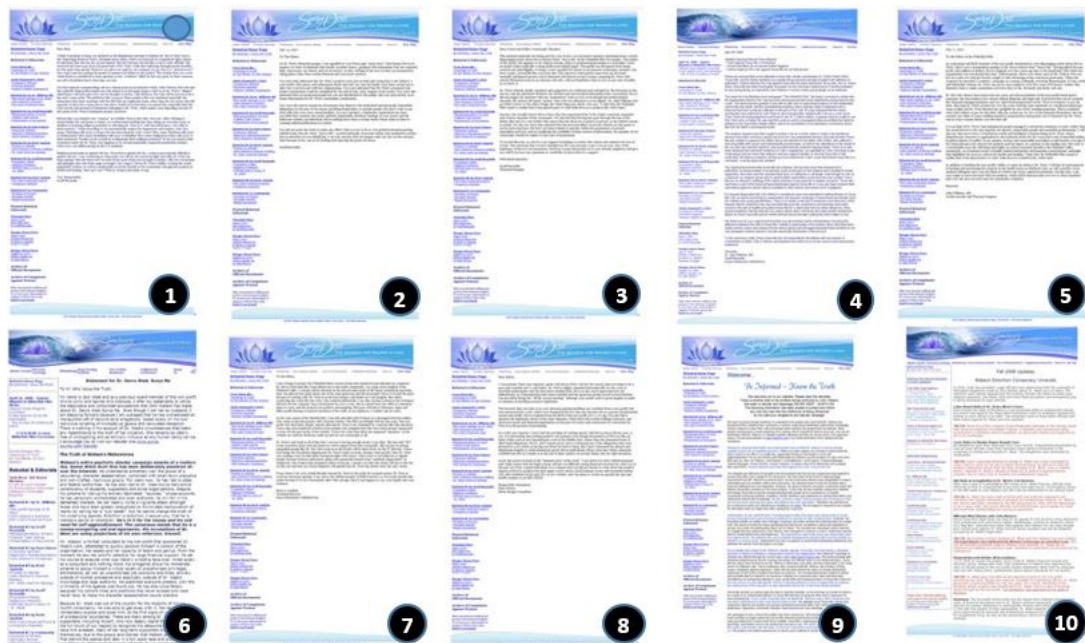
**2.** At the time Williams posted this statement on his cult leader's website, he was 100% aware that Devra Patton West had, in April 2006, viciously assaulted Dr. Pat Cole MD by repeatedly hitting her on the head as part of a campaign to extort \$1.3 million from the victim which West succeeded in doing. Dr. Julio Williams would have known that the police had been called to the assault that Devra West was charged with assault, and was eventually convicted of the assault in April 2008. Dr. Julio Williams would have received a copy of a lengthy missive that Devra West mailed to her entire mailing list on April 17 2006, shortly after the assault occurred. The missive entitled ['The Law of Severity on the Path to Purification,'](#) sought to justify West's assault on Cole by asserting that the victim was a Nazi in the WWII death camps in another lifetime! West did not take credit directly for writing this missive but asserted that a long dead Ascended Master by the name of 'El Morya' had channeled the message through her.

Dr. Julio Williams would have read the two newspaper articles published in July and August of 2007 in the [Whitefish Pilot](#) and [Bigfork Eagle](#) respectively. Here is what the victim Dr. Pat Cole MD told the Whitefish Pilot about the assault.



*"She has told me that she has the 'spiritual' power and authority to 'take me out,' to be composted," Cole wrote in the temporary restraining order statement. Cole claims West threw a lamp at her and hit her with a briefcase, cell phone and her hand. "She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself." Photos taken after the alleged beating were submitted to the sheriff's office.*

There can be no doubt that Dr. Julio Williams knew about the 2006 assault but instead of coming to the aid of a fellow physician, he joined in the campaign of denials from other senior members of the cult. These statements of denial were mainly aimed at the members of her cult who, having been brainwashed and conditioned to obey Devra West's every word, would be expected to swallow her denials. In spite of all the evidence to the contrary, proving that Devra West was a dangerous psychopath and probably a serial killer.

### Court Rules to Dismiss Bogus Assault Case:

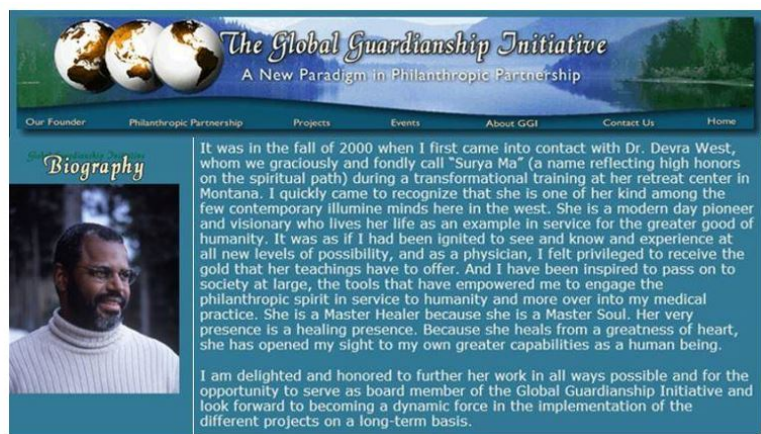
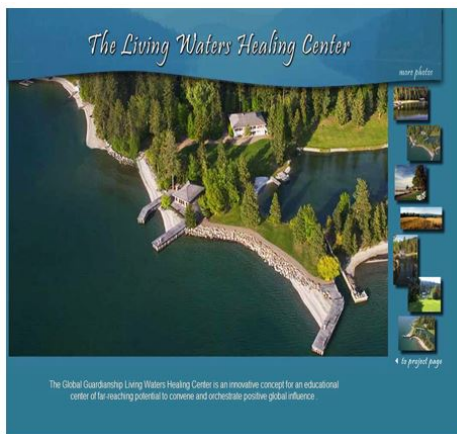
All allegations have been expunged from court records. Irregularities perpetrated by Cole to court officials, more than indicated Cole's direct involvement in the conspiracy to entrap and discredit Dr. West. The allegations were dismissed as implausible.

**TRUTH:** Cole's misguided attempt to entrap Dr. West was a ploy motivated by Cole's need to cover-up her own in-depth financial fraud, as well as to hide her medical malpractice issues that had been divulged to Dr. West. **4.** The July 12 2007 [Whitefish Pilot](#) newspaper article also referred to the fact that Devra Patton West was fraudulently misrepresenting a multi-million dollar lakefront property as belonging to her as part of the illusion that she was a wealthy business woman and not a con artist. Robert & Tabby Ivy told the [Whitefish Pilot](#) newspaper that they had repeatedly asked Devra West, over a two year period, not to use images of their property in her brochures and on her website.

6. In 2008, John Watson was [granted judgment](#) against Devra Patton West and [awarded \\$760,000](#) in costs and damages. Devra Patton West immediately issued a statement from her website asserting that Watson's win in court was a technical error. 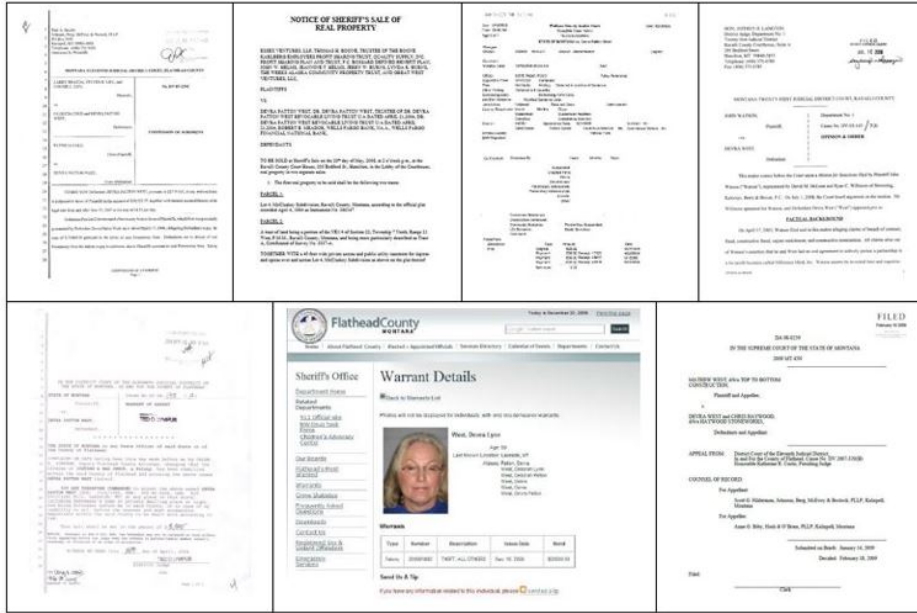

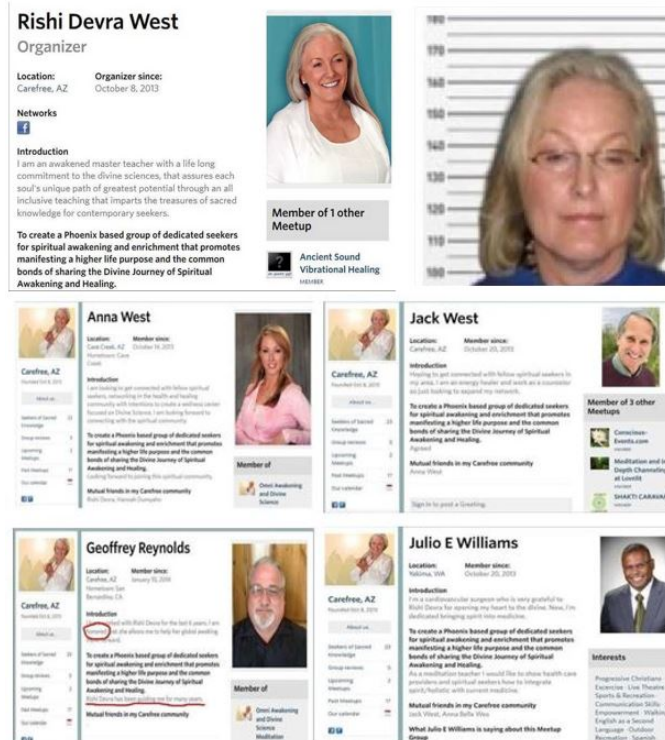

The very same campaign of violence that Geoffrey Reynolds predicted would occur in August 2007. 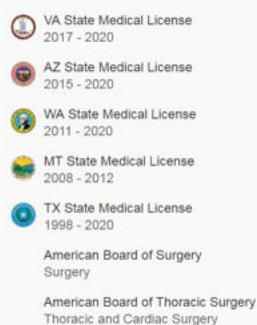


## Essentia Health Welcomes Dr. Julio Williams

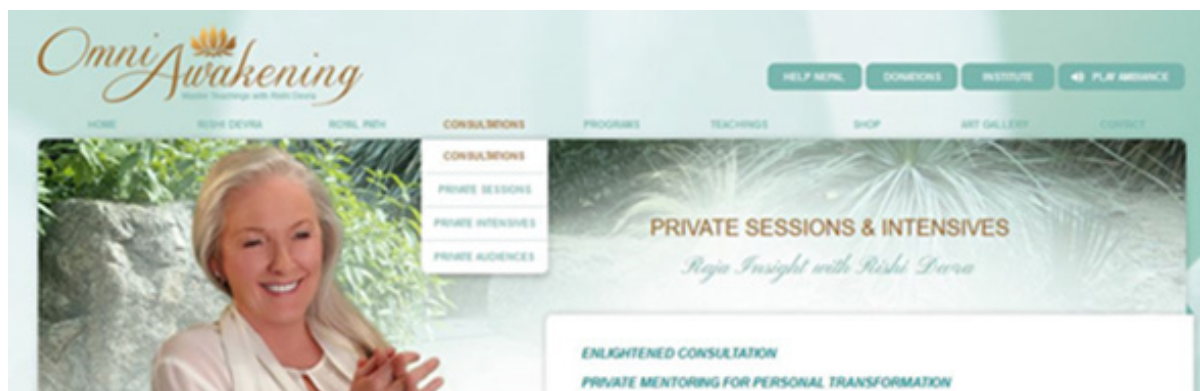

**Step 2.** Those targeted are duped / manipulated / pressured into believing one of the following two scenarios.

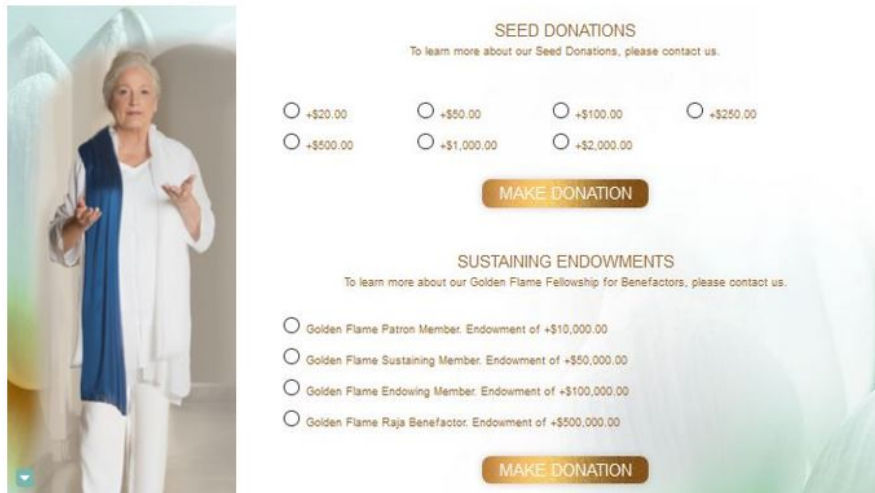
1. That they are suffering from a totally non-existent brain tumor or a cancer which Devra West guarantees she can cure for a large fee.
