It is unlikely, when interviewed for the position of accountant at McSwain & Co., that Geoffrey Reynolds CPA declared that he was a senior member of a cult / criminal gang whose leader, Devra Patton West, is suspected of at least one murder, at least one attempted murder and numerous counts of theft, fraud, extortion and violent assaults. It is unlikely that he declared to his new employer that he was guilty of failing to report serious crimes to the police that were committed right under his nose by his previous employer. It is unlikely that he declared to his new employer that he was guilty of money laundering, complicity to commit murder and criminal conspiracy. When we advised his current employer McSwain & Co., about Reynolds' criminal past, his / their response was to sanitize Reynolds' entry on their website to remove all mention of Reynolds' past association with Devra Patton West's criminal racketeering gang. Given Reynolds treachery and dishonesty, we believe he should have been sacked on the spot; as to keep employing him, risks a public relations nightmare for McSwain & Co. when Reynolds is eventually arrested and called to account for his links to organized crime.





Originally Reynolds' resume on McSwain & Co.'s website included mention of the eight years he spent as part of Devra Patton West's criminal racketeering gang between 2006 & 2014. Above left was the first sanitized version of Reynolds' resume designed to mislead the public and clients about Reynolds' criminal past. Above right is the current version of Reynolds' entry on McSwain & Co.'s website which omits Reynolds's photograph. This is a clear attempt to mislead the public / clients about Reynolds' past.

The above two sanitized entries on McSwain & Co.'s <u>website</u> for Reynolds, both make the following FALSE statement under the heading 'Experience.'

"Prior to joining McSwain & Company, PS. Geoff was independent consultant. He worked as an Outsourced CFO for many companies needing CFO services but unable to hire a CFO internally, this included Start-up Consulting, Business Plan

Development, Mergers & Acquisitions and many other services. Geoff also served as CFO for Intramedicine, Inc. and Infinite Axis, Inc. Geoff began his career with Kendall and Associates, a Public Accounting Firm in Los Angeles, CA, becoming a partner.

Though Reynolds' website entries on McSwain & Co.'s website have been sanitized and amended, a copy of Reynolds' own personal website still exists in cyber space, which clearly shows the information that Reynolds and McSwain & Co. are trying to hide from the public and existing clients. Envisioned company's future and implement plans, strategies and policies to guide and direct employees to achieve it. Supervised and coordinated organization's operations and made sure employees have the resources needed to do their jobs. Over sees all operations to minimize expenses. As a down payment on our evidence that Reynolds is a pathological liar and was a senior member in a cult / criminal racketeering gang, we would point out two FACTS that contradict Reynolds' claims.

1. Below, we share with you an excerpt from an August 2007 newspaper article published by the Bigfork Eagle newspaper. The full article can be found by going here.

Out of six businesses mentioned in West's literature, only one remains active and in good standing with the Montana Secretary of State office -- Sacred Environments LLC. Two were never registered -- Divine Unity Foundation and Millennium Mind Institution; two were involuntarily dissolved -- Surya Enterprises Unlimited and Global Guardianship Initiative; and one was involuntarily revoked -- Sacred Archive Institute.

It would appear that Surya Enterprises Unlimited (shortened by Reynolds to 'Surya Enterprises') was involuntarily dissolved.

2. Under selected accomplishments, Reynolds states that he secured \$30M in wrap loans with no expenditure of company equity. This too is a lie. Below are pieces of evidence that prove Reynolds is not telling the truth and just making stuff up to pad his resume. (It is what pathological liars do!)

The following statements are excerpts from a series of harrowing emails sent to the whistleblower, John Watson, in March of 2007. These statements came from Rebecca West, no relation to Devra West, who was serving as Devra West's office manager at the time Reynolds claimed to have secured \$30M in wrap loans. The following three statements came from an email entitled 'Help Me.'

This phone call is the straw that broke the camel's back for the finance controller [Geoffrey Reynolds CPA] who has finally realized that he can no longer ignore the very bad situation he has gotten himself into by loaning Devra \$300,000. I know that unless the \$30M comes in this week, the Naka Shela Retreat Center is lost to foreclosure along with the house that Dr. Cole bought in Lakeside, which is where Devra lives (in the basement) with her son Che, his wife Jamie, and their newborn and 7-year daughters living upstairs. Dr. Cole was forced to sign a "Quit Claim Deed" by Devra and will be yet another assault to her credit rating. My credit rating has taken a huge blow due to lack of timely paychecks, missing wages, bounced checks and caused me to be unable to refinance my home last month.

I have followed the \$30M CPEA funding issue closely and although the monies are earmarked for a 3-Tier Business Plan to develop Spas is the very way to pay off her debt to all of us.

The following statement came from an email entitled 'I'm in Danger.'

Please be advised that the CPEA \$'s obtained with Dr. Cole's funds are due into the bank account this week. These monies were supposed to be available over a year ago and if the transaction is not a fraud then \$30M will be deposited in increments.

These loans were NEVER granted! Witness the fact that a \$6,000,000 cheque that Devra Patton West wrote for a deposit on a property 'bounced' resulting in an arrest warrant being issued for her in respect of <u>criminal cheque</u> fraud. Below is another excerpt from the <u>Bigfork Eagle</u> newspaper article published on 9 August 2007.

Besides being evicted from her Bayside home in Lakeside and bouncing a check for the purchase of the well-known Osprey House on Angel Point, West has a \$2,287 lien against her for failing to pay unemployment taxes for her Montana employees.

Reynolds claims that several people have been stirring up trouble by publishing untrue allegations against West.

To come to the point, two of the statements made by Reynolds on the resume still shown on his personal website are totally false. These two statements were formally shown on his resume at McSwain & Co. until they sanitized it to remove any mention of his association with Devra Patton West's criminal racketeering cult / gang.











<u>Devra Patton West - a short history.</u> At this point, it would be useful to give some background about Devra Patton West, a lifetime criminal and quite possibly a serial killer who treats the police and criminal justice system with utter contempt. If we look into Devra West's past, we see that prior to acquiring occult (hidden) knowledge in the early 1990's she was already a common criminal operating pretty much outside the law. As witness / victim Jeremy Samuelson relates, in the <u>statement</u> he sent the whistleblower John Watson in 2007, Devra West and her

husband Jack West were pot growers / drug dealers who had defrauded him out of \$10,000. In 1991 Devra West defrauded Satya, a class mate of hers at the 'energy mastery' school, out of \$6000. As a consequence of acquiring occult (hidden) knowledge while attending <u>The Robert Jaffe School for Energy Mastery</u> between 1990 & 1991, Devra West achieved two important objectives.

- 1. As a narcissist who thought she was superior to everyone else, Devra West now had some tricks up her sleeve which she could use to convince spiritual seekers that she was a 'divine being,' a Master Teacher to be worshipped and obeyed.
- 2. After acquiring a certain level of skill at Shamanic visioning, she was able to exponentially leverage her criminal tendencies. She could do this because the Shamanic skills she had acquired could be used a weapon to manipulate the sheeple (spiritually confused persons who cannot tell a devil from and angel) into doing her bidding. It could also be used to facilitate theft, fraud, extortion and to intimidate victims and witnesses into silence or murder her victims and witnesses all with plausible deniability. How Devra West uses occult knowledge to silence her critics and the victims and witnesses of crime.

A Comparison between Rishi Devra AKA Devra Patton West & Joao Teixeira de Faria AKA John of God.

The first link leads to a bulletin that explains how she uses the occult to intimidate victims, witnesses and murder those who challenger her. The other is a link to her Brazilian counterpart 'John of God' who was recently arrested for child sex trafficking and a range of other offenses. Note when reading the article his use of the occult at the time of his arrest. No wonder victims were to come forward until after he had been arrested. I suspect the same will be true of Devra Patton West.







Above: Like Devra West, 'John of God' is a practitioner of the occult arts. West's proclivity is control over the lives of others and money. John of God's was sexual abuse / domination and money. Both pretend to be something they are not to suck in the gullible who, after brainwashing and conditioning are mentally and physically abused and then robbed and discarded.

Geoffrey Reynolds' history with Devra Patton West. Prior to joining Devra West's employ in September 2006, Geoffrey Reynolds CPA, if we can believe his personal resume, worked in California between 2003 & 2006 providing fundraising and management advice for movie companies. Shortly after taking up his 'employment' with Devra Patton West in Montana Reynolds, not the brightest bulb on the Christmas Tree, swallowed Devra West's bullshit about trying to save the world hook, line and sinker. As a consequence, Reynolds was manipulated by Devra Patton West into loaning her his life savings in the amount of \$300,000. Rebecca West makes reference to this in several of her emails to the whistleblower John Watson, who like every other 'consultant' before and since was also approached by West for a loan that in the case of many, including Dave Kushner, would never be repaid. Below are a couple of comments Rebecca West made about the predicament that Reynolds had gotten himself into shortly after joining West's employ / cult / criminal gang in September 2006.

I am aware that the only person still financially supporting Devra (the finance controller [Geoffrey Reynolds] is out of money), is Dr. Julio Williams and he gave her \$100,000 last week. Devra spends money so fast that this funding will not last long. Tanmayo's (Coca-Cola heiress) son contacted the finance controller yesterday demanding the monies his mother contributed be returned. This phone call is the straw that broke the camel's back for the finance controller [Geoffrey Reynolds CPA] who has finally realized that he can no longer ignore the very bad situation he has gotten himself into by loaning Devra \$300,000.

And...

The companies owe large sums of money for WC, and ST, and Fed payroll taxes and was the reason he [Geoffrey Reynolds CPA] secretly laid-off Wendy Stuart, without confirming this choice with Devra first. He was attempting to protect his CPA license and as of last night pretends not to remember that we both saw her get hit by Devra with a large, heavy three-ring binder and fired on the spot! I also told him for the fourth time yesterday evening, that in addition to her cruel verbal abuse, I had been slugged by Devra, three times in the back. I told him that I would be going to the State Unemployment Office with the truth and asked him, as my co-worker, if he would tell the truth regarding our working conditions. He [Geoffrey Reynolds CPA] said that it is his responsibility to represent his employer and he will not tell the truth unless specifically asked for the sake of keeping his job.

Devra dangles the carrot and since he {Geoffrey Reynolds CPA] has loaned her his life savings, plans to keep playing her game until it is played out or he is eventually running her property management company. He has not been paid the \$300,000+ owed him and provides excuses that although he has had only four employers in his lifetime, most rich people are eccentric and in his experience their behavior can be much worse than Devra's.

It is clear from the above comments that Geoffrey Reynolds, shortly after joining Devra Patton West's employ in September 2006, fell entirely under Devra Patton West's control. Last week's bulletin was dedicated to Dr. Julio Williams MD, who was / is a student in Devra West's unaccredited school for occult studies and a senior member of her cult / criminal gang. Unlike Geoffrey Reynolds, Julio Williams has been totally brainwashed and conditioned by Devra Patton West to do her bidding, however immoral or illegal that might be. This includes using his credentials as a physician / thoracic surgeon to endorse Devra Patton West as a miracle healer who can summon up 'Divine Grace Healings' for those

who can afford to pay \$500,000 for the privilege of being 'cured.' Often those targeted by Devra West and her accomplices are being cured of a condition that Devra Patton West, using occult knowledge, may have induced in them in the first place!

As stated, Geoffrey Reynolds has <u>not been brainwashed</u> like Julio Williams. However, I leave it to the reader (and the FBI and law enforcement) to decide whether Geoffrey Reynolds CPA was a corrupt and despicable individual before joining Devra West's employ in September 2006. The only other alternative was that Devra Patton West, using the \$300,000 Reynolds had loaned her, blackmailed Reynolds into becoming an accomplice in organized crime. Specifically, Reynolds was briefed about the planned murder of whistleblower John Watson in August 2007, and when that failed, the criminal conspiracy to bankrupt him in 2010. 

In the excerpt from the Bigfork Eagle newspaper featured previously in this bulletin, Geoffrey Reynolds, speaking on behalf of his employer / cult / gang leader refers to "untrue allegations" against Devra Patton West that people were using to "stir up trouble." 

Above, the Whitefish Pilot, the Bigfork Eagle and the Ravalli Republic newspaper articles laid bare Devra Patton West's criminal racketeering business model in Montana. And her regular appearances to court as the defendant in fraud-related lawsuits, made it clear that Devra West was no guru but a career criminal. Below are details of

some (not all) of Devra Patton West's appearances in court at the time the <u>Bigfork Eagle</u> newspaper article was published. These are cases where Devra Patton West appeared as the defendant in mainly fraud related lawsuits. These cases were ongoing in August 2007, with many coming to a conclusion in 2008. These are what pathological liar Geoffrey Reynolds refers to as "stirring up trouble by publishing untrue allegations"

Later in 2009, she was the recipient of an arrest warrant for felony theft. Devra West and son Chris Haywood guilty of defrauding Top to Bottom Construction. This is the tip of the iceberg! What follows are clear and unequivocal further examples of Reynolds statements and actions being orchestrated by cult / gang leader Devra Patton West.



2. Geoffrey Reynolds – Lies to a newspaper about his 'employers' assault on Dr. Pat Cole MD. In another excerpt from the Bigfork Eagle newspaper Geoffrey Reynolds, speaking on behalf of his employer, asserts that.

Speaking for West, Geoff Reynolds claims the charges are untrue. He said photos of the first alleged assault were taken on a different date, and the bloody clothing in the photos resulted from Cole falling down a stairs at her Cherry Creek condo in Lakeside, not from an assault.

The man who took the photos, however, tells a different story about the alleged assault. He came from out-of-state and was sharing the condo with Cole while he attended sessions with West. He said he was meditating when Cole appeared wearing a bloody sweatshirt. The man said they cleaned some of the blood off Cole's scalp and then took photos so Cole, as a doctor, could see her injuries and decide how to treat the wound. Cole said West hit her on the head with a shoe, the roommate said.

Firstly, Reynolds did not join West's employ until September 2006 and was up until that time, working in California. Therefore, Reynolds was not a witness to an assault that took place in April 2006 some 6 months earlier. A witness

who was attending the same sessions with West as Cole, and who was sharing a condo with Cole witnessed Cole coming back to the condo after being assaulted by West. Clearly, Reynolds was lying when he said Cole had suffered the injuries on an earlier date when she fell down stairs at her condo. Additionally, at the very time that Reynolds was denying that his employer / cult / gang leader Devra Patton West had assaulted Dr. Cole MD, Reynolds was desperately trying to remove a written admission by Devra West that she had assaulted Dr. Cole MD from John Watson, the whistleblower's website. Below are a couple of excerpts from a missive entitled, 'The Law of Severity on the Path to Purification,' that Devra Patton West wrote to her mailing list on 17 April 2006, just a day after the police were called to the assault on Dr. Pat Cole MD.

The Law of Severity on the Path of Purification

Response to the Call of Master Surya Devi for Review

April 17, 2006 From Master El Morya of the Shamballa Counsels

What must be taken into account in all matters of review on the part of the Shamballa Counsels is the surrounding circumstances and the root motivation that is at play within any given matter of cause and effect or in the case of Surya Ma's actions the matter of singular cause aligned in Divine Will. We therefore have come to the following determination:

At no time has Surya Ma's intentions been rooted in anything other that the highest of grace despite the seeming severity that was meted. And we are witness to the sacrifices that she has made on behalf of the awakening of those who are placed in her charge and on behalf of the Divine Plan itself. She has offered up very resource and body, mind and soul

Dr. Cole is long over due in the sound arighting of her soul with its Creator. Her role in the death camps of Europe during the reign of the Nazi defilement is as yet unrectified. The suffering that was administered directly from her hand was an unconscionable infliction of brutality and evil and more over was resultant in the compromise of her very soul of its inherent link with the light of God. This is a rift in time of planetary karma and many souls have been lost to this rift and remain entrapped in the astral planes of this horror of human disgrace. Her continued denial of this samscara remains a factor to be rectified and she cannot progress until she comes to terms with her compulsions of victimhood rationale, that are merely smokusereens that veil her memory of her perpetrations against her fellow human brethren.

Clearly, Devra Patton West is at least a very dangerous psychopath. In the above missive Devra West, not speaking as herself but acting out her alter ego as the Ascended Master Surya Ma, makes the following two assertions:-

(i). Her actions were rooted in the highest grace despite the seeming severity that was meted [when assaulting Dr. Cole MD]. Below here is a statement that Cole gave the Whitefish Pilot newspaper about the assault.

In her statement to the county sheriff's office, Cole claims West abused her verbally and physically. "She has told me that she has the 'spiritual' power and authority to 'take me out,' to be composted," Cole wrote in the temporary restraining order statement. Cole claims West threw a lamp at her and hit her with a briefcase, cell phone and her hand.

"She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself." Photos taken after the alleged beating were submitted to the sheriff's office.

Another witness Carlida Finch, an employee of Devra West's, overheard Devra Patton West planning Cole's murder. She saw the injuries inflicted by West on Cole and made several statements about them to the authorities about the matter and claimed that West's business was a 'hostile working environment.' (ii). Sought to justify the assault to her cult by asserting that the victim, Dr. Pat Cole MD, was a Nazi in the WWII death camps in another lifetime. 

Above ten statements of denial all, as if by magic appearing on West's website on the same day. These statements in response to the two newspaper articles printed in the Whitefish Pilot & Bigfork Eagle newspapers in 2007.

4. Geoffrey Reynolds – Treachery and Lies Revealed. After commencing his 'employment' (membership of the cult) in September 2006, Geoffrey Reynolds was tasked with forcing the removal of a copy of 'The Law of Severity on the Path to Purification,' from John Watson, the whistleblower's website. John Watson was given a copy of that missive by an employee of Devra West's as clear proof that Devra West had assaulted Dr. Cole MD, despite all the denials by West and the senior members of her cult. These denials continued up to West's conviction for assault and beyond her conviction. The point is, that immediately after the publishing of the Whitefish Pilot news article, on July 12 2007, Reynolds and several other cult members published statements of denial on West's website as shown above here. On August 9 2007 Reynolds denied Devra West's guilt in the interview he gave to the Bigfork Eagle newspaper on August 9 2007. He did this at the very same time he was making several desperate attempts to force West's written admission that she had assaulted Cole off the whistleblower's website.

Below is a copy of one of the later attempts to remove that statement from the whistleblower's website. In this email sent by Geoffrey Reynolds to the service provider of John Watson's website, Devra Patton West claims copyright of her own statement wherein she admits assaulting Cole, in an attempt to use the Millennia Copyright Act (MCA) to force its removal from Watson's website.

5. Geoffrey Reynolds Guilty of Money Laundering \$463,750 extorted from Dr. Pat Cole MD through Devra Patton West's business as 'normal business' receipts. Geoffrey Reynolds' employment with Devra Patton West came about because his predecessor, Betsy, refused to 'manufacture' fake invoices to make it look like the funds extorted from Dr. Pat Cole MD were received legally as normal business receipts. The following is an excerpt from an email from ex-employee Carlida Finch wherein she clearly alludes to the reason why Geoffrey Reynolds' predecessor resigned. Below is an excerpt from the statement that Reynolds gave to the Bigfork Eagle newspaper on August 9 2007.

Reynolds claims Cole owes West \$753,484 and that colors Cole's allegations. Cole's bills for 2004-2006 totaled \$1.3 million, including \$250,000 for an "internship" under West and \$213,750 in "therapy fees" for eleven months last year. Cole managed to pay West \$621,484, but it didn't come easy. At one point, Cole cashed out her IRA and paid West \$293,843.

As stated earlier, Reynolds is not the brightest bulb on the Christmas tree, as he more or less admits money laundering \$463,759 extorted from Dr. Cole MD. Does he really believe that someone would pay these vast sums of money for an 'internship' and for 'therapy' from Devra West? Does he actually believe that someone would willingly cash out their IRA for an internship and therapy? It is clear from the evidence that where Betsy, his predecessor, had reservations about money laundering the proceeds of organized crime through Devra Patton West's criminal racketeering business model - Geoffrey Reynolds had no such reservations.

As a result of the evidence John Watson provided in January 2004, Devra West's charity status was revoked; you can view the Revocation Certificate by following the link. While researching his lawsuit, John Watson found out that there were scores of victims of theft, fraud, extortion and violent assaults at the hands of Devra Patton West. Basically, every employee and most of the students to her unaccredited school for occult studies were victims, if not of financial crimes then they were mentally and physically abused, as Devra Patton West tried to force them into joining her cult as low paid or no paid slaves.

In March of 2007, John Watson started to receive a series of emails from Devra Patton West's then office manager Rebecca West (no relation to Devra West). Because the content of these emails was so serious he decided to share them with the local press and as a result in July of 2007 the Whitefish Pilot newspaper published its story about several of the crimes being committed by Devra Patton West and her accomplices chief amongst them the vicious assault by Devra Patton West on Dr. Pat Cole MD. On August 9 2007 a similar article was published by the Bigfork Eagle newspaper giving further details of West's criminality. These two newspaper articles were followed by a third in April 2008, when the Whitefish Pilot reported that Devra West had been convicted of assaulting Dr. Pat Cole MD. The fourth article appeared in the Ravalli Republic in October 2008, announcing that Devra Patton West was found guilty of defrauding John Watson, who by then had turned whistleblower and had a website up dedicated to informing the public about Devra West's cult / criminal racketeering gang.

After whistleblower John Watson had very publicly made it obvious that Devra Patton West was not a guru but the leader of a dangerous cult / criminal gang whose success was predicated on her use of the occult, two FACTS were made very clear to Devra Patton West.


(i) Her guru / cult / extortion business, that relied on the public swallowing the propaganda that she is a guru / minor deity, was finished in Montana.

(ii) In order to launch her guru / cult / extortion business in a third western state (after being obliged to leave New Mexico in 1995 and Montana) she would need to force down John Watson's website which contained a library of information which contradicted the narrative that Devra West was a 'divine being' and not an occult thief / suspected serial killer.

On August 9 2007, in what he thought was an 'off the record conversation,' Geoffrey Reynolds announced John Watson's impending murder to the news reporter Constance See. She took the threat seriously enough to share it with a federal agent John Nielson, who passed the threat on to John Watson via email.



What Reynolds actually said was this. "Watson would be dead within 12 months or in jail for reacting to what Devra Patton West was going to do to him and his family!" A few days later Devra Patton West, using her occult skills, made a failed attempt on Watson's life.



I do not have the space in this bulletin to go over material covered in previous bulletins. To read how self-appointed Ascended Master Devra Patton West and her Brazilian counterpart 'John of God' (notice they both claim to be 'divine beings' because they are able to get away with multiple murders under the authorities noses) follow these two links already referred to above.

Additionally, we would say that Devra Patton West herself, has not been shy about bragging about her abilities. She had this to say to the Whitefish Pilot reporter when being interviewed on July 12 2007:-

West claims to have been trained in shamanic visioning and healing by Native American elders and to have been both a Cheyenne medicine woman and General George Patton in past lives. She also claims her "gifts" can heal people with various illnesses, including leukemia, and she plans to teach what she knows to cardiologists and other physicians when her plan for healing spas unfolds. "If you ever saw me heal, you'd be down on your knees crying like a friggin' baby," West said.

One has to decide for themselves whether the statement highlighted in yellow above in the last sentence comes from a guru or a dangerous psychopath / suspected serial killer. The final question worthy of an answer is this.

When announcing John Watson's impending death to the newspaper reporter Geoffrey Reynolds clearly had confidence that Devra Patton West was capable of delivering that outcome. In 2002, shortly after John Watson was hired as a business consultant, he was told by Devra West's then husband, Jack West that those who opposed his wife had a habit of dying suddenly. Was Reynolds so confident in Devra Patton West's ability to murder John Watson because she had shared with him details of previous murders that she had carried out using her occult weapon? Such as the sudden and mysterious death of Devra Patton West's student and confident Lisa Swidler, who had witnessed Devra Patton West defrauding \$30,000 from student Dave Kushner? Lisa had also witnessed the kidnapping, holding captive and extorting tens of thousands of dollars from student Marion Cantwell who upon release was told she would be killed if she went to the police.

Dr. Pat Cole, whose murder West was overheard planning; she lived only after handing over \$1.3 million.

John Watson defrauded in 2002, turned whistleblower in 2006; West tried to kill him in 2007.

In addition to the murders, there is evidence that Devra Patton West was using her occult weapon to intimidate victims like Dr. Pat Cole into dropping their complaints, or witnesses like Rebecca West into withdrawing their hostile statements against her. In the harrowing email entitled 'Help Me' that Rebecca West sent in March 2007 to the whistleblower John Watson, she asks for help with West's shamanic witchcraft. Additionally, Devra Patton West's daughter-in-law Jamie Haywood accuses West of targeting her in an attempt to force her to give up her infant daughter to West's son after their marriage broke down. Jamie Haywood's testimony at the custody court hearing speaks volumes about Devra West's sordid life that she is prepared to murder others to keep out of the public eye. 7. Geoffrey Reynolds announces a campaign of occult 'under the radar' violence against John Watson and his family that is ongoing 13 years later. As stated earlier, what Geoffrey Reynolds actually said to the reporter was this:-

"Watson would be dead within 12 months or in jail for reacting to what Devra Patton West was going to do to him and his family!"

Following the failed murder attempt John Watson, his wife and children were subject to a campaign of occult 'under the radar violence' which continues to this day. That is from 2007 to 2019 i.e. 12 plus years. Below are some of the attacks used by Devra Patton West against John Watson and his family and, from what other victims say, against them and their families. Is it any wonder that 95% of the victims of crime at Devra Patton West's hands choose to walk away empty handed.

- **1.** Migraine headaches that start with the scalp burning such that the victim has to apply a cold wet towel to the head to stop the burning sensation. These migraines are so bad that the victims have to take pain killers for days until the pain subsides only to be targeted again and again.
- **2.** Acid reflux attacks that continue for months causing one to have to take powerful drugs to stop their stomachs digesting itself.
- **3.** Sinuses constantly running. When I say running I mean that one has to walk around with a cup in one's hand to drain the sinuses into.
- **4.** Excruciating muscle pain in the legs like cramps on steroids.
- 5. Extreme back ache such that one could never get comfortable except when lying down in bed.
- **6.** Attacks to the genitals. This form of violent attack seems to have been directed at all members of the family simultaneously. A clear sign that the whole family was under attack came when different family members separated by hundreds, in one case thousands of miles, acquired the same symptoms on the same day!
- 7. Targeting the heart was, and still is, a favorite target of West's. These attacks gave John the feeling that a stake was being repeatedly pushed into his heart. 13 years ago when these attacks started, this was quite worrying, however 13 years later he has learned to ignore these attacks in the knowledge that if Ms. West had been able to kill him, she would have done so long ago. Long term effects unknown.
- **8.** The Feb / Mar / Apr 2018 long term attack was against John's right ankle. Long story short, while he slept the pain built up in his right ankle and when he got up it was painful to walk. Throughout the day the pain subsided somewhat (a moving target is harder to hit) but overnight the occult thief / suspected serial killer works on it again.
- **9.** While employed in 2017, his right knee and ankle were targeted simultaneously; these attacks continued for several weeks and everyone at his place of work noticed that he was limping for weeks. Eventually Devra West must have got bored or whatever spell / software / visualization she was using wore out. Perhaps she just moved on to another target.
- **10.** A sudden spate of nose bleeds. John never gets nose bleeds. He doesn't have high blood pressure and yet in 2017 he suddenly had seven or eight in quick succession all within a month. Part of West's strategy is to try and frighten the target into submission by having them believe the attacks, especially the attacks to the heart and head, might prove fatal. Having been a marine, John does not scare easily and certainly nose bleeds are not going to ruffle his feathers.
- **11.** One of the attacks Devra West uses regularly is against their digestive systems. Like all the other attacks, this variety of violent assault is preceded by a loud hissing. Within minutes whatever they have in their stomachs starts gurgling loudly, followed by severe stomach pains (gas) then diarrhea. Even after eating even the most bland food, upon hearing the hissing, his wife and he would both know what came next.
- **12.** Another favorite attack of Devra Patton West's, also proceeded by a loud hissing, is where one's energy is drained, to the point of wanting to go to sleep.
- 14. Attack to one or both eyes. This felt like someone was pushing a needle through the eye.
- 15. Irrespective of what region of the body Devra West is targeting, there is always the sleep deprivation. This has been consistent throughout the 13 years and commented on by other victims including West's neighbor in Flathead Lake, Michelle Fetveit who got into a water dispute with West. John interviewed Michelle in 2007 and sure enough, she remarked about being woken up at 3.00 am each morning.

Just as predicted by Geoffrey Reynolds CPA when interviewed by the <u>Bigfork Eagle</u> newspaper on August 9 2007, a campaign of occult violence was launched at John Watson and his family. If it did not result in his murder, the plan was, as Reynolds explained, to provoke John Watson into reacting in a way that would have resulted in him being jailed. I guess West & Reynolds hoped that Watson would be provoked into taking the law into his own hands just as a victim did in New Mexico in 1995 when, realizing the police were totally incapable of helping him, he chased

Devra West out of the state in the middle of the night with a loaded gun. However, John Watson has used their tactics against them in that for the past eight years he has logged each and every attack and emailed details of those attacks first to West's lawyer (who like everyone else does not believe the occult exists) and for the past four years to Dr. Julio Williams MD, the other senior member of West's cult.



Rishi Devra is the Spiritual Guardian of the western region of the USA. While on bended knee before her she assured me that what looked like organized crime and racketeering was in fact Shiva energy manifesting through her. As a senior member of her cult I have no choice but to follow her orders.


8. Geoffrey Reynolds agrees to 'front' a \$10,000,000 extortion conspiracy orchestrated by Devra Patton West designed to bankrupt the whistleblower for telling the truth.

With the 2007 murder plot a failure, Devra Patton West's multimillion dollar a year criminal racketeering business model was on hold. No one was going to buy the 'divine being' narrative while John Watson's website was up containing thousands of documents to show that Devra Patton West was a con artist and a violent convicted criminal who had been 'run out' of New Mexico and Montana. West & Reynolds bided their time until they could implement 'Plan B' which they both did in 2010. While attending court to see how much he was to be awarded for winning his fraud lawsuit against Devra West in 2008, the whistleblower was served for defamation by Devra West & Geoffrey Reynolds - for telling the truth about West's criminality.

It shows just how committed to Devra Patton West's criminal racketeering cult / gang <u>Geoffrey Reynolds</u> was that he was prepared to:-

- (i) Be complicit in a plot to murder Watson a total stranger to him; a plot Reynolds announced to the press on August 2007.
- (ii) That he would place himself in some considerable danger for Devra Patton West when he agreed to go before a Montana court and make totally false statements about himself and his relationship to the whistleblower who he had never met and did not know existed until Devra West briefed him after September 2006.

Remember, we know from Geoffrey Reynolds' own personal website that prior to September 2006 he worked in California and yet, in the pleadings Reynolds was instructed to make by Devra West to the Montana court (see below), he states clearly that he was defamed by the whistleblower between 2002 and 2006.



As one can see below from an excerpt of Reynolds' resume taken from his own website (full copy available here) his statements were a total pack of lies and doubtless made on the instructions of Devra Patton West.

Consultant, Geoffrey L. Reynolds, CPA, 2003 to 2006. Established financial management consultancy. Provided fund raising and management advice for various publications and movie productions. Services also included tax and estate planning, forensic accounting, and developing / implementing accounting and computer systems.

So, using the unlimited resources of decades of criminal activity and a \$2,000,000 donation from senior cult member Julio Williams MD, Devra Patton West was able to neutralize John Watson, the whistleblower's 2008 win in court against her. She did so by waiting for him to attend court in 2010, to attend the 'award hearing' for the fraud lawsuit he had won against her, where she and her stooge Geoffrey Reynolds issued two frivolous defamation lawsuits against him. West and Reynolds did so gambling that Watson was unlikely to be able to afford to defend them. The truth is an absolute defense against defamation but only if you can afford to defend the truth in a court of law. He could not afford to do this because in 2005, fearing for himself and his family, he immigrated to Halifax, Nova Scotia on the east coast of Canada. The move turned out to be pointless, as neither distance nor time are a barrier to those who employ the occult against their victims.

Knowing that Watson could not defend the defamation lawsuit she had launched against John Watson, she had 'liar for hire' Geoffrey Reynolds CPA make exact copies of her pleadings and had him submit the copy in his own name. This is criminal conspiracy. By having Geoffrey Reynolds make false pleadings to the court, in addition to her own, she effectively doubled the award the court made against John Watson. To be clear, Geoffrey Reynolds, a total stranger to John Watson, whose periods of employment with Devra Patton West were separated by 4 years, agreed to be part of a criminal conspiracy orchestrated by Devra Patton West which resulted in two identical default undefended judgments of \$5,000,000 apiece. This miscarriage of justice is made all the more obvious when it became known that, after Reynolds was awarded his \$5,000,000 by the court, he signed his award over to

Devra Patton West's ex-husband, Jack West. This is a criminal conspiracy whose obvious motive was to force Watson's website down, which they achieved, and to bankrupt him to ensure he was not a problem in the future.



Above: Justice is not the objective of the courts; practicing the law is. As a consequence, the litigant with the most to spend on legal fees often 'buys' the result they want, as was the case with Devra Patton West who, after being found guilty of defrauding John Watson simply launched two new lawsuits against him using liar for hire Geoffrey Reynolds to 'double up' on the pay out!

The civil courts rarely dispense justice; their function is to 'practice' the law. In most cases, the litigant with the most money ends up 'buying' the result they want and in the process the lawyers, judges and others involved in the process earn a good living as is described perfectly by this illustration above. In Devra West's case, she made it perfectly clear to the whistleblower in March of 2003, that if he took her to court and sued her for fraud, that she would use every dirty trick in the book against him. She also stated that the cost of fighting the lawsuit would come out of his pocket, not hers, because senior cult member Julio Williams had pledged \$2,000,000 toward the cost of her legal fees. You can hear Devra Patton West threaten John Watson that she would do this if he took her to law. Listen to her say this in her own voice as John Watson recorder her saying it in 2003.

<u>Definition of the word Scum</u> (adj.) Possibly the worst word you can have your name associated with. It is <u>hard</u> to define the word, but it is basically used to describe someone <u>so disgraceful that they are seen as the lowest form of life</u>. "Worthlessness", "waste of skin", "dirt". 
