Meet Rishi Devra AKA Devra Patton West - a con artist and violent convicted criminal who is currently masquerading as the 'Teacher,' the 'Divine Mother' and the 'Western Regent' while targeting Sedona AZ.



For nearly 30 years, Patton West has operated her cult / criminal racketeering business model right under the authorities noses with apparent impunity. Scores of victims of theft, fraud, extortion and numerous victims of violent assault most too afraid to go to the police because they know the police cannot help or protect them. If Patton West's ex-husband Jack West, and the whistleblower John Watson are to be believed, Patton West is responsible for several murders. Below is just a very small sample of crime committed in Montana on an industrial basis, right under the authorities noses.



Countless acts of theft, fraud, extortion, violent assault and one well documented attempted murder with several suspected murders. Thirty years of racketeering committed in three western states. Patton West has never been held to account for any of it!

Let me illustrate how the murder of a whistleblower did not go according to plan and how Patton West and her two accomplices, Julio Williams & Geoffrey Reynolds, sought to make up for the failure by implementing 'Plan 'B.' Below are images of Patton West and her accomplices.

The above photo of Patton West is from a 2009 <u>arrest warrant</u> issued in Montana for Felony Theft. The arrest warrant issued just one year before she left Montana for Arizona and just two years before she announced that she had been elevated to the status of Planetary Regent and Mother of Ten Thousand Suns.

John Watson a victim of fraud turned whistleblower. One victim of racketeering and attempted murder who would not give up the fight for justice.

Watson, like Geoffrey Reynolds and many other professionals, was recruited by Patton West to work on fake projects that were never intended to see the light of day. These 'projects' were just a vehicle to attract professionals that she hoped she could manipulate to join her cult and provide her with financial donations. The strategy is described in our web page entitled 'Fake Career Opportunities.' Watson was employed on projects between January and August 2002. During that time, her then husband Jack West made a point of telling John Watson that those who opposed his wife had a habit of dying suddenly. After 6 months, and when it was obvious to Patton West that Watson was not going to join her cult, he was in August 2002 constructively dismissed and defrauded out of wages and shares. Watson found out later, while researching his lawsuit, that he was one of scores of victims of theft, fraud and extortion.

Patton West had what could be described as a conveyor belt of victims that were recruited as employees or consultants for non-existent jobs with those not agreeing to join her cult summarily dismissed being before she had to start paying employment insurance. Given that this employee had overheard Patton West talking about murdering her business partner, Dr. Pat Cole MD the employee decided to leave. He decides to sue Patton West for fraud in 2003 (a lawsuit he won in 2008).

What follows are a list of some of the actions taken by Patton West, Williams & Reynolds against one victim who would not go away quietly. Williams & Reynolds both knew that Patton West was guilty of defrauding Watson.


1. In March 2003, after hearing Watson was going to sue her for fraud patton West insists on a private meeting with Watson which Watson decides to record with a digital tape recorder. The meeting lasts for 44 minutes and you can listen to the entire exchange by going here. During the meeting, Patton West made two crucial statements the first was to admit that she had defrauded Watson but did not see herself writing out a check for what she owed him. Patton West also stated that if Watson sues her (for the crime she just admitted) she would get so f*cking down and dirty huge expenses coming out of his pocket but not hers! West agrees she has defrauded John Watson but does not see herself paying him!

West says that if Watson sues her she'll get so f*cking down and dirty huge expenses coming out of his pocket and not hers because Williams will pay her legal fees.

2. After Patton West's failed mission to persuade Watson not to sue her (for a crime she had just admitted) Patton West returned to her compound. Upon arrival at her compound, Patton West called a meeting with all of her employees, at which she told her employees (on pain of being fired) to manufacture false 'witness' statements about Watson which she intends to use against him in court. We know this to be true because one employee wrote to the whistle-blower's lawyer retracting her false statement.



3. In 2005 Patton West gets Dr. Julio Williams MD to defame Watson via a <u>statement</u> posted on her website. In that statement, Williams stakes his honor and credibility on Patton West's personal integrity. Here is a short excerpt from his statement:-

I, Julio Williams MD have also been a long time student of Surya Ma and I stake my honor and credibility on defending her personal integrity and establishing the truth. I am proud to serve on the Board of Directors of the Global Guardianship Initiative.

After two arrest warrants (1) & (2), a conviction for assault and after being forced to sell her assets at a Sheriff's Sale to pay past victims of crime \$2,000,000 in court fines and interest it must be obvious to all that Dr. Julio Williams has no honor or credibility and yet he is still employed by Essentia Health as a surgeon who gets to stand over unconscious patients wielding a scalpel?

4. Between 2005 and 2008, Patton West and her accomplices Reynolds, Williams and others <u>defame Watson</u> from her website on multiple occasions, as she seeks to persuade her cult and the public that her lies are their truth. Patton West is not shy in admitting that the truth does not matter (if she can persuade the public that her lies are their truth). You can hear her say this in her own voice by going <u>here</u>.

5. Dr. Julio E Williams sent an <u>expletive laden</u> email to Watson in January 2007, in a clumsy attempt to get Watson to drop his lawsuit against his cult / gang leader Patton West. Below is an excerpt from that email.

If what you are after is money (and /or the Victor property) it is going to take a lot of your own personal money to try and get it. I have personally allocated Two million dollars for Dr. West defense and legal expenses.

If you want to wrestle with me in the legal arena know that I will do everything in my power to bring you down. Mr. Watson, You will have your date in court. You fuck with me and you will meet your match.

6. After it became obvious that Watson was not going to drop his lawsuit, senior cult member Geoffrey Reynolds announced Watson's impending murder to a local newspaper reporter while being interviewed about Patton West's vicious assault on a local female doctor. In August 2007, Reynolds told the Bigfork Eagle news reporter, in what he believed to be an 'off the record' conversation, that Watson would be dead within 12 months or in jail for reacting to what Patton West was going to do to him, his wife and children. The motive for murder? To stop Watson publishing the truth about Patton West and her 'criminal past' on the internet so that she could relocate to Arizona and reincarnate their as the Ascended Master Rishi Devra. The murder plot Reynolds announced failed but the campaign of intimidation being directed at Watson and his family has continued for the past 13 years.





Above: The fact that Geoffrey Reynolds announced Watson's impending murder to the press on August 9 2007, in advance of Patton West's failed attempt must mean that Reynolds was briefed in advance and was therefore complicit in Patton West's attempt to murder of Watson. The murder plot failed but the campaign of intimidation Reynolds announced continues.


7. In 2010, three years after the murder plot failed, Dr. Julio E Williams put up \$2,000,000 of his own money to fund a criminal conspiracy against Watson; just as Julio Williams had promised he would do in his January 2007 expletive laden email to Watson.

This is exactly what Patton West predicted would happen during a conversation with Watson in 2003, when she tried unsuccessfully to persuade / threaten Watson not to go to law. See point (1) above. Having failed to murder Watson or intimidate him, Patton West, Williams & Reynolds wait to put Plan 'B' into operation. For as long as his website was up Patton West's multi-million dollar a year criminal business model was dead in the water.

In 2010, when Watson traveled to the USA to see how much the court in Montana is going to award him for winning his fraud lawsuit against Patton West in 2008, Patton West and the cult put Plan 'B' into effect. Upon arrival at the court, Watson is served with two defamation lawsuits (for telling the truth) by Patton West and her stooge Reynolds. Reynolds has never met Watson and their periods of employment are separated by four years. And yet, under direction by Patton West, Reynolds alleges being defamed by Watson. Long story short, because Watson could not afford to travel to the USA to defend Patton West's & Reynolds' two frivolous (without merit) lawsuits Patton West and her stooge Reynolds were awarded a non-defended default judgment of \$5,000,000 each.



8. In January 2018, when details of Patton West's criminal past in New Mexico & Montana started to show up Julio Williams posted a propaganda piece on the internet about the injunction he had 'bought' for Patton West. Instead of being truthful and stating that the injunction was obtained along with the two civil lawsuits that Williams had funded, instead he lied about the injunction. Williams statement sought to have us all believe that a judge, acting independently of Patton West's & Reynolds' civil lawsuits, ordered the injunction against Watson as part of a cyber-security fraud investigation. It must be obvious to all concerned by now that Patton West's criminal racketeering business model is only made possible by the outrageous claims she makes, the lies, deceit and propaganda posted on her website. A full analysis of the injunction and Williams' deceitful, dishonest statement can be found by going here. What Williams fails to say is that the injunction forbids Watson from sharing the truth about Patton West. It does not mean that her arrest warrants, her conviction for assault and her many visits to court as the defendant in fraud related lawsuits did not happen! It just means Watson cannot tell you about them. We can.



9. Finally, the campaign of occult 'under the radar' violent intimidation that Reynolds announced in August 2007 continues to be directed at Watson and his family. Patton West assumes that even if the authorities believe what the victims are telling them, it is unlikely a prosecution will follow as the 'weapon' she is using to intimidate, harm, injure and even murder is not regarded as a weapon under legal statute. The point we want to make here is that senior cult member, Geoffrey Reynolds, announced Watson's murder and the use of violence against Watson and his family on August 9 2007. That campaign of intimidation continues to this day, 13 plus years later. Julio Williams has been a senior member of Patton West's cult from 2005 until present day. As a student of Patton West's unaccredited school for occult studies, Williams has been learning how to use that knowledge as a weapon since joining the cult 20 years ago in the year 2000.







ILLUSION

Long story short, both <u>Geoffrey Reynolds</u> and <u>Julio Williams</u> have known that Patton West intended to murder Watson since the time Reynolds announced her plans to the public on August 9 2007 her intention to do so.

Both <u>Geoffrey Reynolds</u> and <u>Julio Williams</u> have known about the campaign of occult 'under the radar' violent intimidation being directed at Watson and his family by Patton West, at least since Reynolds announced it on August 9 2007. Reynolds even commented to the press that if not murdered the plan was to get Watson to react in a way that had him jailed. This is exactly what a criminal conspiracy is.

Both <u>Geoffrey Reynolds</u> and <u>Julio Williams</u> are well aware that the campaign of intimidation against Watson and his family continues to this day. We know Williams is aware of the ongoing campaign of violence being directed against Watson and his family, because Williams has received between 400 to 500 emails about it from Watson over the past 4 to 5 years or so. In summary, both Geoffrey Reynolds CPA & Dr. Julio Williams MD were / are both willing accomplices in Patton West's criminal racketeering gang. They were obviously both fully aware of the criminal nature of Patton West's business model. As detailed above, to stop Watson wrecking that criminal business model both Reynolds & Williams agreed to conspire with Patton West to murder Watson. Reynolds even announced Watson's murder to the press, along with the campaign of intimidation to be directed at Watson and his family which continues to this day. When the murder plot failed, Reynolds & Williams conspired with Patton West to bankrupt Watson into silence. Williams provided \$2,000,000 to fund endless litigation and Reynolds provided false statements to the court, which netted Patton West another \$5,000,000 civil judgment against Watson.

Look again at the victims on the clock face below.




At 1.00 Patton West arrives in Montana in 1995. After being chased out of New Mexico by a gun wielding victim who knew the police were unable or unwilling to help. Upon arrival in Montana patton West calls herself the Ascended Master Devra JI and sets about building a cult around herself.

At 2.00 business consultant John Watson is defrauded out of pay and shares (see above). In 2008 Watson was granted judgment against Patton West and was awarded over \$700,000 in costs and damages by a Montana court.

At 3.00 Kendall Haywood lost her daughter. A child custody court case was totally subverted by Patton West who mounted a campaign of violent intimidation against a clean living decent honest mother so that Patton West's porn loving, wife beating son could get custody of an infant female child from its mother. How do you persuade the court that a porn loving wife beating parent Chris Haywood (Patton West's son), who had an FBI record for forgery, substance abuse and traffic violations should be given custody over the mother who was decent and honest? How do you persuade the court that the father, who just before the court hearing forced his underage girl friend to have an abortion because it would look bad when he was attending the child custody hearing, to give the father custody. Patton West tries the same strategy a few short years later when wife number two Jamie Haywood sues for divorce only this time Jamie Haywood escapes with her infant daughter. At 4.00 Mike Hendrickson victim of Fraud. Mike signed a note guaranteeing a \$200,000 overdraft for the charity Patton West ran with her husband jack West. Patton West empties the bank account into a personal trust fund for her and her eldest son Rob Meador with the result that Mike Hendrickson has to pay the bank \$200,000 to cover his guarantee. This is mentioned briefly in the Whitefish Pilot news article. Mike, like many victims of fraud / extortion had a choice to make walk away and write it off to experience or become a victim of intimidation, violence and or murder.

At 5.00 Dave Kushner victim of Fraud. Dave agreed to loan Patton West \$30,000 for two weeks and even got a signature on a loan agreement from Patton West agreeing to repay the loan within the stated time period. Once Patton West got the money, she refused all contact with Dave Kushner and refused to repay the loan to him. Dave like many victims of fraud / extortion had a choice to make walk away and write it off to experience or become a victim of intimidation, violence and or murder. At 7.00 Lisa Swidler murdered to keep her quiet. Lisa was murdered by Patton West after attempting to leave the cult. Lisa was a witness to the crimes committed against Dave Kushner and Marion Cantwell. Because the weapon used to murder Lisa (and others) is not regarded as a weapon under legal statute, the murder was treated as a death resulting from 'natural causes.' Though why the sudden mysterious death of a young healthy mother of two, resulting from internal bleeding, should occur is a mystery. A mystery unless you know of someone who has also been the recipient of similar occurrences while being at odds with Patton West.



Above: A pathological liar whose psychosis has her believing she is a god on a special mission to save humanity. She is standing next to part of a \$4,000,000 haul of artwork and valuables (as valued in 2002) that she stole from a Montana charity in 2004. While giving a statement to a Montana court under oath in 2009 Patton West stated that these items did not exist. In reality after stealing these items from the charity she hid them in a lock up for ten years and, after the statute of limitations on theft passed, retrieved them. Her Greek goddess outfits and the stolen statuary are all part of the illusion that she is a god.

At 8.00 Patton West defrauds Montana charity out of \$7 to10 million dollars. After Patton West's charity is struck off for fraud in January 2004, she orchestrates a massive fraud that sees the charities main asset, a property worth \$1,250,000, stolen from the charity and put in a personal trust fund for her and her eldest son Robe Meador. The theft is achieved by calling in fake non-existent loans she says she granted to the charity. That property was later sold at auction to pay \$2,000,000 to past victims of crime. At the same time \$4,000,000 worth of art work and valuables paid for by cash donations from the public went missing. Ten years later art work and valuables all turned up after the statute of limitations on theft expired and were featured on her website as part of a 'moving sale.' The items all matched a list Watson had compiled in 2002 as part of calculating the value of the charity's assets. While being interviewed in court in 2009, Patton West declared that the artwork and valuables were either lost or stolen. Go here to read her statement given under oath.

9.00 Patton West changes her name to the Ascended Master Surya Ma. After her charity was struck off for fraud, Patton West announces that due to the fact she is moving from the 5th to the 7th dimension she needs to move to a location with higher vibrations. Accordingly, Patton West moves her cult from Victor Mt to Flathead Lake MT. She also announces that she can only take 12 disciples with her and only those willing to commit 66% of their net worth to her!

<u>10.00 Patton West viciously assaults her business partner Dr. Pat Cole MD</u>. The <u>Whitefish Pilot</u> newspaper gave an account of the victim's ordeal. What follows is an excerpt from that article.

Cole claims West threw a lamp at her and hit her with a briefcase, cell phone and her hand. "She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself." Photos taken after the alleged beating were submitted to the sheriff's office.

Cult members, **Dr. Julio Williams** ($\underline{1}$ & $\underline{2}$), **Geoffrey Reynolds CPA** ($\underline{1}$, $\underline{2}$, $\underline{3}$ & $\underline{4}$) & **Jack West** ($\underline{1}$) all deny assault on Dr. Pat Cole knowing about <u>Devra's West's email</u> to her cult mailing list wherein she admitted the assault. Reynolds made several <u>desperate attempts</u> on behalf of Patton West to have a copy of Patton West's written admission of guilt removed from Watson's website.

11.00 Patton West is forced to leave Montana. After being forced to leave Montana because of all the negative press and her multiple appearances in court cases as the defendant. Here are three examples of the negative press as published by the Whitefish Pilot, Bigfork Eagle and Ravalli Republic newspapers. See the 'Crimes' page on our website or review above for a list of multiple court appearances as the defendant in mainly fraud related lawsuits. Bear in mind 90% of victims walked away empty handed rather than become murder victims.



12.00 It is all about the money. As Patton West states in the image near the top of this bulletin, "It will be the privilege of everyone she meets to seed her financial transition." Read this letter from a student who relates a conversation with Patton West where she is boasting about her wealth and how she does not need bank accounts. It is mostly converted to diamonds and precious metals and hidden from creditors. And another email from a European student who relates how Patton West told one student that the more money they gave the closer to God they would be.

Nearly 30 years of racketeering and murder, and no consequences. Is it any wonder that Patton West, a criminally insane narcissist, believes she is a God on a mission to lead humanity? Where are the FBI?

Patton West has two advantages that most other criminals and serial killers do not have.

1. Her lies, deceit and propaganda are all apparently 'protected' under religious freedom laws. Even though the obvious motive is fraud. This includes her claim to be able to deliver miracle cures to cancer patients.



2. The <u>weapon</u> she uses to intimidate and murder those who oppose her is not recognized as a weapon under legal statute so her 'extra judicial' killings (murders) are not investigated because the deaths appear to be as a result of natural causes.

In addition to the above, advantages Patton West, like most criminal kingpins, works with low life scum like Reynolds & Williams. These two miscreants are both perfectly happy to be accomplices to multiple murders and countless acts of organized crime.

Introducing Geoffrey Reynolds CPA

Currently, Geoffrey Reynolds is working at McSwain & Co accountants based in Olympia WA. When we made this information available to McSwain & Co. their first response was to sanitize Reynolds's online resume to remove all mention of his 'employment' with the cult / criminal gang between 2006 & 2014 and then later to remove Reynolds' photograph from their website. The current entry is what you see near the top of this website.

It is not for us to impugn McSwain & Co.'s motives for sanitizing Reynolds' resume entry on their website <u>but the</u> result is to hide Reynolds' criminal past from the public and existing clients.

As you will see, Geoffrey Reynolds CPA, in addition to being totally corrupt, is not the brightest bulb on the Christmas tree witness the fact that his actual, factual, resume is still posted on his <u>personal website</u> which clearly shows the information that he and McSwain and Co. appear to be hiding from the public and their existing clients.
