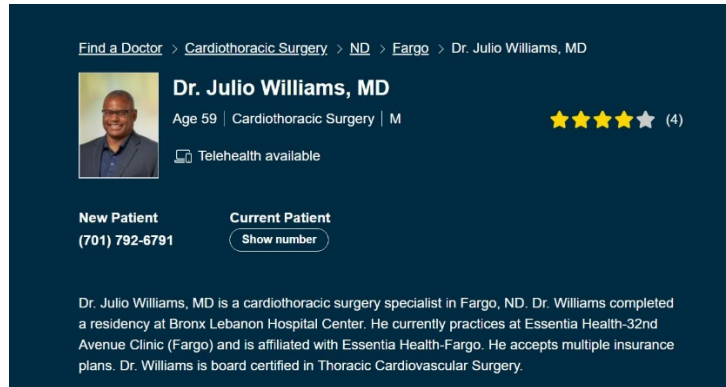


This is my complaint about Dr. Julio Enrique Williams MD.

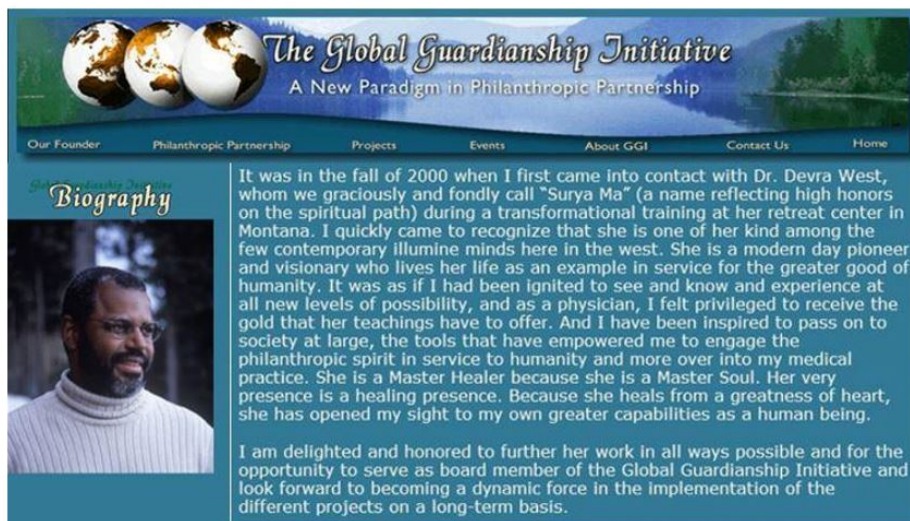


The above image, taken from the [Health Grades](#) website, is intended to help identify Dr. J E Williams. Though Dr. Williams is currently employed by Essentia Health in North Dakota he also appears to have an office in Yakima WA at this address:- 111 S 11th Avenue, Suite 201, Yakima, WA 98902. Dr. William is or was associated with the Hendrick Medical Center, 1900 Pine St, Abilene, TX, 79601.

A Short Over View of my ‘relationship’ with Dr. Julio E Williams MD.

Dr. Julio E Williams MD was never my physician. Our connection occurred in 2002 when we both happened to be in the same place at the same time. For my part I worked as a Business Consultant for the first six months of 2002 at what I thought was a charity but which I later learned, to my cost, was a cult / criminal racketeering gang. The cult / criminal racketeering gang was and still is led by Devra Patton West a resourceful con artist who insists that she is the Regent of the Western Hemisphere and that she has been preparing to lead humanity for thousands of years! In August 2002 I was defrauded out of pay and shares by Patton West (one of scores of victims of organized crime over three decades). In response to being defrauded in March 2003 I issued a lawsuit against Patton West which I won in 2008.

Dr. Julio E Williams MD joined Patton West’s cult in the year 2000 as this brief excerpt from his bio posted on her website in 2007 indicates. Let me call this **Exhibit 1**.



Note Dr. Williams' comments (next to the yellow arrow) about Patton West's name reflecting high honors on the spiritual path. Note Dr. Williams' comments (next to the red arrow) concerning how he is both delighted and honored to 'further' her work in all ways possible including serving as a board member on the Global Guardianship Initiative (for profit and non profit corporations she uses as a front for organized crime).

Hold this information in mind while I relate my experience with Dr. Julio E Williams MD. After announcing my fraud lawsuit against Patton West in early 2003 Patton West requested an urgent meeting with me at my ranch in Victor Montana. To cut a long story short I was threatened by her that if I went to law against her she would get so f*cking down and dirty huge expenses coming out of my pocket not hers because other members of her cult would pay her legal expenses. Hold that thought! You can hear Patton West make this threat, and others, because I recorded the meeting on a digital tape recorder. Please listen to a few short excerpts from that conversation because I want you to know what kind of a person Dr. Julio E Williams admires and honors. Below are some of the responses from Patton West after I told her I was going to sue her for fraud:-

1. [You are f*cking over a Spiritual Teacher for Christ's sake.](#)
2. [I'll go so f*cking down and dirty. Huge legal expenses coming out of your pocket not mine. \(Because members of her cult will pay her legal expenses.\)](#)
3. [It doesn't matter what is actually true. If she can persuade the public and the courts that her lies are their truth](#)

During the six months I acted as a business consultant for Patton West's charity (which was [struck off for fraud](#) in January 2004) I saw Dr. Williams on maybe two or three occasions. This would be while he was attending classes at Patton West's unaccredited school for occult studies. I do not believe I ever spoke to him though if I did I do not recall our conversations. However in 2005 a statement appeared on Patton West's website which in part was authored by Dr. Julio E Williams MD. The statement, which can be read in full by going [here](#), was a 'hatchet' job by Patton West whose purpose was to portray me as the villain. It was propaganda mainly intended for the rank and file members of her cult who treated it everything she said as gospel. Below here is the statement Dr. Julio E Williams made. Let me call this **Exhibit 2**.

I, Julio Williams MD have also been a long time student of Surya Ma and I stake my honor and credibility on defending her personal integrity and establishing the truth. I am proud to serve on the Board of Directors of the Global Guardianship Initiative.

In the interests of full disclosure there were two other physicians that also made similar statements to that Williams made. They were Dr. Cornell MD and Dr. Cole MD. All three physicians were recruited by Patton West as part of her latest get rich quick scheme which involved Patton West offering miracle cures for cancer for six figure sums. The three physicians were recruited to give Patton West credibility in the eyes of future victims. Dr. Cornell came to her senses and left immediately after being asked to show her 'loyalty' by signing off on that above mentioned statement. Dr. Cole remained on-board until April 2006 at which time she was viciously assaulted by Patton West as part of a campaign of violence whose objective was to extort \$1.3 million from Cole which Patton West succeeded in doing at the cost to her of a \$500 fine and a 6 month suspended jail sentence. You can read all about the assault on Dr. Cole in the article published by the Whitefish Pilot newspaper in July 2007. You can read about Patton West assertion that her 'gifts' can heal various illnesses including leukemia. Patton West also stated that she planned to teach what she knows to cardiologists and physicians.

The only cardiologist or physician associated with her currently, and continuously since the year 2000, is Dr. Julio E Williams MD who is currently in his 21st year as a member of her cult / criminal racketeering gang. Hold that thought about Williams being involved in her claims to be able to cure cancer.

In January 2007, as my lawsuit against Patton West was nearing a successful conclusion I received a threatening email from Dr. Julio E Williams which contained the f*ck word and which was an obvious attempt to intimidate me into dropping my lawsuit against Patton West.

Williams, who as I have explained was a virtual stranger to me, had decided to insert himself into a legal dispute. Threatening a court witness is called 'Witness Tampering' and is punishable by up to ten years in jail. What the penalty for threatening a plaintiff in a fraud lawsuit would be I have no idea. If what you are after is money (and /or the Victor property) it is going to take a lot of your own personal money to try and get it. I have personally allocated Two million dollars for Dr. West defense and legal expenses.

If you want to wrestle with me in the legal arena know that I will do everything in my power to bring you down. Mr. Watson, You will have your date in court. You fuck with me and you will meet your match.

Long story short the court granted me [judgement](#) against Patton West in 2008 and I was granted the following [financial award](#) by the judge.

During the 5 years I was prosecuting my lawsuit against Patton West I was subject to threats, intimidation, false witness ([this being an example](#) from one member of her cult who wanted to recant her false statement) and my impending murder was announced to the press by [Geoffrey Reynolds](#) a senior member of Patton West's cult. Immediately after I won my lawsuit in 2008 Dr. Julio E Williams, good to his word, provided the funding for Patton West so that she (and senior cult member Geoffrey Reynolds) could launch multiple frivolous (without merit) lawsuits against me. I was served with those lawsuits when I attended court in Montana in 2010 to see what the court was going to award me after Patton West had appealed my lawsuit against her. The truth is an absolute defense against defamation but only if you can afford to defend yourself. Having moved aboard in 2005 for my own safety I could not afford another five years of air fares or lawyers' fees. The result being that Patton West a) neutralized my lawsuit against her and more importantly forced down my websites which contained details of scores of victims of crime at Patton West's hands in Montana and New Mexico.

So let me recap. I was defrauded by Patton West in 2002, went to law in 2003 and won my lawsuit in 2008. Just as Patton West predicted in 2003 a member of her cult would pay for her legal expenses. As you can see from Dr. Julio E Williams' email above the member of her cult she was referring to was Dr. Julio E Williams MD. The same Dr. Williams who two years prior posted a defamatory statement on Patton West's website.

Dr. Williams was not finished yet as in 2018, when the information about Patton West's criminal activities in Montana started to appear on other websites, he posted a totally dishonest statement on-line which totally misrepresented the injunction his money had 'bought' for Patton West in 2010. Please note that Dr. Julio E Williams is still signing off his lies and propaganda as a 'Board Member' of Patton West's latest corporate vehicle for fraud and extortion which as I shall show Williams is still very much involved.

This concludes the short 'overview' of my relationship with Dr. Julio E Williams MD. I ask you to come to your own conclusions as to what motivated an almost total stranger (to me) to spend millions and risk jail in the defense of someone who has a history of criminal activity and violence spanning 30 years! The above overview, while explaining my relationship (or lack thereof) with Dr. Julio E Williams MD, is not part of my complaint. My complaint against Dr. Williams and the leader of his cult / criminal racketeering gang Patton West will be resolved in a criminal court. My family and I continue to be the subject of intimidation by the leader of Dr. Williams' cult / criminal gang which he is totally aware of as he has personally received scores of emails about. For some reason Dr. Williams has not passed these onto the authorities.

In addition to passing information to the FBI I have recently been corresponding with the Arizona Attorney General's office who I understand are investigating Patton West's many claims which at the very least amount to wire and mail fraud. Dr. Julio E Williams is directly involved in these crimes. As stated above a criminal trial involving Williams and Patton West will resolve these matters in the fullness of time. However my complaint to North Dakota and regulators in Washington State and Texas revolves around:-

1. Whether Dr. Julio E Williams MD is fit to be practicing medicine. As you will see from the above and the following submission Dr. Julio E Williams MD totally lacks integrity, is a pathological liar and is totally without a moral compass. I understand that all physicians sign the Hippocratic Oath which in essence is a promise to 'do no harm.' I ask you to asses Dr. Julio E Williams' performance in fulfilling that oath and his suitability to be standing over an unconscious patient wielding a scalpel.

2. I contend that Dr. Julio E Williams MD is directly involved in organized crime, has funded organized crime and is directly involved in the sale of 'miracle cures' by Patton West. This deception may involve Patton West making the victim ill then forcing them to pay for the fake 'cure.' Those that go public about these crimes are targeted for intimidation and or murder. Dr. Williams was / is complicit in the ongoing attempts to silence me.

Regarding point numbered (1.) above here is the evidence to support my complaint / assertion that Dr. Julio E Williams is unfit to practice medicine. I contend that if Dr. Williams' liability insurers were aware of this information they would either refuse to insure him or substantially increase his insurance premiums.

To recap. In his 2005 statement shown earlier in this document Dr. Julio E Williams MD staked his 'honor and credibility' on defending Patton West's personal integrity and establishing the truth. In reality Dr. Julio E Williams' threatening email to me in January 2007 was all about hiding the truth and Patton West's lack of personal integrity from the public. As was his pledge to spend up to \$2,000,000 to defend Patton West against my fraud lawsuit.

As a direct result of Dr. Julio E Williams' actions, the lawsuits he funded and the injunction he 'bought' the list of crimes shown below (the tip of the iceberg) were scrubbed from the internet allowing Patton West and Williams to relocate their criminal racketeering business model to Arizona in 2010. Where complete with a new name, new fake bio and a host of new titles and accolades Patton West is targeting 'spiritual seekers' and the seriously ill.

Below here is some of the information that Patton West, aided and abetted by Williams, sought to hide.

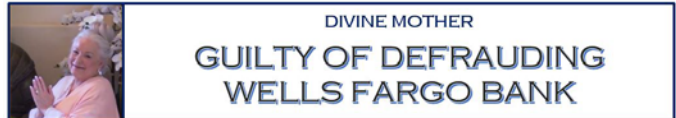

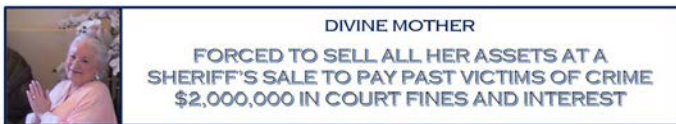

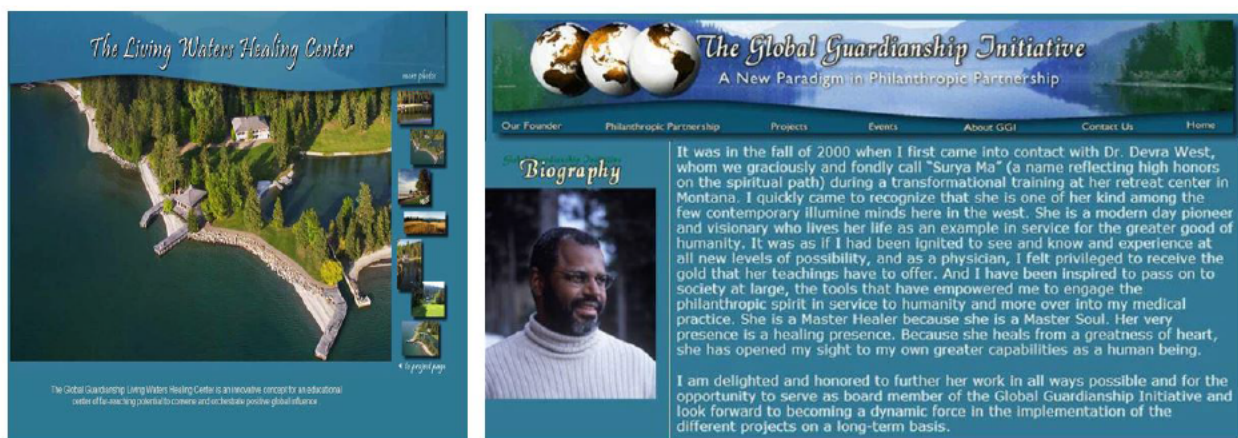

Note directly above  here Patton West asserts that she can offer the phenomena of [‘Divine Grace Healing’](#) and ‘karmic resolution of divine dispensation.’ For Divine Grace Healing read ‘Miracle Cures.’ For karmic resolution of divine dispensation read ‘Forgiving Past Karma.’ Patton West is flying as close to the wind as she dare with these statements as there are laws for non-physicians to promise cures of any kind. The Medical Regulators must also take a dim view of any physician involved with a lay person offering miracle cures. As one of her [ex-employees](#) pointed out Patton West was charging \$500,000 for these miracles in 2002!

Regarding point numbered (2.) above here is some of the evidence to support my assertion that Dr. Julio E Williams MD is directly involved in fraud, extortion and was / is complicit in attempted murder.

1. Dr. Julio E Williams MD involved in Fraud and Mail & Wire Fraud in Montana.

The image below contains an excerpt of Dr. Julio E Williams’ biography as it appeared on Patton West’s website circa 2007 to 2009. You can review Dr. Williams’ full biography by going [here](#).



On an adjacent web page to Williams’ biography’ you will find a copy of the image shown above left. The image depicts Patton West’s ‘Living Waters Healing Center’ the only problem was that this image belonged to Robert & Tabby Ivy and not to Patton West. If you review the [Whitefish Pilot](#) newspaper article published on July 12 2007 you will find the following comments by the real owner of the property.

A third Lakeside property – the well-known Osprey House on Angel Point, owned by Robert and Tabby Ivy -- is promoted in the Surya Ma Enterprise brochure as the "Surya Devi VIP Retreat Spa." Tabby Ivy refutes that claim. "Devra consistently misrepresents her involvement with our house, erroneously saying she has an offer on it, but we have had no formal offer nor accepted any from her," she said. "After I saw our house in her brochure, I walked into her office and said, 'I don't want my house on any of your marketing materials.' For two years, she claimed she was going to buy our home. She wrote a bad check for several million dollars to the Realtor, and that was our experience with her."

Being a pathological liar is a quality new members must possess if they are to be accepted into Patton West’s cult / criminal racketeering gang. The fact that Dr. Williams has remained a member for over 20 years speaks volumes about his character or I should say lack of character. Let me give some examples of just how big Patton West’s lies are. On the same day the Whitefish Pilot news article was published on July 12 2007 Patton West was in court giving evidence on behalf of her son ([who like his mother has a criminal record](#)). When giving evidence Patton West was asked if her business was a ‘billion dollar concern.’

Counsel asked “Is it fair to characterize your company as a multi-billion dollar enterprise?” Patton West replies, “Correct.” Below is an excerpt from Page 10 of the [court transcript](#).

15 Q. Okay. On the last page of this exhibit --
16 first of all let me ask you some questions. Is it fair
17 to characterize your company as a multi-billion dollar
18 enterprise?
19 A. Correct.

On August 9 2007, less than one month after her appearance in court on July 12 2007, a second newspaper article was published by the [Bigfork Eagle](#) newspaper within which it became clear that Patton West was no billionaire or millionaire. Below is an excerpt from that article.



Out of six businesses mentioned in West's literature, only one remains active and in good standing with the Montana Secretary of State office -- Sacred Environments LLC. Two were never registered -- Divine Unity Foundation and Millennium Mind Institution; two were involuntarily dissolved -- Surya Enterprises Unlimited and [Global Guardianship Initiative](#); and one was involuntarily revoked -- Sacred Archive Institute. Besides being evicted from her Bayside home in Lakeside and bouncing a check for the purchase of the well-known Osprey House on Angel Point, West has a \$2,287 lien against her for failing to pay unemployment taxes for her Montana employees.

I have highlighted in yellow the [Global Guardianship Initiative](#) because this is the same corporation that Dr. Julio E Williams MD was a board member of (see the excerpt of his biography above on the preceding page). However the Bigfork Eagle newspaper article maintains that the Global Guardianship Initiative was involuntarily dissolved. That being the case why was Dr. Williams MD saying how delighted and honored he was to be a board member through to 2009?

Let's cut to the chase the for-profit corporations, the non-profit corporations (listed above) and the charity that was [struck off in 2004](#) were all vehicles used by Patton West to defraud and extort money from the public. An important part of the fraud was to be able to portray herself as a wealthy business woman who hoped to dupe investors into funding her latest 'get rich quick' scheme. At the very time Patton West was asserting, in court and under oath, that she was a billionaire she was in point of fact being evicted from two rental apartments, had a lien against her for unpaid employment insurance in the amount of \$2,287 and owed past victims of crime \$2,000,000 in court fines and interest. The latter debt would become the subject of a [Sheriff's Sale](#) at which her assets (those not hidden) would be sold to pay her creditors. Those debts did not include what the court awarded to me.

We know that pathological liar Dr. Julio E Williams was totally aware that Patton West did not own the multi-million dollar property she was then show-casing on her website as her own. We know that Williams was aware that she was at the time being evicted from two rental properties. We know this because in early 2007 Dr. Julio E Williams MD donated \$100,000 to Patton West so that she could continue her criminal activities in Montana. Below is an excerpt from a [harrowing email](#) entitled 'Help Me' that Patton West's ex-office manager Rebecca West (no relation) sent me in March 2007. On the second page, second paragraph, Rebecca makes it clear that the only one supporting Patton West's criminal activities at the time was Dr. Julio E Williams MD.

"I am aware that the only person still financially supporting Devra (the finance controller is out of money), is **Dr. Julio Williams** and he gave her \$100,000 last week. Devra spends money so fast that this funding will not last long. I know she has hoarded all her expensive jewels, artwork and artifacts and in addition I contemplate how much money/jewels she has stashed in order to bail herself out in the event you are able to take her down completely, or if the funding does not come through."

The rest of the email explains how tens of employees 'have come and gone' in a short time period. This is another aspect to Patton West's criminal activities explained in detail in this posting entitled '[Fake Career Opportunities.](#)'

2. Dr. Julio E Williams MD becomes involved in Mail and Wire Fraud in Arizona in 2014.

Dr. Julio E Williams MD was also totally aware of the violence meted out by Patton West upon female members of her cult. Let me give you three well documented examples which occurred during his tenure. He was actually present at one of the incidents – but did nothing.

Susannah Felder. In July 2001 Patton West was asked by an employee of the charity to explain why Patton West had removed \$80,000 from the charity's bank account to pay for her son's legal fees. Patton West's response was to viciously assault the employee Susannah Felder and in the process ripped clumps of hair from the victim's head. Ex-board member of the charity AJ White explained in the notarized [statement](#) she gave me what took place.

Beatrice McGuire. In 2002 Patton West attended a meeting with some of her Canadian and foreign students. During the meeting a student, Beatrice McGuire, challenged Patton West on an obvious lie. Patton West response was to viciously assault Beatrice McGuire. An assault that resulted in Beatrice requiring plastic surgery to attach part of her ear that had been ripped away from her head. A witness, student Debra Coffey, explains in a [notarized statement](#) that she gave me what happened.

Dr. Pat Cole MD. In 2006 Patton West launched a campaign of violent assaults against Dr. Pat Cole MD a wealthy student who was also Patton West's business partner (in Patton West's latest greatest get rich quick scheme). In early April 2006 after a particularly vicious assault By Patton West upon Dr. Cole the police were called and Patton West was charged with assault. In April 2008 Patton West, after numerous attempts to intimidate Cole and her witnesses into dropping the complaint, she was convicted of assault. Below here is what the victim told the Whitefish Pilot news reporter for a story they published on July 12 2007.

"She has told me that she has the 'spiritual' power and authority to 'take me out,' to be composted," Cole wrote in the temporary restraining order statement.

Cole claims West threw a lamp at her and hit her with a briefcase, cell phone and her hand. "She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself." Photos taken after the alleged beating were submitted to the sheriff's office.

The Whitefish Pilot news article was published on July 12 2007 but let me take you back to early April 2006 just days after the assault occurred. When the assault occurred it was so vicious and so disturbed those present that Patton West felt compelled to issue a statement to her entire mailing list to quell the unrest amongst the rank and file of the cult. Accordingly on April 17 2006 Patton West sent out a statement entitled '[The Law of Severity on the Path to Purification.](#)' This missive went to every member of Patton West's cult including **Dr. Julio E Williams MD** that much I know from speaking to an employee working in the office at the time.

In an attempt to justify the assault Patton West, then calling herself the Ascended Master Surya Ma, asserted that because Dr. Pat Cole was a Nazi in the WWII death camps in another life time the beating was both justified and long overdue. To be clear Patton West admitted the assault, admitted it was severe but assured everyone that it was administered with grace. There was no mention in this missive of the plot by Patton West to murder Dr. Cole which employee [Carlida Finch](#) overheard. There was no mention of the \$1.3 million Patton West successfully extorted from Dr. Cole MD at a cost to Patton West of a [\\$500 fine and a 6 months suspended jail sentence](#). Who says crime does not pay.

Here is part two of that statement.

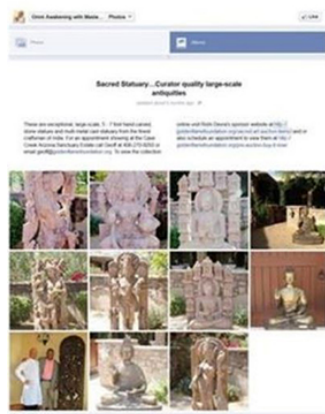

In paragraph (3.) Both items mentioned in paragraphs (4.) & (5.) are the latest vehicles being used for fraud, extortion and organized crime. In paragraph (6.) she mentions the Rishi Collection. The Rishi Collection consists of millions of dollars of art work and valuables that she stole from her charity in 2004 immediately after it was struck off by the Secretary of State for Montana.



In an attempt to hide these times from her creditors, including myself, Patton West hid these items in a lock up for ten years. After the statute of limitations on theft expired in 2014 these items reappeared as for sale at auction or from her website.

In 2009 my lawyer deposed Patton West and one of the questions he asked was what happened to all the artwork and valuables. That would be the artwork and valuables that I, with the assistance of her bookkeeper, cataloged as belonging to the charity in 2002. Patton West [response to the question](#) was that these items were stolen or lost and that she had walked away from that life. As you will see if you go to her current website and to this [webpage](#) nothing could be further from the truth. As you will see she currently has a bronze statue like the one in the image above on sale for \$34,000! Who says crime does not pay.

The statement featured on Page 12 & 13 was copied from Patton West's Facebook pages. When combined with two websites full of similar lies, deceit and propaganda it is obvious that the motive is fraud. That Williams is a willing accomplice in this fraud and much more cannot be in doubt. Let me review the evidence so far:-

1. As stated in the excerpt of his biography featured on Page1 Williams has been involved with Patton West since the year 2000 i.e. 21 years.
2. In 2005 Williams was persuaded by Patton West to post a defamatory statement about me on her website. In excerpt of that statement, featured on Page 2 of this document, Williams stakes his honor and credibility on defending her personal integrity and establishing the truth.
3. In 2007 Williams intervenes again in a legal dispute between me and the leader of his cult / criminal racketeering gang. He does so by sending me a threatening email in which he promises to make available up to \$2,000,000 to fund Patton West's legal fees. Something Patton West promised would happen in March 2003 if I went to law against her.
4. I win my lawsuit against Patton West in 2008. Dr. Williams makes available some of the \$2,000,000 that he promised Patton West. Using his money she launches multiple frivolous lawsuits against me in 2010 that I cannot afford to defend. In effect Williams 'bought' the legal outcome Patton West and the cult needed to force details of her criminal past off the internet so that she can reincarnate herself in Arizona with a new name and new fake bio.
5. There is no way Dr. Williams can avoid knowing about the newspaper articles featured on Page 4 which detail some of Patton West's criminal activities in Montana. There is no way Dr. Williams can avoid knowing about the 10 'criminal acts' listed on pages 5 & 6 of this documents. There is no way Dr. Julio E Williams can avoid knowing about the lies, deceit and propaganda featured on her two websites [The Rishi] & [Omni Awakening]. Does Dr. Williams believe that Patton West is was called to service at age 7? Does Dr. Williams believe that Patton West has been preparing to lead humanity for thousands of years? Does Dr. Williams believe that Patton West is the 'Mother of Ten Thousand Suns'?

6. Does Dr. Williams believe that Patton West, a con artist chased out of New Mexico in 1995 at the point of a gun by one victim, is capable of delivering Miracle Cures (Divine Grace Healings)?
7. If Dr. Williams believes all this bullshit then why was he prepared to threaten me, a total stranger to him, in an attempt to get me to drop my fraud lawsuit against Patton West. Why when I refused to do so did he make available \$2,000,000 to stop me sharing the truth about Patton West?

The obvious answer is that Dr. Julio E Williams MD is a willing accomplice in Patton West's cult / criminal racketeering gang which has operated in three western states over the past 30 years.

The evidence reviewed at the top of this page and on the preceding page makes it perfectly clear that Dr. Julio Williams knows that Patton West is a total fraud and a criminal. Remember, back in 2005 Williams staked his honor and credibility on Patton West's personal integrity! It is clear that if Dr. Williams has no honor or integrity.

The third source of 'income' is derived by extorting money from those who attend the [classes](#), [private sessions](#) and [audiences](#) advertised on her website. Though she charges fees for these sessions / audiences these amounts are peanuts compared to the huge sums of money obtained from extortion.

Before explaining how the extortion scam works it would be useful to the reader to understand something about Dr. Williams's. As his [biography](#) informs Williams grew up in the Dominican Republic where Voodoo is one of many religions practiced so becoming an apprentice to a white witch like Patton West must have been like a dream come true to Williams. To be clear Williams has been a student of Patton West's unaccredited school for occult studies for over 20 years. For over two decades Dr. Williams has been schooled in occult (hidden) knowledge. The very knowledge that Patton West has been using as a weapon for three decades to facilitate theft, fraud and extortion. We know from one of her [employees](#) that she was charging \$500,000 for the 'cure' in 2002.

There is another version of this extortion scam that involves Patton West 'sorting' attendees to her [classes](#), [private sessions](#) and [audiences](#) by wealth and usefulness. Having found a suitable candidate Patton West targets them, in the way I described on the previous page, and then after they are made ill she then offers them the cure for a large sum of money. Those that agree to pay get the cure. Those that refuse to pay are made progressively more ill until they do pay. Below here is an image of the [Pay Portal on Patton West's website](#).



The website is beautiful and must have cost hundreds of thousands of dollars. But like a gigantic Hollywood Blockbuster it is all illusion. If the public are being asked to donate money based on lies and propaganda it is called fraud. Above you will see that her 'Pay Portal' can handle single donations of up to \$500,000 which coincidentally was the same amount she was charging in 2002 for fake cures for cancer. I ask you who on earth would want to donate \$500,000 to a total flake like Patton West? The answer is no one. However the main function of the 'Pay Portal' is not to receive large cash donations from the public. Its main function is to receive huge payments from victims who think they are going to get a cure for cancer or who have been targeted with illness by Patton West so that she can extort payment for a 'cure' from them.

Dr. Julio Williams appears to be a key player in these crimes. After all back in 2007, while being interviewed by the Whitefish Pilot newspaper, Patton West made the following statement:-
